**A BILL FOR**

**An Act to amend the State's health professionals registration Acts to allow for further successive terms of office and for related purposes**

Be it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

**1. Short title**

This Act may be cited as the *Health Professionals Registration (Miscellaneous Amendments) Act 2009*.

**2. Commencement**

This Act commences on the day on which this Act receives the Royal Assent.
