Notices of Motion

50 The Minister for Disability Services and Community Development to move—That the House:—

- (1) Acknowledges that the 18th - 24th June 2018 is Refugee Week 2018, with 20 June 2018 World Refugee Day - a day to recognise the importance of Tasmania's diverse multicultural community.
- (2) Notes that as part of the 2018 theme #withrefugees, the Tasmanian Government's many programs and initiatives to support refugees and new arrivals, including our 'Welcome Settlement Package' which provides on-island support for new refugee arrivals so they too can benefit from Tasmania's growing prosperity and enjoy a better life.
- (3) Further acknowledges the important role community organisations have in advocating for and supporting members of our multicultural community, and the good work they do each and every day in ensuring refugees can access the supports and services they need to start a new life.
- (4) Thanks refugees and new arrivals for the many benefits they bring to Tasmania, in making Tasmania a more culturally informative, dynamic, diverse and vibrant State. (20 June 2018)

51 The Minister for Energy to move—That the House:—

- (1) Notes the Hodgman Liberal Government's Tasmania-First Energy policy commitment to deliver secure and reliable electricity supply and lower prices with a target set to deliver:—
 - (a) 100 per cent self-sufficiency in renewable energy generation by 2022; and
 - (b) the lowest regulated electricity prices by 2022.
- (2) Further notes the Government's commitment to protect the people of Tasmania from electricity price shocks by capping electricity price increases by up to CPI for three years.
- (3) Further notes the Hodgman Liberal Government's commitment to supporting non-regulated commercial and industrial businesses by extending the energy rebate for businesses in 2018/19 with a further \$10 million for the rebate scheme.
- (4) Acknowledges that the Government's review of the Solar Feed in Tariff has already commenced, with the focus on suitably rewarding and incentivising those Tasmanians investing in solar.
- (5) Further acknowledges the Government's commitment to empower Tasmanian community organisations and sporting clubs with a \$300,000 Community Solar and Energy Efficiency Package to install solar energy systems and modern energy efficient heating appliances.
- (6) Recognises as a part of the Tasmania-First Energy Policy, the Governments promotion and support of new renewable energy developments in the state such as Cattle Hill and Granville Harbour wind farms. (20 June 2018)

- 52** The Minister for Veterans Affairs to move—That the House:—
- (1) Notes that supporting Tasmania's veterans and ex-service personnel is a major priority of the Hodgman Liberal Government.
 - (2) Further notes that Tasmania has more than 10,500 veterans and ex-serving personnel and that their service and sacrifice deserves to be acknowledged.
 - (3) Further notes in the 2018-19 Budget, the Government is committing a record \$750,000 package to support veterans, ex-service personnel and their families. This package includes:—
 - (a) providing peak body status to the Return Service League (RSL) (Tasmania Branch) which will see an increase in core annual funding to \$110,000 to provide assistance and advocacy, with indexation of 2.25 per cent to be applied from 2019-2020;
 - (b) provision of \$50,000 per year for three years to RSL (Tasmania Branch) to undertake projects that improve service delivery to ex-serving men and women in Tasmania;
 - (c) provision of \$50,000 to RSL (Tasmania Branch) to deliver events celebrating the 2018 Armistice centenary, which also marks the end of the Centenary of ANZAC;
 - (d) establishing the Teddy Sheean Grants Program of \$100,000 a year for 3 years for repairs and maintenance to RSLs and other veterans' organisations as well as war memorial construction and repairs; and
 - (e) establishing a \$225,000 partnership with the Parks and Wildlife Service to enable participation in an active recreation and adventure program for veterans in Tasmania's National Parks.
 - (4) Further notes the Hodgman Liberal Government remains a proud supporter of Tasmania's servicemen and women and their families. (20 June 2018)
- 53** The Minister for Energy to move—That the House:—
- (1) Notes that mining and minerals processing is a key economic pillar in Tasmania, employing more than 6,300 people and accounting for over 50 per cent of our exports in 2016-17, or more than \$1.5 billion a year.
 - (2) Further notes that the 2018-19 Budget includes \$2 million for the new Exploration Drilling Grant Initiative to expand the real and potential mining base industry in Tasmania through supporting increased 'greenfield' mineral exploration.
 - (3) Acknowledges that this commitment sits alongside ongoing programs including the Government's:—
 - (a) \$1.4 million Geoscience Initiative, which aims to provide geoscientific data, that will underpin the industry's future;
 - (b) \$1 million Mining Sector Innovation Initiative, which will see exciting new technologies, solutions to mine rehabilitation and other cutting edge projects explored; and
 - (c) continued funding for the Mineral Exploration Investment Attraction Plan, which promotes mining and exploration in Tasmania to a national and international market.
 - (4) Further notes that there is no better friend of the mining and minerals processing than the Hodgman Liberal Government. (21 June 2018)
- 54** The Minister for Veterans Affairs to move—That the House:—
- (1) Recognises that Sunday, 1 July 2018 is Reserve Forces Day, an annual commemoration of the value of Reserve service to the nation.
 - (2) Notes that 2018 will be the 21st year this event has been held since 1998, with thousands of former and serving reservists now participating in parades across the nation.
 - (3) Acknowledges that the theme for the 2018 Reserve Forces Day in Hobart is Tasmania's contribution to the Western Front and the Desert Campaign in 1928, in particular the leadership of Tasmanian born, Major General Sir John Gellibrand.
 - (4) Further notes that reserve forces have played a key role in Australia's defence over the years with militia – the pre-cursor of today's Reserves – forming the backbone of the Australian Naval and Military Expeditionary Force (ANMEF), the first Australian forces deployed overseas during World War 1, and also of the famous Australian

Imperial Force (AIF) that fought with such distinction and courage through Gallipoli and the Middle East and on the Western Front.

- (5) Honours the 1.25 million Australians who have served with Reserve forces over the years.
- (6) Thanks all those who volunteer their time and effort with the Reserve Forces Day Council, both in Tasmania and nationally, to ensure that the service and sacrifice of our Reservists is appropriately commemorated and remembered. (21 June 2018)

55 The Minister for Sport and Recreation to move—That the House:—

- (1) Acknowledges that the 5th annual National Australian Football League (AFL) Inclusion Carnival is currently being held in Launceston from 18 June to 23 June 2018.
- (2) Congratulates New Horizons Club, AFL Tasmania and the City of Launceston for collaborating on their successful joint bid in bringing the carnival to Northern Tasmania.
- (3) Notes that the AFL Inclusion Carnival is a national tournament for male players over the age of 16 who are living with an intellectual disability.
- (4) Welcomes and congratulates all of the participants, coaches and supporters from the Northern Territory, NSW/ACT, Queensland, South Australia, Tasmania, Victoria Country, Victoria Metro, and Western Australia for their participation and support of this carnival.
- (5) Celebrates the fact that Tasmania's participation has grown every year of the annual event, having gone from forming part of a composite team with Victoria to competing as a stand-alone side.
- (6) Further notes that the Carnival is a true indication of how sport builds opportunities and can be accessible to all.
- (7) Further acknowledges that the finale of the carnival will be the curtain raiser to the Hawthorn v Gold Coast match on Saturday 23 June 2018 – a wonderful opportunity to promote the importance and significance of this Carnival to people living with disability.
- (8) Wishes all participants the very best for the Carnival, and most of all - a lot of fun. (21 June 2018)

56 Dr *Broad* to move—That the House calls on the Premier to table all advice the Government has received about the Liberal's firearms policy and the National Firearms Agreement. (21 June 2018)

57 The Minister for Sport and Recreation to move—That the House:—

- (1) Notes that the Tasmanian Government's partnership over 3 years with the Collingwood Magpies Netball Team in the elite level Suncorp Super Netball series, including the hosting of regular season and preseason matches in Tasmania, has been a great success for Tasmanian players.
- (2) Further Notes that the Hodgman Liberal Government has committed a further \$220,000 towards improving regional netball facilities to support grassroots participation, and \$250,000 p.a. to Netball Tasmania as the peak organisation towards its work in both grassroots and elite level development.
- (3) Acknowledges that local Tasmanian players now have a pathway to the elite level through the Australian Netball League and the Tasmanian Magpies.
- (4) Further notes that for the 2018 season the Tasmanian Magpies squad was made up of 15 players, 9 of whom were Tasmanian.
- (5) Congratulates Maddie Carter, Zanna Jodlowska, Emma Johns, Hannah Lee, Shelby Miller, Kaitlin Petrie, Danni Pickett, Kelsie Rainbow and Alex Vinen on being the 9 Tasmanians in the 2018 squad.
- (6) Celebrates with and congratulates the Tasmanian Magpies on being the 2018 Deakin University Australian Netball League champions. (3 July 2018)

59 The Minister for Aboriginal Affairs to move—That the House notes:—

- (1) 8-15 July is NAIDOC Week 2018, a week to celebrate the history, culture and achievements of Aboriginal and Torres Strait Islander peoples, which is celebrated by

all Australians and is a great opportunity to learn more about Aboriginal and Torres Strait Islander communities.

- (2) This year's theme – 'Because of Her, We Can!', acknowledges that Aboriginal and Torres Strait Islander women are pillars of our society that have played – and continue to play – active and significant roles at the community, local, state and national levels, as leaders, trailblazers, politicians, activists and social change advocates.
- (3) Aboriginal and Torres Strait Islander women continue to influence as doctors, lawyers, teachers, electricians, chefs, nurses, architects, rangers, emergency and defence personnel, writers, volunteers, chief executive officers, actors, singer songwriters, journalists, entrepreneurs, media personalities, board members, accountants, academics, sporting icons and Olympians – the list goes on.
- (4) For over 40,000 years in Tasmania, Aboriginal women have carried their dreaming stories, song lines, languages and knowledge that have kept their culture strong and enriched us as the oldest continuing culture on the planet.
- (5) The Tasmanian Aboriginal community celebrates NAIDOC Week through numerous community activities and events around the State. Events include flag raisings, art exhibitions, community lunches, cultural activities, and 'on country' excursions.
- (6) While we are seeing some progress, Aboriginal women face additional barriers, and the Hodgman Liberal Government will continue to reset the relationship so that Aboriginal women have equal opportunity to participate in and contribute to Tasmania's social, political, economic and cultural life.
- (7) Tasmania's Aboriginal women and girls are to be recognised, thanked, congratulated and acknowledged for their invaluable contributions and achievements that they have made – and continue to make – to their communities, families, our culture and our history. (4 July 2018)

60 The Minister for Resources to move—That the House:—

- (1) Notes the participation in National Tree Day and Schools Tree Day by schools and communities around the state in July 2018.
- (2) Further notes that Schools Tree Day is a great hands-on opportunity for students to experience planting and caring for seedlings as they grow and, in doing so, to help beautify or provide more shade or shelter at their school.
- (3) Further notes that the event teaches students about the importance of trees to our environment and the value of wood as a natural, renewable and beautiful resource.
- (4) Further notes that half of Tasmania – or almost 3.4 million hectares – is forested and our forest management standards are world's best practice.
- (5) Further notes that in Tasmania we plant three trees for every single tree that is harvested.
- (6) Further notes that our productive forests provide employment for a great many Tasmanians and support regional communities around the State.
- (7) Commends all 38 schools across Tasmania involved in the 2018 Schools Tree Day.
- (8) Further commends Sustainable Timber Tasmania for donating around 8,700 seedlings of 15 native tree species to schools for the event. (4 July 2018)

61 The Minister for Veterans Affairs to move—That the House:—

- (1) Recognises that 27 July 2018 is Korean Veterans Day, an annual day of remembrance for those who served during the Korean War.
- (2) Notes that 27 July 2018 will be the 65th anniversary of the signing of the Armistice that brought an end to active fighting in Korea in 1953.
- (3) Pays tribute to the more than 18,000 Australians who served in the Korean War, including 350 who paid the ultimate price, 1,200 who were wounded and 44 who are still listed as missing in action today.
- (4) Acknowledges the sacrifice of our allies in Korea, including the estimated half a million casualties suffered by South Korea and almost 140,000 casualties suffered by the United States of America.
- (5) Honours the service and sacrifice of all those who fought for freedom and human dignity in this conflict. (5 July 2018)

62 The Minister for Veterans Affairs to move—That the House:—

- (1) Notes the Victoria Cross is the highest military award for bravery in wartime.
- (2) Further notes that to date (July 2018) more than 1,350 Victoria Crosses have been awarded worldwide, of these, 100 have been to Australians and fourteen won by Tasmanians – a wonderful representation.
- (3) Further notes that five of those fourteen Tasmanians demonstrated their outstanding act of bravery in 1918, 100 years ago, in France:—
 - (a) Sergeant Stanley McDougall from Recherche Bay on 28 March 1918;
 - (b) Corporal Walter Brown of New Norfolk on 6 July 1918;
 - (c) Lieutenant Alfred Gaby of Springfield Ringarooma on 8 August 1918;
 - (d) Sergeant Percy Statton of Beaconsfield on 12 August 1918; and
 - (e) Lance Corporal Sidney Gordon from Launceston on 27 August 1918.
- (4) Further notes that the Victoria Cross is manufactured by Hancocks and Co, Jewellers of London, and has been since its inception in 1857, with each award individually approved by Her Majesty the Queen.
- (5) Commends all of current and ex-service personnel who have served their country under the Commonwealth, their spirit of service and sacrifice must be remembered. (5 July 2018)

63 Ms *White* to move—That the House:—

- (1) Notes the sad day in Tasmania’s media landscape with the final WIN News bulletin produced in the state on Friday 17 August 2018.
- (2) Further notes this decision by WIN News management will have a profoundly negative effect on local media content and media diversity.
- (3) Further notes the significant contribution of the reporters, camera operators, producers and other staff who have professionally delivered the news to Tasmanians right up until the final bulletin.
- (4) Further notes the deep respect and sympathies for those staff who have lost their jobs at WIN News in Tasmania.
- (5) Calls on WIN Television management to rule out further job cuts to its operations in Tasmania. (21 August 2018)

65 Ms *White* to move—That the House:—

- (1) Notes the Hodgman Government has lurched from crisis to crisis over the past five weeks and the Minister for Health, Hon. Michael Ferguson MP, has been at the centre of all of it.
- (2) Further notes the Minister went missing when Tasmanian families desperately needed leadership and information about meningococcal disease.
- (3) Recognises that on his watch, the health and hospital system has experienced continuous escalations to Level 4 at the Royal Hobart Hospital (RHH) and Code Blacks at the Launceston General Hospital (LGH).
- (4) Further notes with regret that patients at the RHH are being treated in corridors and on Liverpool St with ambulances queued waiting to get into the emergency department.
- (5) Further notes the Minister has been forced into a humiliating back down over the Government’s pre-election changes to gun laws.
- (6) Condemns the Minister’s admission that he discussed the private, very personal medical details of Angela Williamson – specifically how she was forced to travel to Victoria to access a termination – with her employer, leading to her dismissal from Cricket Tasmania. (21 August 2018)

67 Ms *Dow* to move—That the House:—

- (1) Notes the successful election of Justine Keay MP to the Federal seat of Braddon following the recent By-Election.
- (2) Further notes the hard fought campaign of Justine Keay and congratulates her on her re-election as the Member for Braddon.
- (3) Further notes the hard work and commitment of all those who volunteered their time during the campaign and at pre-poll votes.
- (4) Further notes that the ALP success at the recent By-Elections around the country reaffirming the community’s support for investment in our hospitals and schools not tax cuts to the big banks.

- (5) Further notes the importance of the Federal Government honouring the commitments it made to the people of Braddon throughout the By-Election Campaign prior to the next Federal Election, including:—
- (a) West Park facilities upgrade;
 - (b) Jobs Ready Generation Package;
 - (c) Bass Highway and Murchison Highway upgrades;
 - (d) Welding simulator at TMEC Burnie; and
 - (e) Montello Soccer Ground upgrade. (21 August 2018)

68 Mr *Shelton* to move—That the House:—

- (1) Notes that the message from Tasmanians in 2014 and again in March 2018 was that they want a Government that focuses on creating jobs and growing the economy.
- (2) Further notes that our long-term plan is working and as at July 2018, a record 249,700 Tasmanians are in work.
- (3) Further notes that the Tasmanian Chamber of Commerce and Industry (TCCI) has reported from its most recent survey that business confidence is at record levels, and that the June 2018 quarter Deloitte Access Economics Report stated that Tasmania’s “Export growth has skyrocketed, bucking the trend seen at a national level”.
- (4) Further notes the turnaround in Tasmania’s economy since the State was in recession under the former Labor-Green Government. (21 August 2018)

70 The Minister for Veterans Affairs to move—That the House:—

- (1) Recognises that 18 August 2018, was Vietnam Veterans Day, an annual day of remembrance for those who served during the Vietnam War.
- (2) Notes that this day, originally known as Long Tan Day, commemorates the day in 1966 when the battle of Long Tan was fought by the men of D Company, 6th Battalion, the Royal Australian Regiment (6RAR).
- (3) Further notes that this day, first commemorated in 1969 with the raising of a cross at the battlefield by the men of 6RAR, has since been adopted to cover all veterans who served in the Vietnam War—the longest conflict in Australia’s history.
- (4) Pays tribute to the almost 60,000 Australians who served in Vietnam between May 1962 and April 1975, including 521 who paid the ultimate price and more than 3,000 who were wounded.
- (5) Acknowledges the service of the approximately 1,800 Tasmanians who served in Vietnam, including 17 who died in their country’s service.
- (6) Further notes commemorative service and wreath-laying ceremonies were held across Tasmania to mark the event, and included the Vietnam Veterans Day Remembrance service at the Hobart Cenotaph, the Vietnam Veterans Commemoration service at Launceston Cenotaph, and the Day Service at the Vietnam Veterans Memorial site at the Cenotaph in St Helens, of which I am a Patron. I thank all the members of the Executive for their efforts in supporting Vietnam veterans on the East Coast over the years.
- (7) Honours the service and sacrifice of all those who fought for freedom in this conflict and remembers the motto of the VVAA: “Honour the Dead but Fight like Hell for the Living.” (22 August 2018)

71 The Minister for Resources to move—That the House:—

- (1) Notes and commends the ingenuity of SRT Logistics for investing in solar panels on an industrial scale for its worksite, working with.
- (2) Further notes that by partnering with Aurora Energy and BEON Energy Solutions, SRT Logistics developed a customised rooftop solar solution for their distribution warehouses at Launceston and Devonport, investing in over 2,500 panels, with approximately 830kW of capacity and the potential to generate enough power to service 143 homes.
- (3) That combined, this development is one of the largest commercial solar PV installations in Tasmania, which will empower the company to manage their power costs now and into the future.
- (4) Further notes that the Tasmanian Government whole-heartedly supports this type of business investment.

- (5) Commends SRT Logistics for this investment because it is not only significant investment in its business but it is also visionary thinking, in contributing to the development of more clean, affordable, renewable energy in Tasmanian.
- (6) Finally, the House notes that the SRT project assists in the Hodgman Liberal Government's objective of 100 per cent renewable energy in Tasmania by 2022. (22 August 2018)

72 The Minister for Building and Construction to move—That the House:—

- (1) Notes the Australian Institute of Architects - Tasmania Chapter, held the 2018 Tasmanian Architecture Awards on 7 July 2018, which attracted a record number of entries, covering 37 projects across 10 categories.
- (2) Further notes these entries showcased Tasmania's talented architecture profession - demonstrating a very high quality of designs and workmanship.
- (3) Further notes Tasmania's built infrastructure has long had a reputation of design excellence locally, nationally, and internationally, and the Architecture Awards recognise the finest accomplishments of Tasmanian architects.
- (4) Congratulates all shortlisted projects and winners across all categories, including public architecture, commercial architecture, sustainable architecture, interior architecture, heritage, small project, urban design, educational and residential architecture.
- (5) Further notes the winners of the '2018 Chapter Prizes':—
 - (a) Leigh Woolley awarded the President's Prize;
 - (b) Taylor and Hinds Architects awarded the James Blackburn Triennial Prize;
 - (c) Mat Hinds awarded the Emerging Architect Prize;
 - (d) Kwan Chak Law awarded the SWT Blythe Student Prize; and
 - (e) Latona Masterman and Associates awarded the Enduring Architecture award for the Friendly Beaches Lodge.
- (6) Further notes, all category projects recognized with an award or named award will proceed to the 2018 National Architecture Awards that will be announced in Melbourne in November 2018.
- (7) Congratulations to all entrants for their hard work and important contribution to the architecture profession in Tasmania. (23 August 2018)

73 The Minister for Building and Construction to move—That the House:—

- (1) Notes the Master Builder Awards for Excellence was held on 18 August 2018 at the Hotel Grand Chancellor in Hobart, attended by the Premier, the Hon Will Hodgman MP.
- (2) Further notes these awards celebrate Tasmania's best builders and their teams who demonstrate excellence, professionalism and an utmost commitment to quality workmanship in the projects being constructed around the State.
- (3) Further notes that there were 33 award category winners, highlighting the extremely high level of achievement of individuals and organisations who have excelled in their areas of expertise.
- (4) Further notes the special category winners, including:—
 - (a) Residential Master Builder of the Year – Davies Construction;
 - (b) Commercial Master Builder of the Year – Vos Construction & Joinery Pty Ltd;

- (2) Further notes these awards celebrate the outstanding accomplishments of the Tasmanian electrical and communications contracting industry, recognising leadership and excellence in quality, technology, innovation, management, and commercial expertise.
- (3) Further notes the awards recognise the finest accomplishments and outstanding contribution of electro technology apprentices who have excelled in their training.
- (4) Congratulates all the award entrants and winners on their achievements, hard work and commitment to the Tasmania electrical and communications industry:—
 - (a) Industrial small category – Shane Hill Electrical for the Distribution Centre project (commendation);
 - (b) Industrial medium category – RBD Electrical for the Tasports Inspection Head Services Upgrade project;

77 Ms *White* to move—That the House:—

- (1) Recognises the professionalism of the state's health workers who provide care to Tasmanians every day in a health system under enormous pressure.
- (2) Agrees that their ideas, insight and experience are invaluable to driving changes that result in better outcomes for patients.
- (3) Calls on the Minister for Health, Hon. Michael Ferguson MP to personally convene roundtable meetings with medical staff around the state so that he can hear their concerns first hand. (28 August 2018)

79 The Attorney-General to move—That the House:—

- (1) Acknowledges the Government's commitment to addressing the issue of sexual violence.
- (2) Notes that the Government has provided additional funding to the Office of the Director of Public Prosecutions to allow for the establishment of a new Family Violence and Sexual Assault Unit.
- (3) Further notes that this Unit has allowed for the Office of Director of Public Prosecutions and the Witness Assistance Service to engage with victims at an earlier stage.
- (4) Recognises that early engagement with victims reduces the rate of withdrawals, meaning more offenders are being held to account.
- (5) Commends the staff in this Unit for the important and difficult work they are undertaking. (28 August 2018)

80 The Minister for Primary Industries and Water to move—That the House:—

- (1) Congratulates students and staff at Prospect High School on the opening of an \$8.5 million renovation.
- (2) Recognises the mature approach by students during the major renovation process, as they welcomed trades men and women who worked to deliver new:—
 - (a) Art and Drama classrooms;
 - (b) communal spaces;

NOTICES OF MOTION

- (c) student change rooms;
 - (d) weights area; and
 - (e) staff room and administration facilities.
- (3) Further recognises the quality video production designed by students to document the renovation process.
 - (4) Notes the upgrade to Prospect High is part of the biggest investment in Tasmanian school infrastructure in more than 20 years.
 - (5) Further recognises that the Hodgman Liberal Government is committed to providing access to modern learning facilities for Tasmanian students to complete education through to year 12.
 - (6) Further recognises the Government's Capital Works upgrades to state schools which, as well as providing improved learning environment for students, is driving economic growth and creating jobs across Tasmania. (28 August 2018)

81 The Minister for Primary Industries and Water to move—That the House:—

- (1) Notes the release of the 2018 Tamar Estuary and Esk Rivers report card, the first since the signing of the Launceston City Deal.
- (2) Recognises the hard work of NRM North operations manager Amanda Locatelli for her ongoing commitment to the health of the Tamar River.
- (3) Further notes that the Tamar Estuary and Esk Rivers support a wide range of industries in northern Tasmania, from agriculture, forestry and fisheries, to heavy industry and tourism, and is valued by the community as one of the focal points for Launceston and for many recreational activities such as rowing, fishing, and boating.
- (4) Acknowledges that improving the health of the Tamar Estuary is essential, and this is why the state and federal governments have committed \$94.6 million to carry out key actions identified by the Tamar Estuary Management Taskforce over the next five years.
- (5) Further notes the long-term work on improving the Estuary's catchment and the combined Launceston sewerage and stormwater system will reduce the pathogen load entering the upper reaches of the Tamar.
- (6) Further recognises that this Government is committed to continuing the close co-operation between all tiers of government and our TEER partners to progress the management strategies identified by the Tamar Estuary Management Taskforce, leading to sustained on-going improvements in the health of the Tamar Estuary. (28 August 2018)

82 The Minister for Primary Industries and Water to move—That the House:—

- (1) Recognises the tremendous success of the inaugural Tassie Scallop Fiesta held in Bridport 2-5 August 2018.
- (2) Notes the Northeast community's support that ensured this winter festival achieved in the way it did.
- (3) Further notes the diverse range of events throughout the weekend including scallop splitting competitions, cooking demonstrations, live music and kayak ballet.
- (4) Congratulates Tony Scott, Len Gillett and their team of organisers for having the vision to create such a festival in a traditionally slower period for the local economy.
- (5) Further recognises the hard work of Tasmanian scallop fishers who brave the conditions to bring the scallops to port and build on Tasmania's strong brand.
- (6) Further notes that the seafood industry is a strong part of Bridport's heritage and means a great deal to regional Tasmania generally, providing employment and economic growth.
- (7) Looks forwards to the 2019 Tassie Scallop Fiesta to again celebrate the importance of the scallop industry to Bridport. (28 August 2018)

83 The Minister for Resources to move—That the House:—

- (1) Notes and commends the innovative and community inclusive approach TasNetworks applied to their joint Australian Renewable Energy Agency and University Consortium - Bruny Island solar and battery project - with the collaborative input of The University of Tasmania, the University of Sydney, The Australian National University and Reposit Power.

NOTICES OF MOTION

- (2) Commends TasNetworks for receiving the Energy Project of the Year Award from the Electric Energy Society of Australia in April 2018.
- (3) Acknowledges TasNetworks for receiving the Business Community Engagement Award from the Clean Energy Council at the Australian Clean Energy Summit in July 2018.
- (4) Further commends TasNetworks for receiving the Engineering Australia's Tasmanian Engineering Excellence Award in August 2018, and for becoming a finalist in the 2018 Australian Engineering Excellence Awards, soon to be announced in September.
- (5) Further notes the ingenuity of the project with 34 Bruny Island homes turned into 'mini-power stations' with the combination of rooftop solar panels, battery storage and energy management software that allowed households to actively trade and store the electricity their homes produced, and avoid TasNetworks starting up the back-up Bruny Island diesel generator during a major network peak.
- (6) Further notes TasNetworks' inclusive approach, working closely with the local community and the University of Tasmania to make the project a success.
- (7) Further notes the Tasmanian Government's enthusiastic support for this type of innovative community energy project.
- (8) Further acknowledges that the TasNetwork project assists the Hodgman Liberal Government's objective to become 100 per cent self-sufficient in renewable generation by 2022. (28 August 2018)

85 The Attorney-General to move—That the House:—

- (1) Notes the Hodgman Liberal Government's significant investment in the Tasmania Prison Service (TPS) in both staff and infrastructure is building a stronger, future-focussed corrections system for Tasmania.
- (2) Future notes the 2018-19 State Budget includes:—
 - (a) \$70 million for the new Southern Remand Facility that will house in excess of 150 remandees;
 - (b) \$45 million (of a \$150 million project) for stage one of the much needed new northern prison;
 - (c) \$9.3 million for shared facilities at the Risdon Prison site;
 - (d) \$17.2 million for alternative sentencing options; and
 - (e) \$16 million in additional operational funding for the TPS.
- (3) Acknowledges the Hodgman Liberal Government's comprehensive law and order agenda includes legislation to remove the outdated practice of granting remission, a practice that can see prisoners receive up to three months off their sentence.
- (4) Condemns the Labor Party for their continued failure to develop policy in this critically important portfolio.
- (5) Calls on Labor to get behind the Government's comprehensive plans for law and order and investment in our corrections system in both people and infrastructure. (29 August 2018)

86 The Minister for Environment to move—That the House:—

- (1) Notes the Government is committed to working with all levels of government, the waste industry and the wider community to improve waste management in Tasmania.
- (2) Further notes that the Government recently convened a round table to discuss the issue of waste management with key stakeholders from local government and the industry. It was agreed at the round table to develop a Tasmanian Waste Action Plan in collaboration with all levels of government, the waste and recycling industry and the broader community.
- (3) Acknowledges that the Government has already acted on its most pressing waste issues by providing grants for controlled waste and tyre processing facilities, making changes to the regulation of waste tyre stockpiling and assisting with the rollout of national product stewardship schemes for e-waste, paint, batteries and packaging.
- (4) Recognises that the Government has also made a number of further commitments to waste management, in particular tackling littering and dumping through Community Service Orders, improved reporting and enforcement of littering and dumping, working with local government to increase recycling capacity and the release of a report that considers the potential of a Container Refund Scheme (CRS) for the State.

NOTICES OF MOTION

- (5) Agrees that waste and recycling initiatives, such as a CRS or banning of particular products may have a role to play, but they should all be considered through the context of a Waste Action Strategy. (29 August 2018)

87 Ms *White* to move—That the House:—

- (1) Notes the Australian Bureau of Statistics (ABS) has released average weekly wage statistics, showing that Tasmanians earn the lowest average wage of any state or territory.
- (2) Acknowledges that the average Tasmanian worker earns \$10,000 less per year than the average Australian worker.
- (3) Further notes the ABS statistics showed the gap between average wages paid to Tasmanian public sector workers and their counterparts on the mainland has increased from 24% to 27% since the election of the Liberal Government in 2014.
- (4) Further notes the Liberal Government's 2% wage cap policy is at odds with the Department of Treasury and Finance's 2.25% CPI prediction, meaning Tasmanian public sector workers can expect a real wage cut.
- (5) Over the past four years, average public sector wage growth in Tasmania has been the second lowest of any Australian jurisdiction.
- (6) Calls on the Government to scrap its 2% wage cap policy and negotiate in good faith with our hard working public sector workers. (29 August 2018)

88 The Minister for Resources to move—That the House:—

- (1) Notes that 3 September 2018, was Australian National Flag Day, the annual day specifically dedicated to celebrating our national flag.
- (2) Further notes that Australian National Flag Day was officially established in 1996 by the proclamation of the former Governor-General, Sir William Deane [AC](#), [KBE](#), [QC](#) and celebrates the first time the flag was flown on 3 September 1901 over the dome of the Exhibition Building in Melbourne when then Primer Minister, Sir Edmund Barton [GCMG](#), [KC](#), announced the winners of a competition to design a flag for Australia.
- (3) Acknowledges the Australian National Flag as Australia's foremost national symbol and a unifying and powerful expression of Australian identity.
- (4) Further notes that Australian National Flag Day provides all Australians with an opportunity to reflect with pride and gratitude upon the achievements and qualities of this great nation since Federation.
- (5) Further acknowledges the sterling work of the Australian National Flag Association in promoting and protecting our national symbol, whose work locally is led by Mr Reg Watson and ably supported by patron the Hon. Elise Archer MP, Attorney-General.
- (6) Congratulates all individuals, community organisations, local authorities, businesses and schools across Tasmania that celebrated Australian National Flag Day by conducting flag-raising ceremonies and by flying or displaying the National Flag. (30 August 2018)

89 The Minister for Veterans' Affairs to move—That the House:—

- (1) Notes that Merchant Navy Day was 3 September 2018.
- (2) Further notes the Australian Merchant Navy Memorial is a memorial honouring the Australian Merchant Navy's involvement in World War 1 and World War 11.
- (3) Further notes that the memorial is located in Kings Park, on the northern shore of Lake Burley Griffin in Canberra and its location on the shore of the lake represents the Merchant Navy's relationship with water.
- (4) Recognises the Seafarers' Memorial is a memorial honouring the lives of all Tasmanian seafarers who lost their lives at sea, including those who served in the armed forces.
- (5) Further recognises the Tasmanian Seafarers' Memorial, located in Triabunna, on Tasmania's East Coast:—
 - (a) further notes the annual service on 3 October 2018; and
 - (b) the service will include the annual Blessing of the Fleet for the local fishing industry.

NOTICES OF MOTION

- (6) Acknowledges that Merchant Navy Day illustrates the important contribution made to Australia's economic growth and prosperity in peacetime and in war.
- (7) Further notes that the Merchant Navy of the whole British Empire, which included the Australian Merchant Fleet, suffered proportionately the highest casualties of any of the allied services in the Second World War.
- (8) Further notes that thirty thousand two hundred and forty eight British Empire merchant seamen who served at sea under the red ensign lost their lives doing so and that the Australian Department of Veterans Affairs nominal roll records 3,500 Australian merchant seamen serving in World War II in Australian registered ships. (30 August 2018)

90

Mr *Brooks* to move—That the House:—

- (1) Notes that mining and minerals processing is a key economic pillar in Tasmania, employing thousands and accounting for over 50 per cent of our exports in the year to June 2018, or more than \$2 billion.
- (2) Acknowledges that the sector is on the verge of major revival with:—
 - (a) the granting of approvals for a new \$100 million iron ore mine at Rogetta south of Burnie, that will create hundreds of jobs;
 - (b) a boom in job numbers at Grange Resources Savage River and Port Latta operations to around 560 FTEs and \$10 million investment in the first stage of a feasibility study that may lead to accessing the ore body through underground development; and
 - (c) the announcement that Hellyer Gold Mine will be re-opened and tailings processed to extract gold, silver, lead and zinc with up to \$1.5 billion in gold and \$1 billion in zinc to be processed from the tailings dams and up to 50 ongoing jobs created.
- (3) Further notes that the 2018-19 Budget includes \$2 million for the new Exploration Drilling Grant Initiative to expand the real and potential mining base industry in Tasmania through supporting increased 'greenfield' mineral exploration with applications opening on 6 September 2018.
- (4) Further notes that there is no better friend of the mining and minerals processing than the Hodgman Liberal Government. (30 August 2018)
