- 1 The House met at Ten o'clock a.m.
- 2 PRAYERS. – The Speaker read Prayers.
- 3 QUESTIONS SEEKING INFORMATION. – In accordance with Standing Order No. 43, Questions without notice were asked.
- 4 PAPERS. – The Minister for Health laid upon the Table of the House the following Papers:-

In respect of the financial year ending 30 June 2019, the payment out of the Consolidated Fund of the sum of four billion, seven hundred and fifty seven million, and six hundred thousand dollars (\$4 757 600 000) for the purpose set forth in Schedule 1 to the Consolidated Fund Appropriation Bill (No. 1) 2018.

**11** MESSAGE FROM HER EXCELLENCY THE GOVERNOR. – The Speaker read the following Message from Her Excellency the Governor: -

MESSAGE.

C. A. WARNER, *Governor*.

In accordance with the provisions of Section 38 of the Constitution Act 1934 (25 Geo. V. No. 94), the Governor recommends to the House of Assembly:

In respect of the financial year ending 30 June 2019, the payment out of the Consolidated Fund of the sum of thirty one million, and seven hundred and eight thousand dollars (\$31 708 000) for the purpose set forth in Schedule 1 to the Consolidated Fund Appropriation Bill (No. 2) 2018

“A Bill for an Act for the appropriation of \$31,708,000 out of the Consolidated Fund for the services of the Parliament and Statutory Offices for the financial year ending on 30 June 2019” (Bill No. 17)

“A Bill for an Act to amend the Payroll Tax Act 2008, the Payroll Tax Rebate (Apprentices, Trainees and Youth Employees) Act 2017, the Land Tax Act 2000, the First Home Owner Grant Act 2000 and the Duties Act 2001” (Bill No. 18)

And Mr *Gutwein* having presented the said Bills, the same were read the First time and made Orders of the Day for a later hour.

**14** **MEMBERS OF THE LEGISLATIVE COUNCIL ENTER THE HOUSE FOR BUDGET SPEECH.** - The Speaker said: - “In accordance with the Resolution passed by the House of Assembly on 13 June 2018, I now invite Members of the Legislative Council to enter the Chamber to listen to the Treasurer’s speech”

Accordingly, the Sergeant-at-Arms escorted Members of the Legislative Council onto the Floor of the House.

**15** **BILL NO. 16.** - The Order of the Day being read for the Second reading of the Consolidated Fund Appropriation Bill (No. 1) 2018.

And a Motion being made, and the Question being proposed - That the Bill be now read the Second time. (The Treasurer)

And the Budget Speech having been delivered the Members of the Legislative Council withdrew.
