



An apology was received from Mr. Davies for non-attendance on the plea of urgent private business.

The Chairman reported having received a watch from Mr. Burt, which had been the subject of legal action in the case.

The Clerk Assistant was directed to return the watch to Mr. Burt, as its production did not assist the Committee in their inquiry.

Resolved, That the Registrar of the Court of General Sessions, Fingal, be requested to forward a verbatim copy of the charge-sheet of the Fingal Court of General Sessions of the 7th November, 1888, to be duly certified to by him.

Resolved, That ex-Superintendent of Police, Mr. Dineen, be requested to forward a written statement of any knowledge he possessed bearing on the case.

The Committee adjourned at 11.50 A.M. until 11 A.M. on Thursday, the 1st December.
