Response:

The Crown Law output is made up of three separate offices: the Office of the Crown Solicitor (OCS), the Office of the Solicitor-General and the State Litigation Office. The total operating budgets for the Office of the Crown Solicitor in recent years are:

2024-25 = \$5,962,746 2023-24 = \$5,769,093 2022-23 = \$5,383,403 2021-22 = \$4,912,150 2020-21 = \$3,937,751

OCS established a Panel for Legal Services for complex commercial matters in May 2024. Other outsourced legal services are procured consistent with Treasurer's Instructions. Any outsourced legal services are paid for by the instructing agency. The Office of the Crown Solicitor does not have full oversight of the total costs of outsourced commercial legal services but provides the following data from its records.

The following information is drawn from OCS' records for Panel administration and data gathered to inform establishment of the Panel. The following information is not limited to State construction projects. It extends to a range of commercial matters, including development projects (where a third party may develop infrastructure for the State's use) and ICT infrastructure (which is an increasing component of OCS' work). Not all matters undertaken resulted in a completed transaction.

Response:

It is not possible to break the budget down against every individual program delivered by the Tasmania Prison Service.

The two tables below detail the funding source and allocation under specific funding streams.

The funding does not include staff on-costs, professional development or other staff-related expenses for 2025-26 and 2024-25.

In addition, the Tasmania Prison Service's funding for rehabilitation and reintegration programs is drawn from the TPS' budget allocation for permanent staff and specific budget line items for contract positions. The TPS' budget allocation funds permanent staff actively involved in the delivery and coordination of programs.

The TPS has also paid nominal sums for some program licensing in previous financial years, however, the funding for programs is expended on employing staff and contracting with community partner organisations.

Output Group 3.2- Community Corrective Services

1. In terms of the Key Deliverables listed, the Community Corrections - Managing High Risk Offenders is receiving \$1.38m this year and each year across the forward estimates. It is stated in the Budget that it is for operational funding to manage high risk offenders orders and case-manage and monitor dangerous criminals, and high-risk offenders post release including psychological assessments and secretariat services. Can you provide a breakdown of how those funds will be used across those elements? (MW)

Response:

The Dangerous Criminals and High Risk Offenders Scheme is a priority policy for the Tasmanian Government. Community Corrections is required to provide comprehensive advice to the High Risk Offenders (HRO) Assessment Committee established under the *Dangerous Criminals and High Risk Offenders Act 2021*, and to then manage those offenders in the community. My Department also provides secretariat services to the HRO Assessment Committee.

In the 2025-26 Budget, Community Corrections has been provided with ongoing operational funding of \$1.38 million per annum to manage the HRO orders and to case manage and monitor high risk offenders, pre- and post release.

High Risk Offenders are the highest risk offenders managed by Community Corrections who have significant and multifaceted needs that will require intensive case management and support across the life of the order. Additional Community Corrections Officers are required to manage these clients. The officers working with this cohort will supervise lower caseloads, more intensively. They will also receive additional training and ongoing support from specialist therapeutics officers to plan approaches to case management, ensuring a comprehensive risk mitigation approach is taken to community safety. The following table outlines how the Department will allocate this ongoing, operational funding.
