

HOBART FIRE BRIGADE BOARD.

REPORT of the Fire Brigade Board for the City of Hobart for the Year ending 31st December, 1896, made pursuant to Clause 13 of "The Fire Brigades Act, 1883."

DURING the past year the Brigade has attended 21 fires. The Board have to report that the conduct of the Firemen has been satisfactory, and their duties performed most efficiently.

The net expenditure for the year amounts to $\pounds 702$ 18s., which sum is divided equally between the Government, Corporation, and Insurance Companies, as per account attached hereto.

The Superintendent reports that the appliances and plant of the Board are in good order.
