

PENSIONS AND COMPENSATION.

ORDERS IN COUNCIL UNDER SUPERANNUATION ACT.

Laid upon the Table by Mr. Chapman, and ordered by the Council to be printed, July 31, 1874.



ORDERS in Council made under "The Superannuation Act" since the last Meeting of Parliament.

MONDAY, AUGUST 25, 1873.

MINUTE No. 196.

THE Colonial Secretary submits that, in order to carry out the reorganisation of the Audit Department, Mr. Augustus White Parsons be allowed to retire on a pension, calculated on the 5th Clause of "The Superannuation Act," at the rate of £200 per annum.

The Governor approves.

To take effect on and from the 1st October next.

MONDAY, OCTOBER 13, 1873.

MINUTE No. 262.

The Colonial Secretary brings before His Excellency for reconsideration the subject of Mr. Willis's pension, on which an opinion was expressed in the House of Assembly adverse to the application to his case of the rule laid down in Minute No. 96 of 19th May last; and recommends that the full period of 10 years allowed by Section 5 of "The Superannuation Act" be added to his actual term of service, making his pension £288 15s. per annum.

The proposed increase is approved by His Excellency: to take effect from 1st May last: the excess to be provided for upon a Supplementary Estimate.

MONDAY, DECEMBER 1, 1873.

MINUTE No. 291.

Upon the recommendation of the Board of Education, His Excellency grants a Superannuation Allowance under Section 1 of "The Superannuation Act" of £13 10s. 4d. to Mrs. Cora Tucker, late Schoolmistress at Mount Seymour, near Oatlands.

To take effect from the 1st September last, and to be provided for upon a Supplementary Estimate.

MONDAY, MARCH 23, 1874,

MINUTE No. 78.

The Colonial Secretary submits that, upon the recommendation of the Sheriff, Mr. Thomas Reidy, late Gaoler at the Male House of Correction, Hobart Town, be allowed to retire from the public service, in consequence of ill health, and that he be granted a Retiring Allowance of £86 10s. 3d. per annum, calculated upon the following basis:—

Mr. Reidy's period of service under the Imperial and Colonial Governments commenced on the 7th January, 1853, and terminated on the 30th June, 1873—20 years and 6 months: say 20 years.

17.5 salary and emoluments for the last three years amounted to £438 14s. 8d. per annum, 20-60 has of which = £146 4s. 11d., less £59 14s. 8d., the amount of his Imperial Pension = £86 10s. 3d, which is now proposed to be granted to him as a Pension from the Colonial Government.

The Governor approves: to take effect on and from the 1st January last, and to be charged upon a Supplementary Estimate.

MONDAY, APRIL 27, 1874.

MINUTE No. 125.

On the recommendation of the Chairman of the Board of Education, Superannuation Allowances are granted, from the 1st January last, to the under-mentioned persons:—

To Mr. William Barlow, late Schoolmaster at the Mona Vale School, at the rate of £22 4s. 11d. per annum.

To his wife, Mrs. Mary Ann Barlow, late Mistress at the same School, at the rate of £5 10s. per annum.

The amounts to be provided for upon a Supplementary Estimate.

MINUTE No. 126.

On the recommendation of the Surgeon Superintendent, Hospital for the Insane, New Norfolk, His Excellency approves of Mrs. Hannah Workman, Sub-Matron of that Institution, being allowed to retire in consequence of infirmity of body, and grants her a Superannuation Allowance at the rate of £17 7s. 6d. per annum, to take effect on the 1st instant.

The amount for the present year to be placed upon a Supplementary Estimate.
