



Meeting of Parliament.

#### MONDAY, OCTOBER 19, 1868.

#### MINUTE No. 211.

The Governor grants Compensation to the following persons who have been deprived of their situations as Constables by the annexation of the Carrick portion of the Police District of Selby to the Municipality of Westbury:—

#### MONDAY, NOVEMBER 30, 1868.

#### MINUTE No. 225.

The Governor approves of Mr. William Grahame, at present Keeper of the Public Offices, being allowed to retire in consequence of age and failing health, and grants him a Pension at the rate of £93 per annum. To take effect on and from the 1st January next, and to be provided for on a Supplementary Estimate.

## THURSDAY, FEBRUARY 18, 1869.

# MINUTE No. 27.

The Council submit—That Compensation for loss of office be granted to John Sullen, late Master Baker at the Queen's Asylum, for the period of 7 years and 11 months (being his term of service); and that such Compensation be calculated upon the average Salary received by him for the last 3 years, and not upon the amount of Salary at the time of his reduction, inasmuch as his Salary was twice diminished within that period without any fault of his own.

The Administrator approves.

#### SATURDAY, MARCH 6, 1869.

#### MINUTE No. 43.

The Council submit—1. That Joseph Brown, Mail Guard, having met with an accident whilst in the execution of his duty, by which his thigh was broken, and having been reported as incapacitated for further service, be allowed to retire, and to receive a Pension at the rate of £27 16s. 11d. per annum, from the 10th instant inclusively.

2. That Mr. James Waterland, Pilot at the Port of Launceston, who is about to be reduced by the Marine Board, be allowed a Pension of £143 6s. 8d. per annum, from 1st April next.

His Excellency approves of both recommendations: the amounts, as regards the current year, to be provided for upon a Supplementary Estimate.

#### SATURDAY, APRIL 10, 1869.

## MINUTE No. 68.

The Council submit—That in consequence of the intended re-organisation of the Post Office Department, and the failing health of Mr. Hardinge, the Postmaster and Secretary, Hobart Town, that gentleman's services be dispensed with from the 31st March; and that he be granted a Retiring Allowance under the 5th Clause of "The Superannuation Act," at the rate of £341 13s. 4d. per annum. To be provided for on a Supplementary Estimate.

The Governor approves.

## MINUTE No. 70.

The Public School at Birch's Bay having been discontinued by the Board of Education in consequence of the small number of pupils, and the services of the Schoolmistress, Mrs. Harriet Storer, having in consequence been dispensed with, the Governor approves of her receiving a Pension at the rate of £9 17s. 6d. per annum from 1st January, 1868. To be provided for upon a Supplementary Estimate.

#### TUESDAY, APRIL 20, 1869.

# MINUTE No. 73.

The Governor grants to William Wilson, late Overseer at the Queen's Asylum, who is incapacitated from the performance of further duty by old age and a broken arm, a Pension at the rate of £35 17s. 7d. per annum from the 1st March last. To be provided for upon a Supplementary Estimate.

# MONDAY, JUNE 28, 1869.

#### MINUTE No. 129.

The Council submit—That in accordance with the practice of the Lords Commissioners of Her Majesty's Treasury in computing the services of Colonial Chaplains for Pension, as notified in Despatch No. 26, of the 10th March, 1869, namely,—"That the period of service of the Chaplains should be reckoned from the date of their receiving any Salary in respect of their Appointments,"—the Pension awarded to the Rev. Dr. Browne, of Launceston, be increased from £404 5s. to £413 4s. 8d. The increase to take effect from the 1st May, 1868

The Governor approves.

## MONDAY, JULY 26, 1869.

#### MINUTE No. 151.

The Governor approves of the recommendation contained in the following Minute:—That, in accordance with the practice of the Lords Commissioners of Her Majesty's Treasury, in computing the services of Colonial Chaplains for Pension, as notified in Despatch No. 26, of the 10th March, 1869, namely,—That "the period of service of the Chaplains should be reckoned from the date of their receiving any Salary in respect of their Appointments,—the Pension awarded to the Venerable Archdeacon Davies be reduced from £469 8s. 10d. to £465 16s. 8d; such reduction to take effect from the 1st instant.

## THURSDAY, AUGUST 5, 1869.

# MINUTE No. 157.

The Council submit—That, partly at his own request, and partly in accordance with certain arrangements made by the Government, Mr. Sandford Scott be permitted to retire from the Public Service, and be allowed a Pension, calculated upon the 1st Section of "The Superannuation Act, 1860," at the rate of £210 per annum: to take effect from the 1st October next, and to be provided for upon a Supplementary Estimate.

The Council further submit—That, in accordance with the terms of the Minute of the Governor in Council, No. 227, of 6th July, 1863, (Paper, House of Assembly, No. 69), the sum of £50 be paid to Mr. Scott on his retirement: to be also provided for on a Supplementary Estimate.

The Governor approves.
