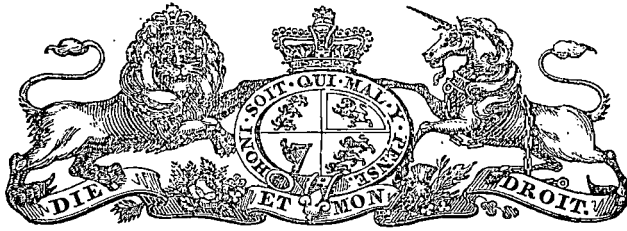

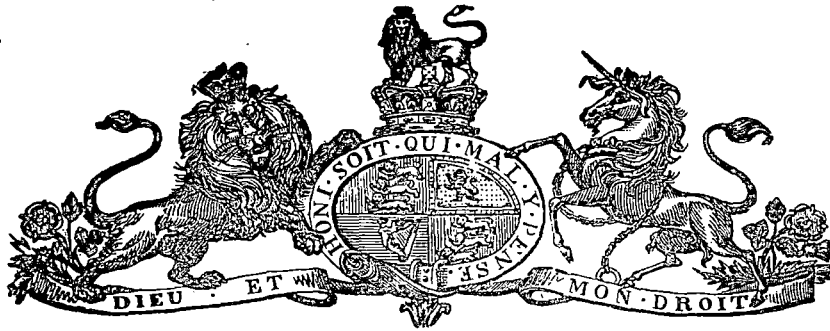
PARLIAMENT OF TASMANIA.
