# The President of the Board of Immigration, or the Hon. the Chief Secretary.

SIR,

I HAVE the honor to submit to you the Report of my recent mission as your Agent for the introduction of Immigrants from the north of Europe, as follows :----

I left the Colony in September, 1884, for Hamburg, with instructions to select and despatch a number equal to 100 adults, and certain nominated passengers on the assisted system, and also to act for the selection and despatch of full-paying passengers under the Land Order Warrant system, The number of applicants on my list seemed to offer sufficient inducement to the steamship company to despatch one of their steamers direct to Hobart. On applying in London, as instructed, to the then Agent of the Board, I found that his term of office had only a few more days to run, viz., to the end of the year, and that no funds were placed at his disposal for covering the expenses of passage money for said emigrants.

Having these emigrants on hand, and the Board temporarily unrepresented, by Mr. Buckler's own assertion, I had to apply to the Crown Agents, as financial Agents for the Government of Tasmania. They readily came to my assistance, by obtaining cable instructions from your Board. The delay thus occurred had, however, the effect of causing a number of my applicants to proceed to the States or some other Colonies; and, on returning to Hamburg, I found fresh instructions, dated November, to limit the entire number to 100, *including* the nominations; and I found the Company unwilling to continue negociating on the reduced number.

In the meantime local influences had been set to work in London to counteract my operations; and what was worse, I found, on my return to Hamburg, that the Imperial Government, in the face of a strong current running in the direction of a German colonisation scheme, had set their face against any proposal to ship Danes. Scandinavians, Germans, and others to a *British* Colony, which made my task to complete the number required extremely difficult. This difficulty is now, however, removed. I had a number anxiously waiting to go, and was compelled to go back to London to communicate with and book the remaining passengers. When this was effected, with much difficulty and delay, I met a fresh obstacle in shipowners, under the circumstances, raising their demand for passage money to a figure which would have entailed considerable loss to the Board; and ultimately writing, when my passengers were ready, that they had no ship to offer.

There was nothing left to me but to revert to the German line, who accepted my offer (£6 per adult less from Hamburg viâ Melbourne to Hobart). This has been satisfactorily carried out. I need only point to the result of my careful selections, as usual, shown by the number of useful colonists that I have been instrumental in introducing by the steamship *Procida*. In the meantime, and during my operations, I accepted a large number of applications of persons desirous of emigrating to Tasmania at their own expense, under the Land Order Warrant System. Obtained offers from steamship companies to assist their coming out at no expense to the Colonial Government, of which offers I enclose the copy of one. Under these conditions, I am committed to nearly 400 approved applicants to forward them out to Tasmania within about 12 months, if required; and they would, no doubt, consider it an act of repudiation if the Immigration Act, 1885, should shut them out from carrying out their intention, after giving notice, selling out, and making all preparations to emigrate to Tasmania.

I beg respectfully to submit to the Board to empower me to carry out so much of the arrangements as I have made prior to the passing of the said Act, passed a month after my departure from Germany to Hobart.

On my leaving Tasmania on this last mission, I had a thousand copies each of the different forms for foreign emigration handed me by the Immigration Agent, and a set of photographs of Tasmanian scenery, to exhibit at my office.

This would naturally lead me to suppose that the Board wished me to extend my operations to secure as many desirable full-paying emigrants as I could, outside of the limited fund then available for assisted passages. My work was then extended in that direction, viz., emigration from the north of Europe, at no money outlay to the Government.

Taking it for granted that no subsequent instructions, recalling those under which I was then acting, would be allowed to cancel what action I had been taking, I was asked to leave final arrangements for a personal visit to the Colony again; and I respectfully submit that I cannot very well be asked to tell my waiting emigrants, on my return, that the Tasmanian Government now refuse to receive them. It would entail a heavy responsibility and loss on myself, and reflect little credit on the Colony amongst the friends and relations already settled here. A number of the latter have also commissioned me to act as their agent in bringing out their friends from the Continent, under the Regulations of 23rd December, 1882, now in force; and I respectfully request the Board to authorise my selecting them personally, and submitting them to the approval of the Agent-General in London.

Those intending emigrants, partly full-paying and partly bounty tickets, were all secured through my canvassing, but could not yet proceed because of the Board's suspending my operations without previous notice. This has caused my coming out; and I trust the Immigration Department will support me in an action which I have taken entirely in theirs and the interests of the Colony.

# Immigration Office, Hobart, 29th April, 1886.

I CERTIFY that German Immigrants arrived at Hobart per s.s. *Procida* on 17th September, 1885, to a number equal to 89 adults. I have reason to believe that these Immigrants were all duly supplied with sea kits under Section 11 of the Regulations attached, as many kits were landed; and in answer to my inquiries the Immigrants made no complaints.

Mr. Buck was called in and requested to explain certain items. After discussion it was resolved to refer the accounts back to Mr. Buck for further explanation and the production of necessary vouchers.

I HAD the honor to address you on the subject of German and Scandinavian Immigration on August 23rd, October 6th, 15th, and 24th.

Since the 15th October—when I acceded to your condition as to bond which you required (before entering into the various questions of detail which would have to be arranged prior to any action being taken)—I have awaited the honor of your further communications. In the meantime I have continued, as I did since March last, to attend to the multifarious details of office work connected with the Germans already here, and the continuance of such Immigration as proposed, translating official and other documents, answering for Department during absence of agent, &c., viz., ten months work and delay without remuneration—and my loss is a heavy one through the long protracted delay. Considering the great benefit the Colony has derived from my past work, I would respectfully solicit a favourable consideration of my case, or a suggestion by which my experience and know-ledge of Immigration matters could be availed of.

#### To His Excellency the Governor in Council.

The humble Petition of Frederick Buck, of Hobart,

**RESPECTFULLY SHOWETH:** 

1887-March.

1. That your Petitioner, as Immigration Agent for this Colony in Germany, and assisting in former similar agencies, has, at various periods, dating back as far as 1855, been instrumental in introducing to Tasmania immigrants of German, Austrian, Danish, Swedish, and Norwegian nationalities, which, in the opinion of the Colony, have proved most valuable additions to our population.

2. That their introduction, entirely due to your Petitioner's judicious and careful selection, and their subsequent successful settlement, has increased the Annual Revenue of the Colony by thousands of pounds, as seen by the number of German names on the Valuation Rolls. The settlement called Bismarck, in the Glenorchy District, is a fair specimen of your Petitioner's work in the way of thriving German settlements on what had always been considered "Waste" Lands all over the Colony.

3. That a revival of this class of Immigration was decided upon in 1884, and your Petitioner was induced to proceed Home and resume his labours.

4. That the funds voted by Parliament having been nearly exhausted by the London Agency, a balance was only found sufficient for the introduction of 100 adults of the above-mentioned class until further moneys were voted,—the Government meanwhile furnishing your Petitioner with necessary information, telegraphic codes, and other accessories to enable him to perform the duties of Director of the Immigration Office in Germany.

5. That all the arduous work, initiated at great personal expense and anxiety to your Petitioner, for the purpose of inducing respectable and suitable persons to come to Tasmania, was abruptly stopped by the Government, and money found only for 88 adults, out of a large number who were willing to emigrate.

6. That your Petitioner, so far from deriving any benefit from what may be considered most valuable work done for the Colony, has hitherto had to submit to a serious loss of several hundred pounds, caused by detention on arrival in London through the disorganised state of the Immigration Department, which had not provided the money for emigrants' passages; waiting two years here for repayment of cash advanced for Government; stoppage of office without notice; and other matters entirely beyond your Petitioner's control.

7. That the small portion of Immigrants to which Government finally limited your Petitioner was landed here in 1885, and proved again to be of a superior class.

8. That your Petitioner, irrespective of the losses mentioned, has now actually still to receive a sum of £91 5s., expended by your Petitioner for the Government in 1884, which your Petitioner proposed to receive personally from the Agent-General in London, your Petitioner being given to understand that an effort would be made to bring out the 200 German and Danish country people still on the list, and connected with the foreign colonists already here. If money had been voted, your Petitioner would have been prepared to start for London.

9. That this idea having been since abandoned, your Petitioner cannot justly be expected to spend nearly the whole of the amount mentioned in travelling to collect it.

10. That your Petitioner prepared and published in Germany, under authority from the Tasmanian Government, an Illustrated Handbook of Tasmania, in German, Danish, and English, for which he was never paid, although the work had a large circulation, and was favourably reviewed by the Continental Press. A second edition was afterwards reprinted by the Melbourne Government Printer for the Tasmanian Government.

11. That your Petitioner did duty at the late Immigration Office, Hobart, until its final close, during the absence of the Immigration Agent on railway commissions, hospital enquiries, Easter encampments, &c., also in communicating officially with the foreign settlers, translating and interpreting for the Chief Secretary's and other Departments, for all of which no clerical provision had been made, but for which work your Petitioner has not yet received any remuneration whatever. 13

12. That your Petitioner, through the above described circumstances, has suffered a heavy pecuniary loss

Your Petitioner therefore humbly prays that your Excellency in Council will be pleased to order the payment to your Petitioner of the £91 5s. above referred to, with such other remuneration as may be considered, under all the circumstances of the case, fair and just for valuable work actually performed for the Government without fee or reward.

And your Petitioner, as in duty bound, will ever pray.

# Memo. to accompany Account herewith.

1. On my arrival here, 4th March, 1885, Mr. Just, then leaving on the Railway Commission, kindly obtained, for the purpose of my winding up with the Immigration Board, the partial use of a spare office at Immigration Department, and arranged for my representing him during his absence, which, as he stated recently, was understood to be for a week or fortnight, but which extended into months. Of the immigrants, the Germans and Danes especially kept me fully employed up till now, knowing me as able to correspond and converse with them.

2. The Lands and Works and the Chief Secretary's Departments can testify to the continuous work I did for and with these immigrants as interpreter, translator of correspondence, and other work connected with Immigration Department. If it was averred that there was no work to do during absence of Agent besides answering the door, the official salary paid to the officer shows the contrary.

3. My cash outlays and interest incurred for these immigrants in 1884-5 are completely lost, and a ruin to me. One-half was spent in waiting here from 4th March to 4th August, 1886, for their repayment, and the balance I can only get back by travelling home; so that this amount would again be absorbed by the expense of collecting it; whereas I was led to fully expect recovering my loss by some adoption of my proposals in letters dated 23rd August, 6th, 15th, 24th October, 9th December, all still unanswered.

4. The Handbook, in English, German, and Danish, written and edited by me whilst not in Government pay, the Government adopted by having it reprinted in Melbourne, without mentioning author. Only the cost of paper and printing copies ordered out from me has as yet been repaid by Government.

5. I at once admit I have no legal claim on the Government, having omitted to stipulate for the remuneration for my services before doing the work. On the last occasion the Government allowed me £1 per diem for attending my immigrants after their arrival here.

6. In throwing myself on the mercy of your Government, I may mention that the cancelling my engagement in June, 1884, without the legal notice, was a loss of several hundred pounds to me, quite irrespective of a costly illness caused by worry and the death of my son at home during my detention here.

IN reference to your Petition to His Excellency the Governor dated 9th instant, respecting a claim for compensation for services rendered in connection with Immigration, I must decline to admit any liability whatever on the part of the Government for recompense to you for work performed, as a complete settlement has already been made.

With regard to the sum of £91 5s., I have to refer you to the terms of your Bond dated 20th July, 1886, which requires that you shall produce to the Agent-General for the Colony in England "full and sufficient vouchers or receipts to the satisfaction of the Agent-General, together with a full "and sufficient receipt for One hundred Sea Kits of the value of One hundred Pounds" before payment is made to you of that amount. I am not prepared to authorise any deviation from these conditions.

It appears to have escaped your memory that on the 29th March, 1887, any outstanding claims on your part for further compensation were fully discharged, for the terms of your receipt for the sum of £50 then paid to you are :----"This amount is in liquidation of all claims preferred by "me for services rendered to the Government in connection with Immigration and for all other "demands whatsoever up to date." Further comment on your Petition is not required.
