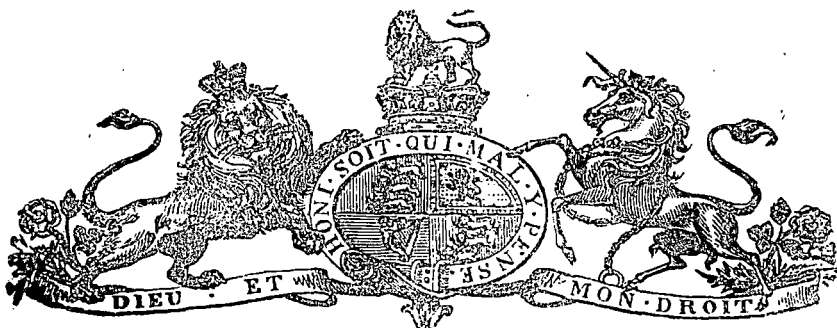

MONDAY, SEPTEMBER 24, 1883.

MINUTE No. 537.

HIS Excellency grants to Mr. John Rothwell, late Deputy Sheriff, a Retiring Allowance of £233 6s. 8d. per annum, commencing on the 1st instant.

To be provided for upon a Supplementary Estimate.

MONDAY, OCTOBER 15, 1883.

MINUTE No. 576.

UPON the recommendation of the Sheriff, the Governor grants a Retiring Allowance at the rate of £60 per annum to James Corkindale Mann, Messenger in the Sheriff's Office.

To commence on the 1st November next, and to be provided for upon a Supplementary Estimate.

WEDNESDAY, JANUARY 30, 1884.

MINUTE No. 72.

THE Chief Secretary, through the Premier, submits that, in accordance with Section 7 of "The Superannuation Act," (24 Vict. No. 15), a reduced Superannuation Allowance of £250 per annum be granted to Mr. Henry Jocelyn Hull, late Deputy Commissioner of Crown Lands, on the ground of Mr. Hull having failed, while acting as such Deputy Commissioner, to keep the accounts of his receipts and payments of public moneys in proper order, and of his not being able to account satisfactorily to the Government for the non-entry by him in his books of moneys admitted to have been received by him on account of the Public Service; the amount of which moneys he has since repaid to the Government.
