



During the year the Brigade attended 26 fires, as per schedule herewith, and the Superintendent reports the Firemen performed their duties in a satisfactory manner.

An account of Receipts and Expenditure is also attached hereto, showing the net expenditure as £740 9s., which has been equally divided between the Government, the Corporation, and the Insurance Companies.
