

PARLIAMENT OF TASMANIA.

ORDERS OF THE GOVERNOR IN COUNCIL UNDER SUPERANNUATION ACT.

Presented to both Houses of Parliament by His Excellency's Command.



ORDERS of the Governor in Council made under "The Superannuation Act" since the last Session of Parliament.

MONDAY, AUGUST 11, 1884.

MINUTE No. 464.

THE Governor grants the following Retiring Allowances:-

1. To Peter Keegan, Constable, per annum, £37 3s. 9d.

To take effect on 1st March last.

- 2. To Mr. Allen Baxter, Head Teacher Public School, Hagley, per annum, £96 3s.
- 3. To Mrs. Margaret Baxter, Mistress of Public School, Hagley, per annum, £14 13s. 4d. To take effect on 1st January last.

The amounts of all these Retiring Allowances for the present year to be placed upon a Supplementary Estimate.

MINUTE No. 474.

In accordance with Section 7 of "The Superannuation Act," (24 Vict. No. 15), the Governor grants to Mr. John Lambert, late Superintendent of Police, a reduced Superannuation Allowance of £71 7s. 11d. per annum, upon a reduction of one year's service, in consequence of his intemperate habits.

To take effect on 1st April last: the amount to be placed upon a Supplementary Estimate.

MINUTE No. 76.

As a case of emergency, His Excellency approves of the sum of £281 5s. being paid to Mr. Richard Fitzsimons, late Chief District Constable, being arrears of Pension from 1st July, 1862, to 31st December, 1884, under the 5th Section of "The Superannuation Act," as recommended by a Select Committee of the House of Assembly.

To be placed upon a Supplementary Estimate for the year 1884.

TUESDAY, MAY 26, 1885.

MINUTE No. 275.

Upon the recommendation of the Sheriff, His Excellency grants to Mr. Ringrose Austin Atkins, Gaoler and Superintendent of the Gaol and Penal Establishment, Hobart, a Retiring Allowance at the rate of £235 12s. per annum.

To take effect on 1st April last: the amount for the present year to be placed upon a Supplementary Estimate.

MONDAY, JULY 27, 1885.

MINUTE No. 369.

On the recommendation of the Sheriff, His Excellency grants to William Archer, Court House Keeper and Crier of the Supreme Court and Court of Requests, Launceston, a Retiring Allowance of £106 16s. 3d. per annum, commencing on the 1st instant.
