A BILL FOR

An Act to amend, repeal and revoke certain legislative instruments consequential on the enactment of the Australian Consumer Law (Tasmania) Act 2010

Be it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

PART 1 – PRELIMINARY

1. Short title

This Act may be cited as the Australian Consumer Law (Tasmania) (Consequential Amendments) Act 2010.

2. Commencement

This Act commences on the day on which Part 3 of the Australian Consumer Law (Tasmania) Act 2010 commences.
