OVERVIEW

1.1 Overview and Strategy

The House of Assembly, together with the Legislative Council and His Excellency the Governor, constitute the Parliament, whose responsibility it is to consider legislation, to authorise the raising of revenue and the expenditure of State monies.

1.2 House of Assembly Mission

To provide the House of Assembly, its committees, the Speaker of the House and Members with advisory, procedural, research and administrative support services of a high standard to assist them to effectively undertake their constitutional and Parliamentary duties.

The mission of the House describes its basic purpose. From this are derived general corporate goals.

1.3 Corporate Goals

The goals of the House of Assembly as a whole are:-

- to support the House in its constitutional role
- to provide the highest levels of advice and procedural research and administrative services necessary for the effective functioning of the House, its committees and Members
- to promote public awareness of the purpose, functions and work of the House and encourage and facilitate visits by the widest possible range of citizens
- to perform all of its functions at the highest attainable levels of professional competence and efficiency
- to be a fair and responsible employer, maximising the potential of all its staff through effective human resource practices.

- leadership
- resource allocation

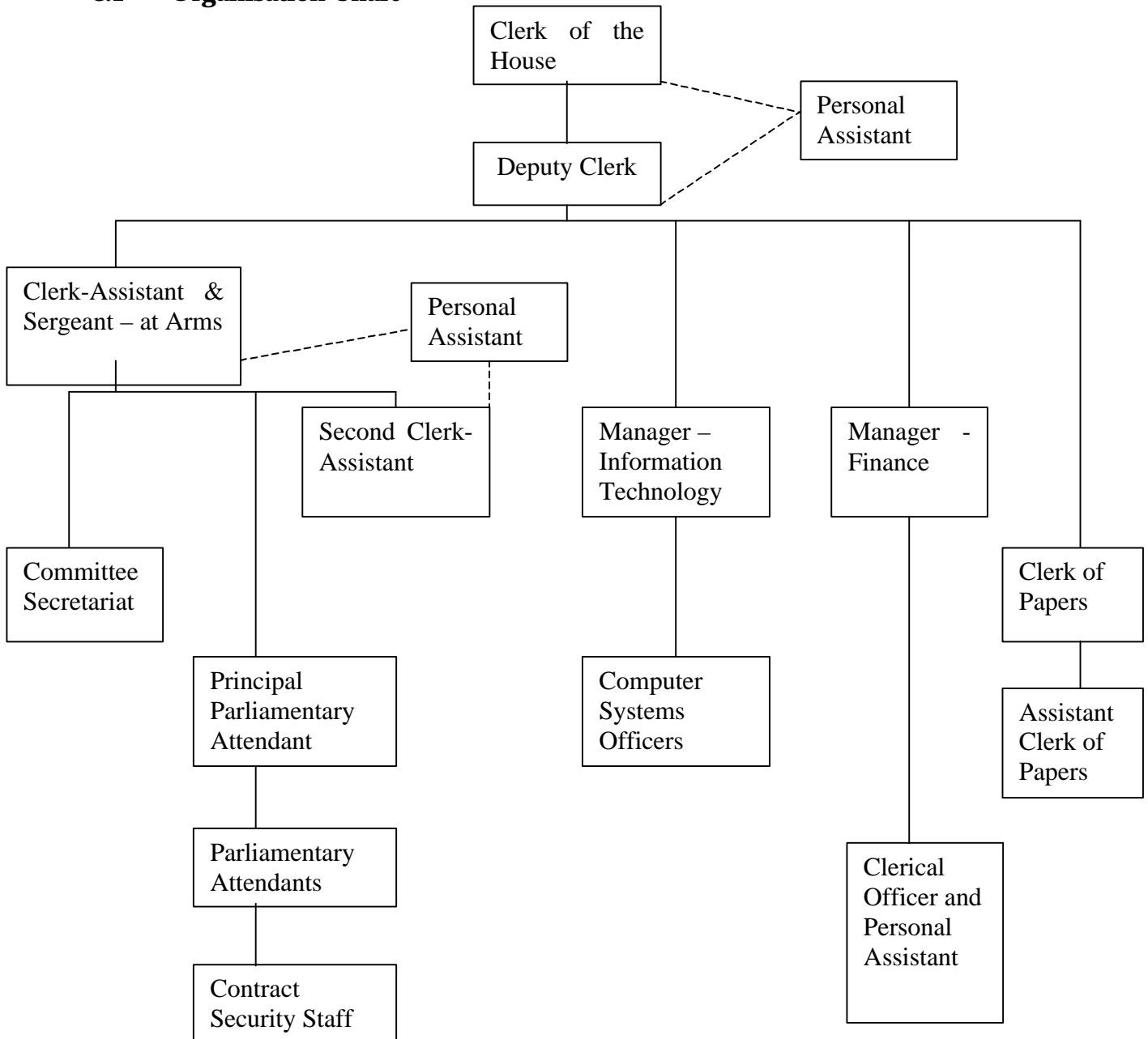

The Secretariat provides administrative support for the Standing Committee of Public Accounts and the Standing Committee on Public Works.. The activities of the Public Accounts and Public Works Committees are reported in the Annual Report of the Legislature-General.

4.4 Work of committees

A summary of the Committee work supported by the Secretariat is set out below.

Community Development Committee

The Committee was established by order of the House of Assembly on 23 October 1996 as a pre-legislative review committee for socially significant legislative proposals and a forum for public consultations.

The Committee was disbanded on 29 July 1998 with the dissolution of Parliament pending the election on 29 August 1998.

Subsequent to the election the Committee resumed sitting on the 26 February 1999. The election radically altered the membership of the Committee with only one previous member of the Committee being reappointed.

The membership of the Committee as at 30 June 2000 was The Hon F. M. Bladel (Chair), The Hon D. E. Swan, Mr D. M. Fry, Mr B. A. Green and Mr K. J. Bacon.

During the financial year 1999-2000 the Committee met on 12 occasions, 5 of which were convened to conduct public hearings.

During the financial year 1999-2000 the Committee received references from the Attorney-General for the Inquiry into Legal Recognition of Significant Personal Relationships and for an Inquiry into the use of Cannabis for Medical Purposes. At 30 June 2000 these inquiries were still current.

Joint Select Committee on the Working Arrangements of the Parliament

The Committee was established by order of the House of Assembly and the Legislative Council on 7 October 1998.

The membership of the Committee as at 30th June 2000 was Mr Michael Aird MLC (Chair), Mr Don Wing MLC, Mrs Sue Smith MLC, Mr Paul Lennon MHA, Dr Peter Patmore MHA and Mr Ray Groom MHA.

During the financial year 1999-2000 the Committee met on 3 occasions. The Committee is currently considering a draft report on a New Parliamentary Committee System which is expected to be tabled before the end of this calendar year.

6.4 Training

Staff development continued during 1999-2000 with staff attending courses in the areas of information technology, emergency awareness and control and the new tax system.

6.5 Equal Employment Opportunity

The House of Assembly is an equal opportunity employer. Representation of House of Assembly staff in EEO target groups can be summarised as follows:-

- (i) 44% of staff are women;
- (ii) 0% of staff are Aboriginal or of Torres Strait Islander descent;

6.6 Industrial Democracy

The House has a co-operative approach to decision making. The size of the House allows for direct and immediate consultation between staff and executive officers. Formal channels of conflict resolution are accessible by staff of the House.

6.7 Occupational Health and Safety

Occupational health and safety is a principal management consideration of the House, with the provision of equipment, facilities and programs, such as eye testing for users of screen-based equipment, to ensure the safety and well being of staff. Parliament House is currently the subject of a 'Strategic Asset Management Plan' being undertaken by Freeman Firth Conservation Architects and Planners. Occupational health and safety matters have and will continue to be considered in some detail within this plan.

The Report found that the financial statements complied with statutory requirements and met applicable accounting standards. The audit report on the financial statements was unqualified.

The House of Assembly was not subject to inquiry by a Parliamentary Committee during 1999-2000.

8.3 Decisions of Courts and Administrative Tribunals

The House of Assembly is aware of no judicial decisions or decisions of administrative tribunals handed down during the year which have significantly affected, or could significantly affect, the operation of the Department.

Commonwealth Parliament: Parliamentary Education Office

During the week 15-19 May 2000 over 1350 students in 37 class groups were able to participate in structured parliamentary education role play lessons conducted by Parliamentary Education Office Outreach Program Unit.

Additionally the Office conducted a teacher development program for over 50 teachers and a day long workshop in conjunction with the YWCA. The workshop entitled was attended by approximately 25 women aged from 17 to 35.

The Office commented that the atmosphere and ambience of the House of Assembly Chamber, the Legislative Council Chamber and the Members Lounge added to the success and authenticity of the programs

INDEPENDENT AUDIT REPORT

To the Clerk of the House

Scope

I have audited the financial report comprising Cash Statements prepared on the cash basis of accounting, and Operating, Financial Position and Cash Flows Statements and notes thereto of the House of Assembly for the year ended 30 June 2000. The Clerk of the House, as Head of Agency, is responsible under Section 27(1) of the Financial Management and Audit Act 1990 for the preparation of the financial report in accordance with the reporting framework prescribed in the Treasurer's Instructions issued under the Act. I have conducted an independent audit of the financial report in order to express an opinion on it to the Clerk.

The audit has been conducted in accordance with Australian Auditing Standards and used procedures which included examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial report, and the evaluation of significant accounting estimates. These procedures have been undertaken to form an opinion whether, in all material respects, the financial report is presented fairly in accordance with the Treasurer's Instructions, Australian Accounting Standards and other mandatory professional reporting requirements so as to present a view which is consistent with my understanding of the financial position of House of Assembly and the results of its operations and its cash flows.

The audit opinion expressed in this report has been formed on the above basis.

Audit Opinion

Notes to and forming part of the financial statements for the year ended 30 June 2000

1. Objectives and funding

The House of Assembly (The House), together with the Legislative Council and His Excellency the Governor, constitute the Parliament of Tasmania, which has the responsibility to consider legislation and to authorise the expenditure of State monies.

The office of The Clerk of the House of Assembly provides the House, its Committees, the Speaker of the House and Members with advisory, procedural, research and administrative support services to assist them to effectively undertake their constitutional and Parliamentary duties.

The objectives of the office of the Clerk of the House are:-

- to support the House in its constitutional role
- to provide the highest levels of advice and procedural research and administrative services necessary for the effective functioning of the House, its committees and Members
- to promote public awareness of the purpose, functions and work of the House and encourage and facilitate visits by the widest possible range of citizens
- to perform all of its functions at the highest attainable levels of professional competence and efficiency
- to be a fair and responsive employer, maximising the potential of all its staff through effective human resource practices

The House is predominantly funded by Parliamentary appropriations and reserved by law appropriations for the above services and for the administration of the payment of salaries and allowances as prescribed by the *Parliamentary Salaries, Superannuation and Allowances Act 1973*.

The financial report encompasses all Funds through which the House controls resources to carry on its functions.

In the process of preparing accrual based reports for the House as a single entity, all intra-entity transactions and balances have been eliminated.

2. Significant Accounting Policies

(a) Basis of Accounting

The financial statements have been prepared in accordance with the Treasurer's Instructions issued under the provisions of the *Financial Management and Audit Act 1990*. For activities financed through the Public Account, selected statements have been prepared on a cash basis of accounting. These statements comprise a Summary of Financial Transactions, a Summary of Consolidated Fund Transactions and a statement for the account in the Special Deposits and Trust Fund administered by the House.

Other statements in respect of the total activities of the House have been prepared on an accrual basis in accordance with the Treasurer's Instructions and applicable Australian Accounting Standards. Collectively these financial statements comprise the general purpose financial report of the House. They have been prepared using historical cost accounting, with the exception that non-current physical assets are valued at their current value to the House, determined by reference to the asset's deprival value.

Administered expenses and revenues are those which the Government requires the House to administer on its behalf but which are not controlled by the House in carrying out its functions. These revenues and expenses are not attributable to the House.

(b) Appropriations

Appropriations are recognised as revenues in the period in which the House gains control of the appropriated funds.

(c) Valuation of non-current assets

With the exception of antique furniture and artworks and artefacts the asset capitalisation threshold adopted by the House is \$5,000 in respect of assets having a useful life of 2 years or more. Assets valued at less than \$5,000 are charged to the operating statement in the year of purchase. Antique furniture and artworks and artefacts are treated as discrete groups of assets and all items in those groups are recorded as non-current assets.

Revaluations of all assets shall be performed on a five yearly basis.

Assets are grouped on the basis of having a similar nature or function in the operations of the House.

(d) *Depreciation of non-current assets*

All non-current assets having a limited useful life are systematically depreciated over their useful lives in a manner which reflects the consumption of their service potential. Depreciation is provided for on a straight-line basis, using rates which are reviewed annually.

Depreciation of computer equipment is based on a service potential of 3 years. Depreciation of furniture and fittings is based on a service potential of 10 years.

As the service potential of heritage assets remains static, no depreciation is provided on these classes of assets. These classes are identified as Antique furniture and Artworks and artefacts in the statement of financial position.

(e) *Employee entitlements*

Employee entitlements include entitlements to wages and salaries, annual leave, sick leave, long service leave and superannuation benefits.

Liabilities for wages and salaries and annual leave are recognised, and are measured as the amount unpaid at the reporting date at current pay rates in respect of employees' services up to that date. The liability for sick leave is not material and has not been recognised.

A liability for long service leave is recognised, and is measured in accordance with Australian Accounting Standard AAS 30 "*Accounting for Employee Entitlements*".

A superannuation provision is maintained in the Special Deposits and Trust Fund for all departments. During the reporting period, the House paid to the provision 11 per cent of salary in respect of contributory members and the appropriate Superannuation Guarantee Charge in respect of non-contributors. Under these arrangements the House has met all of its obligations under the *Superannuation Guarantee (Administration) Act 1992* of the Commonwealth and has no further superannuation liability for the past service of its employees.
