

MOUNT BISCHOFF PROVIDENT HOSPITAL:

REPORT FOR 1891.

Presented to both Houses of Parliament by His Excellency's Command.



ELEVENTH Annual Report of the Mount Bischoff Provident Hospital, for the Year ended 31st December, 1891.

THE Committee of the above Institution have much pleasure in submitting the Eleventh Annual Report and Balance Sheet.

Buildings and Improvements.—The buildings are in a thorough state of repair. Two large galvanised tanks, with a capacity of 600 gallons each, have been fixed in position in case of drought or fire.

Medical.—During the year the Medical Officer, Dr. R. A. Brewis, has treated 375 cases as outside patients, viz., males 195, females 180, and 18 males as in-door patients. No deaths during the year in the Hospital : notwithstanding the unusual amount of sickness prevalent lately in La Grippe or Influenza, together with Typhoid cases, the Committee are pleased in stating every one recovered. Two severe cases of Typhoid from Zeehan have been attended to with the best results. No Female Nurses being procurable in this District Male Nurses had to be employed at considerable extra expense. The Medical Officer, Dr. R. A. Brewis, has been very assiduous in his duties.

Financial.—The year has closed, notwithstanding the heavy drain on the finances, with a credit balance of £578 5s. 6d. against £378 9s. 2d. of last year.

Subscriptions.—The subscriptions for 1891 amount to £252 17s. 4d. against £288 19s. 10d. of previous year.

Kayser, Esq., Manager Mount Bischoff Company, for the sum of £26 15s. collected from visitors to the mine, and handed over to the Hospital. His sympathy for our local Institution is of the heartiest.
