

Sir,

On behalf of the Members of the Statistical Conference—convened by you by Circular Telegram on 23rd January, for the purpose of deciding upon uniformity of system for taking the approaching Census—I have to state that the Conference met on the 3rd March, in Hobart, and concluded its labours on 18th March, and I have now the honor of transmitting to you their extended Report. (Appended.)

Extent and Nature of Subjects of Enquiry.

The Members of the Conference unanimously deemed it unwise to extend the subjects of enquiry beyond the limits already determined in the Householder's Schedule of the Census for 1881, viz.—Name, Sex, Birth-place, Age, Religion (statement not compulsory), Occupation (stating whether Employer, employed on his or her own account, or Wage-earner), Conjugal Condition, Education, Sickness and Infirmity, Materials of Houses, Number of Rooms. The only other item of enquiry agreed to—viz., Number of each description of Live Stock—although not hitherto a subject of Census enquiry in Tasmania, is a most desirable one, and has hitherto formed one of the regular subjects of Census enquiry in the neighbouring Colonies. The model Schedule agreed upon secures perfect uniformity in all these subjects of enquiry, although it was conceded that any Colony is free to extend enquiry beyond these limits should it be deemed advisable to do so.

Classification and Modes of Tabulation.

As there were several imperfections arising out of defective classification and through lack of agreement in modes of Tabulation in the last Census, the Members of Conference were anxious to devise means for avoiding such difficulties or defects in the coming Census. At the same time they were impressed with the importance of adhering as far as possible to modes of classification hitherto employed, as without such cautious consideration useful comparisons with former periods and with other countries would be rendered impossible.

Classification of Occupations.

The classification of Occupations in the last two Censuses of the British Possessions, although of considerable value, has many serious defects. It was originally devised by the late Dr. Farr, C.B., F.R.S.. of England, for use in the United Kingdom. The deviser of this classification endeavoured to trame the groups and combinations as far as possible according to *the materials on which people worked*. So far as minor groups or combinations are concerned this method was fairly successful, but as regards the principal classes of workers it could not form a guiding principle; for it is obvious that all classes of workers must often be related to the self-same materials, and separation into principal Classes could not possibly be based successfully upon this method. It is not surprising, therefore, that Dr. Farr's classification should present many defects and anomalies. For example, Class II.—Domestic, and Class VI.—Indefinite and Non-Productive, hopelessly mixed up Breadwinners and Dependants. Similarly, Primary Producers, Distributors, and Manufacturers were indifferently mixed together under three very distinct Classes—viz., Commercial, Class III; Agricultural and Pastoral, Class IV.; and Industrial, Class V. It is apparent that the lack of any clearly recognised principle for determining the limits of the great Classes themselves led the original Classifier into great perplexities; for we find *Fishermen*, *Veterinary Surgeon*, and *Farrier* grouped under Class Agricultural and Pastoral; Chimney-sweep grouped under workers in Coal; and the Miner, Quarryman, and other Primary Producers are found classed together with a moiety of the *Dealers*, along with Night-soilmen, Artizans, and Manufacturers.

Having long been impressed with these defects in the old system, I endeavoured to amend the classification of Breadwinner Group and Dependants in my last issue of the "Tasmanian Official Record" for 1890, and I had the honour of devising what I deemed to be an improved method of classification, which I submitted to the Members of the Conference at its fourth sitting. Mr. T. A. Coghlan, the accomplished Government Statistician of New South Wales, also submitted a detailed scheme of subordinate groups of Occupations somewhat upon the same lines. These together met with the approval of the other Members of the Conference, and I had the honour to be associated with Mr. Coghlan in drawing up an elaborate and systematic scheme of Classification of Occupations, embodying the principles already presented to them, which, with slight amendments, eventually received the unanimous approval of the Members of the Conference, who resolved to adopt it in the tabulation of the next Census.

The amended Classification is divided into seven principal classes. The first six embrace all independent *Breadwinners*; the seventh, or last class, embracing all *Dependants*. The three important classes related to *Materials* are kept separate by regard to the relationship which their *differing services* bear to the materials which pass through their hands. Thus, Primary Producers of Raw Materials directly acquired by labour from natural sources, bring naturally into one class (Class V.) those engaged in Agriculture, Grazing, Fishing, Hunting, and Mining. Transporters, Dealers or Distributors, who effect no material change in Producers' materials, come naturally together in Class Commercial (Class III.); while all skilled and unskilled modifiers or constructors of materials, in a similar way, come naturally together in Class Industrial (Class V.)

The Domestic Class (Class II.) no longer includes wives and others engaged at home in domestic duties for which no remuneration is paid, nor dependent relatives or children.

The Professional Class (Class I.) only includes those ministering to Religion, Charity, Education, Art, Science, and Amusement, and those connected with the General and Local Government, and in Defence, Law, and Protection. All persons employed by the General and Local Government whose occupations are properly related to the Producing, Commercial, and Industrial Groups are classed with the latter, as it is obvious the main value of such classification is to ascertain *how employed*, and not by whom employed. The exact extent of the Government Service can be easily obtained by reference to the Civil List, and by direct reference to Local Bodies throughout the country.

To facilitate classification, I was also enjoined by the Conference to draw up a more extended tabulation of sub-groups under each of the 104 sub-orders. This I have now done, and, when printed, it is intended to submit the same for the final consideration of the several members of the Conference. It is hoped that this amended classification will more fully meet the wants of the social economist and statesman, who were often, hitherto, misled by the defective nature of the groupings in the older mode of classification. The new classification has also the advantage that tables may readily be prepared from it on the lines of the old method to enable comparisons to be made.

General.

The other matters, though of great importance to the tabulator and statistician, only affect matters of detail, and secure accuracy and uniformity. It is important to state, however, that one of the recommendations affecting the Census Act, to be introduced during the first Session of Parliament, is, that only the heads of enquiry—not the Schedule—be embodied in the Census Act.

I may, in conclusion, take the liberty of reminding you that the work to be done prior to the actual date fixed for the Census involves an enormous amount of labour, for which provision must be specially made at an early date. A draftsman should be set apart as soon as possible to work under the direction of the Superintendent of the Census, in preparing by hand the colours of the boundaries of districts to be enumerated on charts and plans; and, as soon as the Act is passed, it will be necessary to provide for the extraordinary amount of printing necessary in the matter of schedules, enumerators, books, printed instructions, compilation-sheets and cards, &c.

I trust the observations which I have made may be of some service to you when dealing with the recommendations contained in the accompanying Report of the Conference.

CLASSIFICATION OF OCCUPATIONS.

DEFINITION OF PRINCIPAL CLASSES.

SECTION A.-BREADWINNERS.

Class.

- V. CAGRICULTURAL, PASTORAL, MINERAL, AND OTHER PRIMARY PRODUCERS.—(Georgici and part of the Technici of Farr.)—Embracing all persons mainly engaged in the cultivation or acquisition of food products, and in obtaining other raw materials from natural sources.
- VI. INDEFINITE.—Embracing all persons who derive incomes from services rendered, but the direction of which services cannot be exactly determined.

SECTION B .--- DEPENDANTS : NON-BREADWINNERS.

VII. DEPENDANTS.-Embracing all persons dependent upon relatives or natural guardians, including wives, children, and relatives not othernise engaged in pursuits for which remuneration is paid; and all persons supported by private charity, or dependants upon the public revenue. 

REPORT.

TO THE HONORABLE THE CHIEF SECRETARY OF TASMANIA.

Sir,

WE, the Representatives of various Australasian Colonies, at a Conference held at Hobart, in accordance with your invitation, for the purpose of arranging for the collection and compilation of the ensuing Census upon a uniform principle, have the honor to report as follows :---

1. We have held twelve meetings, the Minutes of which will be found in Appendix A.

2. The enquiries to be embodied in the Census Schedule have been fully discussed, and we have agreed to certain recommendations on the basis of which we have framed a model Schedule, a copy of which is given in Appendix B.

3. In view, however, of the possibility of its being found desirable to make alterations in the wording of this Schedule after the Census Act has been passed, in cases where the passing of a Census Act is necessary, we have unanimously resolved to recommend that only the heads of enquiry—not the Schedule—be embodied in the Census Act.

4. The compilation of the Returns of the Census upon a uniform principle has engaged our earnest attention; and, after much deliberation, we have agreed to a series of Resolutions bearing upon the subject, the substance of which is given in Appendix C.

5. The Forms decided upon, with the exception of those for the Occupation Tables, have been mainly those followed by most of the Colonies in compiling the Returns of the Census of 1881. We have, however, deemed it desirable to make radical changes in the tables showing the occupations of the people, as those hitherto adopted have been judged to be out of date, and not suitable to the present requirements of the several Colonies. After lengthened consideration and discussion, we have devised a system of classification which, we believe, with possibly some modifications to be indicated by future experience, will be found to offer a means of overcoming the great difficulties with which the systematic grouping of the occupations of the people of a country has always been found to be attended. The details of this proposed classification will be found in Appendix D.

6. To facilitate, however, comparisons with the Returns of previous Censuses, we propose that, in addition to the Tables of Occupations compiled according to the newly devised system, subsidiary tables be given showing the different groups of occupations, prepared upon the lines of the plan which the new system is intended to supersede.

7. In settling the form of classification under the different heads of enquiry, we have had in view Lord Knutsford's circular despatch of the 28th February, 1889; and have arranged to give effect, as far as possible, to the recommendations embodied in the letter of the Registrar-General of England attached thereto.

8. The system proposed for adoption is calculated to secure uniformity in the tabular statements to be published by the different Colonies. This uniformity, however, will not be broken should it be desired to amplify the Returns, or bring them out in more extended detail than that provided for, which it is distinctly understood any Colony is at liberty to do.

9. We have much pleasure in expressing our sense of the valuable assistance rendered by Mr. T. C. Just in his capacity of Secretary to the Conference, to which post, by the kind consideration of your Government, he was appointed before our proceedings commenced.

MONDAY, 3RD MARCH, 1890.

The Members of the Conference met informally.

Present.—H. H. Hayter, Esq., C.M.G. (Victoria); R. M. Johnston, Esq., F.L.S. (Tasmania); H. J. Andrews, Esq. (South Australia); E. J. von Dadelszen, Esq. (New Zealand); and T. C. Just, Secretary.

After brief discussion as to the mode of conducting business, the Conference adjourned, to meet at Parliamentary Committee Room at 10.30 A.M. to-morrow.

TUESDAY, 4TH MARCH, 1890.

THE Conference met at 10.30 A.M.

Present—H. H. Hayter, Esq., R. M. Johnston, Esq., H. J. Andrews, Esq., B. J. von Dadelszen, Esq., and the Secretary.

Mr. Johnston moved-"That H. H. Hayter, Esq., be elected President of the Conference."

Mr. Andrews seconded.—Carried.

Mr. von Dadelszen moved---" That Mr. E. C. Nowell be invited to be present during the meetings of the Conference, and to favour them with his advice and assistance."

Mr. Johnston seconded.—Carried.

Mr. Nowell soon afterwards entered the room, and was present during the meeting.

The President intimated receipt of a letter from the Premier, appointing Mr. T. C. Just to act as Secretary to the Conference.—Received.

A letter was read from the Colonial Secretary of Fiji, stating that although no delegate from that Colony could attend the meeting, the Government would be glad to fall in with the arrangements recommended by the Conference as far as circumstances would allow. Information was also given, especially as to the mode of taking the Census of the Native population of Fiji.—Received.

A telegram was read from the Acting Colonial Secretary of Western Australia, stating they would be unable to send a delegate to the Conference, but would be glad to be informed of conclusions arrived at, and to receive a copy of the Report.

The President tabled a series of recommendations as to the subjects respecting which enquiry should be made at the Census, and as to the best method of compilation. These recommendations were discussed seriatim.

Section 2 postponed.

Sections 3 to 5 agreed to.

Section 6, amended by the insertion of the words "laid up or" between the words "numbers" and "unable" in the second line. Further consideration of section postponed.

Section 7 agreed to.

Section 8 amended by insertion of the word "the" before the word "Aborigines" in line one, and the insertion of the words "as far as possible" before the said word "Aborigines." Section, as amended, agreed to.

Section 9 postponed.

Section 10 agreed to.

Conference adjourned until 10.30 to-morrow.

WEDNESDAY, 5TH MARCH.

Conference met at 10.30 A.M.

Present.—H. H. Hayter, Esq. (President), Messrs. R. M. Johnston, H. J. Andrews, E. J. von Dadelszen, T. A. Coghlan (New South Wales), E. C. Nowell, and the Secretary.

The Minutes of the preceding meeting were read and confirmed.

The recommendations tabled on the previous day by the President were again considered, sections 1 to 10 being read for Mr. Coghlan's information.

The remaining sections, up to and including section 10, were agreed to.

Section 11 agreed to.

Section 12. Strike out the word "widely" in line 9, also the words "as, for instance, one a Protestant and the other a Roman Catholic or a Jew"; also all the words after "unspecified" in line 2, page 3, to the end of the Section.

Section 13 agreed to.

Section 14 discussed at length and postponed.

Adjourned to 10.30 to-morrow.

Present.—H. H. Hayter, Esq. (President), Messrs. R. M. Johnston, H. J. Andrews, E. J. von Dadelszen, T. A. Coghlan, E. C. Nowell, and the Secretary.

The Minutes of the preceding meeting were read and confirmed.

The President's recommendations were further considered.

Section 14 was further considered.

Mr. Johnston submitted the following classification as to Occupations which he had drawn up, in conjunction with Mr. Coghlan :---

CLASS I. *Professional*—(Andrici, Farr.)—Embracing all persons mainly engaged in the government and defence of the country, and in satisfying the intellectual, moral, and social wants not included in the material services rendered by other classes hereafter specified or classed.

CLASS II., *Domestic.*—Embracing all persons engaged in rendering personal services, and in the supply of board and lodging, for which remuneration is usually paid.

CLASS III., Commercial—(Trade and Transport, United States Census, 1881—Agorici, Farr.)— Embracing all classes of service directly connected with the sale, transfer, distribution, storage, and security of property and materials, but who as a rule do not effect any material change in the nature of the objects which pass through their hands.

CLASS IV., Agricultural and Primary Producers—(Georgici, and part of the Technici of Farr.)— Embracing all classes of service mainly engaged in the cultivation or acquisition of food products and in obtaining other raw materials from natural sources.

CLASS V., Industrial—(Part of the Technici of Farr.)—Embracing all persons not otherwise classed who are principally engaged in specialties connected with the construction, modification, or alteration of raw or unspecialised materials so as to render them available for the various uses of man, but excluding as far as possible all who are engaged mainly or solely in the service of protection and distribution.

CLASS VI., *Indefinite.*—Embracing all persons who derive an income from services rendered, but the direction of which services cannot be exactly determined.

CLASS VII., Dependants.—Embracing all persons dependent upon relatives or natural guardians, including wives and children, relatives not otherwise engaged in pursuits for which remuneration is paid, and all persons supported by private or public charity, or maintained at the expense of the public revenue.

The classification was discussed and referred to Messrs. Johnston and Coghlan to prepare Sub-orders with alphabetical classification of Occupations thereunder.

Mr. Coghlan called attention to the classification of women, especially in reference to agricultural pursuits. It was resolved—"That it be understood and agreed upon, that wives be not tabulated as of the occupation of their husbands unless specially so stated on the schedule. Where no occupation is stated such women to be classed under the head of domestic duties."

Mr. Coghlan moved that Messrs. Hayter and Dadelszen be appointed to draw up a model Householder's Schedule for consideration by the Conference, in harmony with the resolutions agreed upon. Mr. Johnston seconded.—Carried.

Conference adjourned until 10.30 to-morrow.

SATURDAY, 8TH MARCH.

Conference met at 10.30 A.M.

Present.—H. H. Hayter, Esq., (President), Messrs. R. M. Johnston, H. J. Andrews, E. J. von Dadelszen, T. A. Coghlan, E. C. Nowell, and the Secretary.

The Minutes of the preceding meeting were read and confirmed.

Mr. Johnston brought up a Report from the Committee on Sub-orders and Alphabetical Classification, which was discussed at length, and various modifications suggested, the Report being referred back to the Sub-Committee.

Conference adjourned until 10.30 on Tuesday.

TUESDAY, 11TH MARCH.

Conference meet at 10.30 A.M.

Present.—H. H. Hayter, Esq. (President), Messrs. R. M. Johnston, H. J. Andrews, E. J. von Dadelszen, T. A. Coghlan, E. C. Nowell, and the Secretary.

The Minutes of the preceding meeting were read and confirmed.

Mr. Johnston brought up a revised Report from the Sub-Committee, with systematic classification of Occupations into Classes and Orders (Appendix D.)

The classification was agreed to, with amendments.

The President brought up a report from the Sub-Committee on the Householder's Schedule, submitting a model Schedule.

Mr. Coghlan moved that the following be section 8 of the recommendations :---

8. That the "Householder's Schedule," which is drawn up in accordance with the foregoing Resolutions, (Appendix B.) hereto attached, be the basis of the inquiries to be made under the Census Act.

Mr. Andrews seconded.—Carried.

Mr. von Dadelszen moved—That it is desirable to insert a column in the Census Schedule, under the heading "Occupation," to show the distinction between employers of labour or persons in business for themselves, and wage-earners, by entering the letters E. for employer or person not in any service, and W. for wage-earner.

Mr. Johnston seconded.—Carried.

Resolved, That the Schedule and Classification be printed.

Section 1 of the President's recommendations was reconsidered, and amended by striking out all the words after "hereto" in the fourth line.

Section 114.—After discussion, this Section was amended as follows :----

"That in tabulating the occupations of the people the numbers of either sex under 5 years of age; between 5 and 15; 15 and 20; 20 and 25; 25 and 45; 45 and 65, and over 65, be distinguished; that the occupations be tabulated according to the amended system of classification indicated in Appendix D.; also that additional tables, so far as the classes and orders are concerned, be prepared according to the systems followed in the majority of the Australasian Colonies at the Census of 1881; also that subsidiary tables be compiled showing, (I.) The ordinary occupations of the unemployed of either sex. (II.) Employers of labour and persons in business for themselves, also wage-earners. (III.) The ordinary or former occupations of inmates of either sex of (a) Hospitals, (b) Benevolent Asylums, (c) Hospitals for the Insane, (d) Other Charitable Institutions, (e) Gaols and Penal Establishments. (IV.) The occupation he be tabulated, as a rule, under the head of the first mentioned—the exception being a Government officer following some other calling, as, for instance, 'Deputy Registrar and Storekeeper,' in which case he is to be classified as the latter; also a person residing where one of his occupations is carried on which would warrant its being considered as the most important; as, for instance, 'farmer and publican' living at the public-house, is to be classed as a publican, although that calling may be stated second."—Agreed to.

Conference adjourned until 10.30 to-morrow.

- This Schedule is to be filled up in accordance with the headings to the columns on the other side by THE OCCUPIER OR PERSON IN CHARGE OF THE DWELLING with particulars respecting all the persons who slept or abode therein on the night of the , also of the Live Stock kept. If the house is occupied by different families in separate stories or apartments, each such story or apartment must be treated as a separate Dwelling, and the Occupier or person in charge of each must make a Return upon a separate Schedule. 

APPENDIX C.

RESOLUTIONS OF THE CONFERENCE.

SUBJECTS OF ENQUIRY.

1. That the subjects respecting which it is desired that enquiry be made at the Census be named in "The Census Act," but that the Schedule containing those enquiries be not attached thereto.

2. That the subjects of enquiry be as fellow :--Name, Sex, Birthplace, Age, Religion, Occupation, Conjugal Condition, Education, Sickness and Infirmity, Materials of Houses, Number of Rooms, Number of each description of Live Stock.

3. That the Return of Religion be not compulsory, but that it be optional to insert the word "object" instead respecting any one having a conscientious objection to state his religious belief.

4. That the Return of Occupations include an enquiry as to the number of unemployed of each trade or calling.

5. That, with reference to Education, an enquiry be made as to those able to read and write, able to read only and not write, and unable to read : also as to those who may be graduates of any University, together with the designations of their respective degrees, and of the Universities at which they were severally conferred.

6. That with reference to Sickness and Infirmity an enquiry be made as to the numbers laid up or unable to pursue their usual occupation on account of illness or the effects of an accident, or who may be deaf and dumb, blind, insane, idiotic, epileptic, paralytic, leprous, or who may have lost a limb or the sight of an eye.

7. That in the Return of Houses, those inhabited, uninhabited, and in course of erection be separately distinguished.

8. That, in accordance with the foregoing Resolutions, the Householder's Schedule (Appendix B.) hereto attached be the basis of the enquiries to be made under "The Census Act."

COMPILATION.

9. That the Chinese and the Aborigines, as far as possible (including half-castes), be tabulated apart from the general population under every head of enquiry, so that it may be possible to combine their numbers therewith or separate them therefrom, as may be desired.

10. That in compiling the Census Returns, the groupings be as definite as possible; and although it may be sometimes necessary to have such headings as "Other Birthplaces," "Other Religions," "Miscellaneous Occupations," &c., the names of the various Birthplaces, Religions, Occupations, &c. placed under such heads be in every case stated, in foot-notes or otherwise.

11. That, in working out proportions under any head of enquiry to show the value of the numbers in each line to the total, the items in the line for the unspecified be altogether excluded from the computation.

12. That, in the general tables of birthplaces provision be made for showing the number of natives of each of the principal countries of the world and of each Australasian Colony named in the Schedules; also, in foot-notes or separate table, the number of natives of each of the smaller countries of the world there named. That persons whose birthplace is stated to be "Australia" if under 12 years of age be tabulated as born in the Colony to which the Census relates, but if 12 years of age or over, in the column for "Australia undefined."

13. That provision be made in the general tables for showing the numbers and sexes of the adherents to all the principal Religious Sects named in the Schedules; and in foot-notes or separate tables the numbers and sexes of all the adherents to all minor sects there named. That children respecting whom the return of religion is unspecified be tabulated as of the religion of their parents if the father and mother are stated to be of the same religion, or of the religion of one parent if specified; but that if the parents are of different denominations, no assumption be made as to the religion of the children, who are to be classed as unspecified.

14. That the ages of the people of either sex be tabulated in single ages up to 21, then in quinquennial periods of age up to 85, and after that in single ages; also, that a table be prepared showing the numbers of either sex in the whole population at each year of age.

15. That in tabulating the Occupations of the people, the numbers of either sex under 5 years of age between 3 and 15; 15 and 20; 20 and 25; 25 and 45; 45 and 65, and over 65 be distinguished; that the occupations be tabulated according to the amended system of classification indicated in Appendix D.; also that additional tables, so far as the classes and orders are concerned, be prepared according to the systems followed in the majority of the Australasian colonies at the Census of 1881; also that subsidiary tables be compiled showing (I.) the ordinary occupations of the unemployed of either sex; (II.) employers of labour and persons in business for themselves, also wage-carners; (III.) the ordinary occupations of inmates of either sex of (a) hospitals, (b) benevolent asylums, (c) hospitals for the insane, (d) other charitable institutions, (e) gaols and penal establishments; (IV.) the occupations of university graduates. That in the case of a person returned as following more than one occupation, he be abulated, as a rule, under the head of the first-mentioned, the exception being a Government officer following some other calling, as, for instance, "deputy-registrar and storekeeper," in which case he is to be classified as the latter; also, a person residing where one of his occupations is carried on which would warrant its being considered as the more important, as, for instance, "farmer and publican," living at the public-house, is to be classed as a publican, although that calling may be stated second.

16. That in the table of Education the people be grouped in single ages from 3 to 21 years of age, and after that in quinquennial periods to 85 years of age; those of either sex able to read and write, able to read only, and unable to read, being distinguished. That no child under 3 years of age be set down as able to read, and no child under 5 years of age as able to write; also, that Chinese unable to read English be set down as unable to read. That a table be also prepared showing the degree of primary instruction possessed by children between 5 and 15 years of age attached to each religious denomination.

17. That in the tables of Conjugal Condition the people be grouped in single ages from 14 to 21 years of age, and after that in quinquennial periods to 85 years of age, those of either sex never married, married, and widowed or divorced being distinguished; that Chinese be set down as never married unless they have or have had wives in Australasia. That tables be prepared of the divorced persons of either sex, showing their birthplaces, ages, religions, and occupations; also, a table showing the number of wives whose husbands were absent, and of husbands whose wives were absent, on the Census night.

18. That tables be prepared showing the numbers of either sex suffering from each description of sickness or infirmity, grouped in single years of age up to 21, and afterwards in quinquennial periods up to 85 years of age; that tables be also prepared showing the occupations of those suffering from each description of infirmity.

Appendix D.

OCCUPATIONS.

SYSTEMATIC Classification of Classes and Orders, as agreed upon by the Australasian Census Conference, held at Hobart, March, 1890.

CLASSES.

- I. PROFESSIONAL.—(Andrici, Farr). Embracing all persons mainly engaged in the government and defence of the country, and in satisfying the higher intellectual and noral requirements and the special social wants not included in the material services rendered by other classes hereafter specified or classed.
- II. DOMESTIC.—Embracing all persons engaged in rendering personal services, and in the supply of board and lodging for which remuneration is usually paid.
- III. COMMERCIAL.—(Trade and Transport, United States Census, 1881: Agorici, Farr.) Embracing all persons directly connected with the *hire*, sale, transfer, distribution, storage, and security of property and materials, but who as a rule do not effect any material change in the nature of the objects which pass through their hands.
- IV. INDUSTRIAL.—(Part of the *Technici* of Farr). Embracing all persons not otherwise classed, who are principally engaged in various works of utility or in specialities connected with the construction, modification, or alteration of materials so as to render them more available for the various uses of man, but excluding as far as possible all who are engaged mainly or solely in the service of inter-change.
- V. AGRICULTURAL, PASTORAL, MINERAL, AND OTHER PRIMARY PRODUCERS.—(Georgici and part of the *Technici* of Farr). Embracing all persons mainly engaged in the cultivation or acquisition of food products, and in obtaining other raw materials from natural sources.
- VI. INDEFINITE.—Embracing all persons who derive their income from services rendered, but the direction of which services cannot be exactly determined.
- VII. DEPENDANTS.—Embracing all persons dependent upon relatives or natural guardians, including wives, children, and relatives not otherwise engaged in pursuits for which remuneration is usually paid, and all persons supported by private or public charity, or dependants upon the public revenue.
