A BILL FOR

An Act to amend the *Government Business Enterprises (Sale) Act 2003* and to consequentially amend the *Government Business Enterprises Act 1995* and the *Retirement Villages Act 2004*

Be it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

PART 1 – PRELIMINARY

1. Short title

This Act may be cited as the *Government Business Enterprises (Sale) Amendment Act 2007*.

2. Commencement

- (1) Except as provided in this section, this Act commences on the day on which this Act receives the Royal Assent.
- (2) Parts 3 and 5 commence on the day on which the *Printing Authority of Tasmania Act 1994* is repealed.

- (3) Part 4 commences on the day on which the *Southern Regional Cemetery Act 1981* is repealed.
