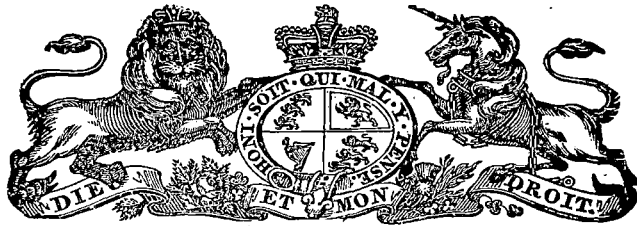

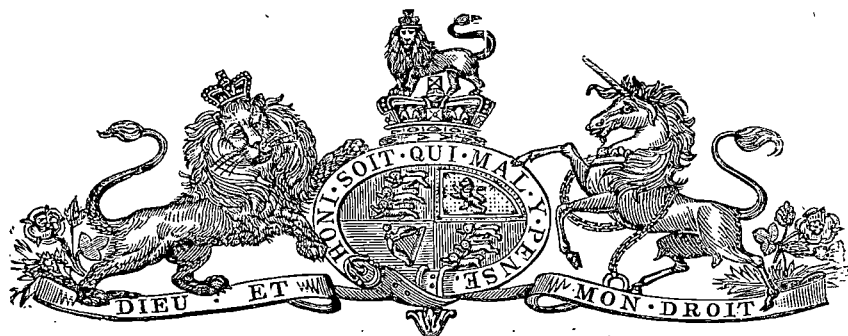

*By His Excellency the Right Honourable JENICO WILLIAM JOSEPH VISCOUNT GORMANSTON Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George Governor and Commander-in-Chief in and over the Colony of Tasmania and its Dependencies.*

WHEREAS by Letters Patent passed under the Great Seal of the United Kingdom constituting the Office of Governor and Commander-in-Chief of the Colony of Tasmania and its Dependencies and bearing date the seventeenth day of June in the Forty-third year of the reign of Her present Majesty it is provided (amongst other things) that in the event of the Governor having occasion to be temporarily absent for a short period from the Colony he may in every such case by an Instrument under the Public Seal of the Colony constitute Her Majesty's Lieutenant-Governor or if there be no such Officer then any other person to be his Deputy during such temporary absence and in that capacity to exercise perform and execute for and on behalf of the Governor during such absence but no longer all such powers and authorities vested in the Governor by the said Letters Patent as shall in and by such Instrument be specified and limited but no others And whereas there is no Lieutenant-Governor of the said Colony of Tasmania and its Dependencies And whereas I the Right Honourable JENICO WILLIAM JOSEPH VISCOUNT GORMANSTON Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George Governor and Commander-in-Chief in and over the Colony of Tasmania and its Dependencies have occasion to be absent from the said Colony from the seventh day of August instant to the thirteenth day of August instant Now therefore I the Right Honourable JENICO WILLIAM JOSEPH VISCOUNT GORMANSTON Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George and Commander-in-Chief as aforesaid in exercise of the power vested in me by the said Letters Patent do by this Instrument under the Seal of the said Colony constitute and appoint the Honourable SIR JOHN STOKELL DODDS Knight Companion of the Most Distinguished Order of Saint Michael and Saint George Chief Justice of the Supreme Court of Tasmania to be my Deputy from the seventh day of August to the thirteenth day of August instant both days inclusive and in that capacity to exercise perform and execute for me and on my behalf during such absence but no longer all the powers vested in me by the said Letters Patent save and except the power to dissolve the House of Assembly of Tasmania.

Given under my hand and the Seal of the Colony of Tasmania at Hobart in the said Colony this sixth day of August one thousand nine hundred.
