

CLAUSE NOTES

Racing Regulation and Integrity (Consequential Amendments) Bill 2024

PART I - PRELIMINARY

Clause 1 **Short title**

Clause 2 **Commencement**

This clause provides that this Act commences on a day to be proclaimed.

PART 2 – ANIMAL WELFARE ACT 1993 AMENDED

Clause 3 **Principal Act**

This clause identifies the *Animal Welfare Act 1993* as the 'Principal Act' for the purposes of this Part.

Clause 4 **Section 25 amended (Examination of animals)**

This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

Clause 5 **Section 39 amended (Membership of Advisory Committee)**

This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

PART 3 – ANNULLED CONVICTIONS ACT 2003 AMENDED

Clause 6 **Principal Act**

This clause identifies the *Annulled Convictions Act 2003* as the 'Principal Act' for the purposes of this Part.

Clause 7 **Schedule 1 amended (Non-exempt applications)**

This clause replaces references to the *Racing Regulation Act 2004* with references to the *Racing Regulation and Integrity Act 2024*.

PART 4 – ANZAC DAY OBSERVANCE ACT 1929 AMENDED

Clause 8 **Principal Act**

This clause identifies the *Anzac Day Observance Act 1929* as the 'Principal Act' for the purposes of this Part.

Clause 9 **Section 3 amended (Interpretation of Part II)**

This clause replaces references to the *Racing Regulation Act 2004* with references to the *Racing Regulation and Integrity Act 2024*.

PART 5 – DOG CONTROL ACT 2000 AMENDED

Clause 10 Principal Act

This clause identifies the *Dog Control Act 2000* as the 'Principal Act' for the purposes of this Part.

Clause 11 Section 18 amended (Effective control of greyhounds)

This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

Clause 12 Section 18A amended (Approval of greyhound suitability program)

This clause replaces references to the Director of Racing with references to Tasracing to make Tasracing responsible for approving a program in respect of the training and assessment of greyhounds to be without a muzzle when not on premises at which the dog is usually kept.

PART 6 – GAMING CONTROL ACT 1993 AMENDED

Clause 13 Principal Act

This clause identifies the *Gaming Control Act 1993* as the 'Principal Act' for the purposes of this Part.

Clause 14 Section 3 amended (Interpretation)

This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*. It also replaces a reference to the Director of Racing with a reference to the Tasmanian Racing Integrity Commissioner (Commissioner). This is to enable the Tasmanian Liquor and Gaming Commission to share information with the Commissioner for the purposes of section 76XA of the Principal Act.

Clause 15 Section 76B amended (Offence to conduct gaming business without endorsed Tasmanian gaming licence)

This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

Clause 16 Section 76XC amended (Additional conditions on Tasmanian gaming licence with totalizator endorsement)

This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

Clause 17 **Section 76ZDM amended (Restrictions on wagering by interested persons)**
This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

Clause 18 **Section 76ZED amended (Initial totalizator endorsement)**
This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

Clause 19 **Section 76ZEE amended (Second totalizator endorsement)**
This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

PART 7 – JUDICIAL REVIEW ACT 2000 AMENDED

Clause 20 **Principal Act**
This clause identifies the *Judicial Review Act 2000* as the 'Principal Act' for the purposes of this Part.

Clause 21 **Schedule 1 amended (Decisions to which Act does not apply)**
This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

PART 8 – JUSTICE RULES 2003 AMENDED

Clause 22 **Principal Rules**
This clause identifies the *Justice Rules 2003* as the 'Principal Rules' for the purposes of this Part.

Clause 23 **Schedule 2 amended (Offences)**
This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

PART 9 – RACING (TASRACING PTY LTD) ACT 2009 AMENDED

Clause 24 **Principal Act**
This clause identifies the *Racing (Tasracing Pty Ltd) Act 2009* as the 'Principal Act' for the purposes of this Part.

Clause 25 **Section 3 amended (Interpretation)**
This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

Clause 26 **Section 6 amended (Principal objectives of Company)**

This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

Clause 27 **Schedule 1 amended (Provisions to be included in constitution)**

This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

**PART 10 – WORKERS REHABILITATION AND COMPENSATION ACT 1998
AMENDED**

Clause 28 **Principal Act**

This clause identifies the *Workers Rehabilitation and Compensation Act 1998* as the 'Principal Act' for the purposes of this Part.

Clause 29 **Section 4DC amended (Jockeys)**

This clause replaces a reference to the *Racing Regulation Act 2004* with a reference to the *Racing Regulation and Integrity Act 2024*.

PART 11 – CONCLUDING PROVISION

Clause 30 **Repeal of Act**

This clause provides that this Act is repealed on the first anniversary on the day on which it commenced.
