

BOARD OF IMMIGRATION.

REPORT FOR 1872.

Laid upon the Table by the Colonial Treasurer, and ordered by the House to be printed, June 17, 1873.



Sir,

Immigration Office, 21st March, 1873.

THE Board of Immigration have the honor to present their Report on Immigration for the year ending 31st December, 1872.

In their last Report the Board referred to the closing of the German Agency conducted by Mr. Frederick Buck; and in March the last batch of Immigrants arrived by the ship *Eugenie*, Captain Voss, from Hamburg, in which vessel Mr. Buck was a passenger.

There arrived by the *Eugenie* thirty-two married Males and thirty-one married Females, one married woman having died at sea. There were also twenty-eight Single Male and thirteen Single Female Adults, and thirty-three Male and forty-five Female Children.

Three Children were born and seven Children died during the passage, which was much prolonged on account of the ship having had to land Emigrants at the Brazils.

In addition to the Bounty Immigrants the *Eugenie* brought seventeen passengers holding Land Order Warrants, and three intermediate cabin passengers, who claimed their Land Certificates under the 7th Section of the Act, 31 Vict. No. 26.

The passengers lodged several serious complaints of the treatment they had received on board against the Captain and Owners, and a Commission was appointed, consisting of Messrs. W. Tarleton, E. C. Nowell, and G. Browne, to investigate the charges.

The result of the enquiry proved that the welfare of the passengers had not been properly considered by the Captain; that the water and provisions had been both bad and insufficient; and that no effectual means had been taken to preserve that necessary order and discipline on board, without which irregularities will inevitably occur on long and protracted voyages such as that of the *Eugenie*, extending to one hundred and fifty-six days.

By the terms of the Contract the complaints of the passengers, with the Report and evidence, were transmitted to the authorities in Germany, "with the view of having the matters duly considered by them, and obtaining such redress as in the judgment of the Hamburg Board of Emigration would meet the exigencies of the case."

As yet no reply has been received, but Mr. Buck, who holds the appointment of Consul for the German Empire, and who is now in Germany, has been requested to make enquiries into the cause of the delay.

The Immigrants by the *Eugenie* appear on the whole to have been drawn from a better class than those by the previous ships, and there was less difficulty in obtaining employment for them. Many secured engagements with masters who had taken men from the *Victoria* or the *Figaro*, and who again sought German labour as that best suited to their wants.

From England there arrived as Bounty Immigrants three Males and seven Females, and three Males and four Females from Ireland: adding those from Germany the total number introduced amounts to one hundred and ninety-nine souls, at a cost to the Board for passage money of fifteen hundred and forty-two pounds.

Land Certificates under the 7th Section of the 31st Vict. No. 26 have been issued to sixteen applicants, entitling the holders to select in all six hundred and eighty acres.

These applicants represent four Married Couples, twelve Single Males, and twelve Children.

The Main Line of Railway Company have commenced the introduction of Land Order Warrant Immigrants under the agency granted them by the Board; and it is hoped that the great care exercised by the Company in the selection of suitable persons, as evidenced by the various certificates required by them before passing an applicant, may lead to the ultimate settlement of an industrious class of able-bodied labourers upon their several allotments.

The balance at the disposal of the Board on the 31st December last amounted to $\pounds 6974$ 6s. 7d.

Appended are five tabulated Returns prepared by the Immigration Agent referring to the operations of the Board under the Bounty System, and two relating to their transactions under the Act of Parliament, 31 Vict. No. 26.
