



## NOTICE OF INTENTION TO VEST CERTAIN LANDS IN THE MUNICIPAL COUNCIL OF LONGFORD.

### Lands and Works Office, Hobart, 11th August, 1885.

WHEREAS the under-mentioned lands, having been reserved by the Governor in Council for the several purposes mentioned, were transferred to the Municipality of Longford : Notice is hereby given that, at the request of the said Municipal Council, and in pursuance of the power vested in it by Section 12 of "The Waste Lands Act, 1870," (34 Vict. No. 10), it is the intention of the Governor in Council to vest the said land in the Municipal Council of Longford for the purpose named, and subject to the conditions contained in the said Act.

### Town of Longford.

- Sect. E., 3a. 2r. 21p., known as the Police Reserve. For police purposes. Sect. D., 4 acres. For public purposes. Sect. A., 6a. 3r. 36p. For public purposes and recreation ground.

Town of Perth.

The Cricket Ground Reserve, containing 4a. 3r. 26<sup>1</sup>/<sub>2</sub>p. For recreation purposes.
