



BENEVOLENT SOCIETIES' REGISTRATION.

Chief Secretary's Office, Hobart, 31st July, 1889.

SIR,

The Government desire to call your attention to the provisions of "The Charitable Institutions Act, 1888," 52 Victoria, No. 8, (copy enclosed), and to convey to the Governing Authorities of the Launceston Benevolent Society the expression of their wish that it should be registered under the Act.

As Parliament grants an annual subsidy towards the maintenance of this and kindred Institutions, it is desirable that they should each work under the Act which constitutes the Governing Body a "Body Corporate," and confers powers upon them to recover amounts due for the maintenance of inmates.

Such registration does not involve any pecuniary responsibility other than that provided in the Schedule to the Act; namely, as per Section 6, Application Fee, 10s.; and Section 11, Certificate by Attorney-General, Fee, £2 4s. 6d.

Mr. John O'Boyle, the Administrator of Charitable Grants, has been appointed, by the Governor in Council, Registrar of Charitable Institutions under Section 3.
