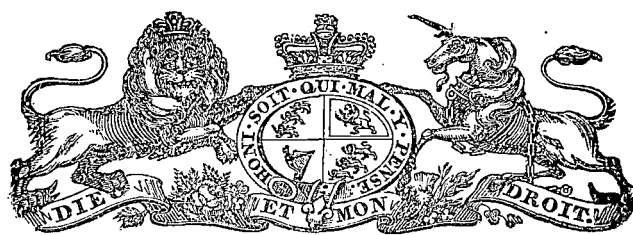

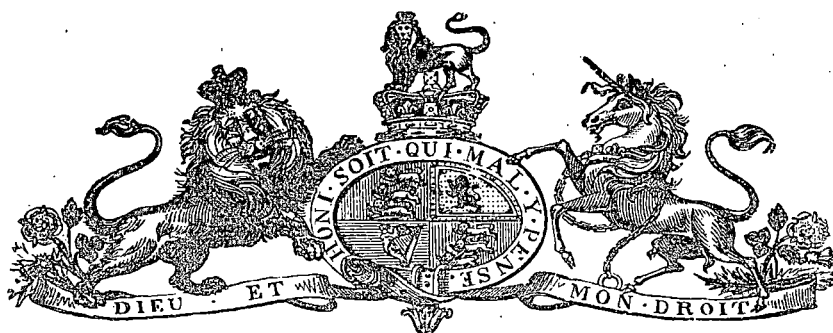

EXTRACTS FROM PENSION PAPERS.

DATES of Commencement and Termination of the several Appointments held by Applicants, with their Emoluments, distinguishing Salary from other Allowances, and specifying such Allowances.

FRANCIS BELSTEAD, *Police Clerk, Westbury.*

Police Clerk, 1st May, 1858, until 16th December, 1863; salary, £120 per annum, with annual increase of £10.. Collector of Police Rates, 19th November, 1858, until 16th December, 1863, 5 per cent on amount of rates collected, averaging £48 per annum for the five years.

Compensation, £121 11s. 11d.—8½ on salary of £170.

THOMAS HENRY POWER, *Police Clerk, Campbell Town.*

Appointed Police Clerk, 27th November, 1855; salary, £190 per annum; average commission on collection of Rural Police Rate, £32 10s. per annum; no allowances.

Pension, £47 10s. on salary of £190.

WILLIAM CAHILL, *Police Clerk, New Norfolk.*

Police Clerk, 1st February, 1850; salary, £220. Deputy Clerk of Peace, 1st February, 1850; no salary or emoluments. Registrar Court of General Sessions, 1st February, 1850; emoluments, about £20. Returning Officer for Electoral District, no salary or emoluments, 1st March, 1858. Collector Rural Police Rate, 5 per cent. on collection, amounting to about £18 10s., 16th November, 1858.

Pension, £77 on salary of £210.

RICHARD H. DAVIES, *Police Clerk.*

Appointed to the command of the *Shamrock* cutter in November, 1832; salary, £120 per annum, with provisions and attendant. Appointed to the command of the Government schooner *Eliza*, 1st October, 1836; salary, £120, with provisions, &c. Appointed Police Clerk—salary £100 per annum—in November, 1842.

Pension, £48 15s. on salary of £180.

HENRY JOSEPH DURIEU, *Police Clerk, Hamilton.*

Appointed District Constable, Hobart Town, 5th April, 1843, and promoted to be a Chief District Constable, July, 1843. Appointed Police Clerk, Deputy Clerk of the Peace, &c., 5th November, 1855.

Pension, £89 10s. 4d. on salary of £179 0s. 8d.

THOMAS HENRY HASKELL, *Police Clerk, Brighton.*

Entered the Police Department, Hobart Town, December, 1834, transferred from there to the Police District of Brighton, July, 1838, as Police Clerk, &c., where he still remains; salary, £240. Appointed Deputy Clerk of the Peace, January, 1850, terminates 19th November, 1863; annual emoluments, £10. Registrar of Court of General Sessions, December, 1856, terminates 19th November, 1863; annual emoluments, £12. Collector of Rural Police Rates, November, 1858, terminates 19th November, 1863; average emoluments for past 3 years, £21.

Pension, £149 10s. on salary of £236 1s. 1d.

EDWARD INNES, *Police Clerk and Chief District Constable, Kingston.*

Mr. Innes was Police Clerk at Prosser's Plains and Sorell from March, 1846, to 31st January, 1852, when he resigned his appointment. He was again appointed on the 1st December, 1854, from which day his service has been calculated.

Mr. Innes will be entitled to £50 allowed as compensation for classification, increases abolished on the 30th June, 1863, in accordance with the terms of the Executive Council Minute No. 227 of 6th July, 1863.

Appointed Police Clerk, Kingston, on 1st December, 1854.

Pension, £103 6s. 8d. on salary of £200.

MATTHEW ROBINSON, *Police Clerk, Bothwell.*

Commencement of appointment, 28th January, 1841. Termination of appointment, 30th January, 1863. Last salary received at the rate of £230. No emoluments or allowances as Police Clerk. Postmaster—Office conducted entirely by family. Registrar Births, Deaths, and Marriages.

Pension, £75 1s. 3½d. on salary of £204 14s. 5½d.

RICHARD UNIACKE, *Police Clerk, Longford.*

26th June, 1848, and terminating on the 28th February, 1862; salary for the last three years, £200 per annum, with an additional 16s. 8d. per month for the last two months, namely, for the months of January and February, 1862.

"I have received the sum of £75 per annum for the last three years, allowance for collecting Police Rate."

Pension, £56 10s. on average salary for the last three years of £188 6s. 8d.

JOHN SURTEES WHITE, *Police Clerk, &c., Franklin.*

Police Clerk, 15th May, 1854, to 31st December, 1867; salary, £200. Deputy Clerk of the Peace, *nil*. Registrar, Court of Requests, *nil*. Allowance, Collector of Rural Police Rates, *nil*. Returning Officer, Electoral District of Franklin, *nil*.

Pension, £60 on salary of £200.

WILLIAM HORATIO WALSH, *Police Clerk, &c., Horton.*

Postmaster, Circular Head, appointed 17th June, 1845, and resigned on 1st January, 1862; salary, £10 at first, which was raised to £20 before resignation. Registrar of Court of Requests at Stanley, Circular Head, appointed on the 21st April, 1849, at a salary of £10, which was increased to £25 before it was united to the office of Police Clerk. Government Schoolmaster at Stanley, Circular Head, appointed 1st May, 1845, and held that office until resignation on 31st December, 1850. Police Clerk, Horton, appointed 26th July, 1851, and held the office until it was abolished by the Government on 31st December, 1867; salary, at first £65, which has been raised from time to time until it reached the maximum of £160 for combined offices of Police Clerk and Registrar of Court of Requests. Applicant has also during portion of his term of office received a commission for collecting Rural Police Rate.

Pension, £69 6s. 8d. on salary of £160.

THOMAS REIDY, *Gaoler for Males, Hobart Town.*

From 1842 to 1844, Clerk in the Commissariat Department, Tasman's Peninsula; salary, 3s. 6d. per diem, with quarters, servant, fuel and light; from 1st December, 1844, to 31st March, 1851, Muster Master, Victualling Clerk, and Station Officer, Port Arthur; salary, £65 per annum, with rations, quarters, servant, garden, fuel and light; from April, 1851, till 31st March, 1856, Store-keeper, Female Houses of Correction, Cascades and Brickfields; salary, £120 per annum, same allowances, with the addition of washing; from 18th March, 1856, first appointment under Colonial Government, till December, 1866, Keeper and Store Accountant, Gaol and House of Correction, Cascades; salary, £200 per annum, with same allowances; from* 1867, till March, 1874, same position, with the addition of Superintendent of the Male and Female Pauper Establishments, and Reformatory for Males, Cascades; salary, £336 per annum, same allowances; from April, 1874, till December, 1883, Gaoler and Superintendent, Campbell-street, salary and allowances the same, with £20 per annum in lieu of garden; from January, 1884, till 31st March, 1885, same establishment, salary, £350 per annum, allowances same.
