**An Act to make amendments consequent on the enactment
of the *Aboriginal Relics Amendment Act 2017***

Be it enacted by Her Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

PART 1 – PRELIMINARY

1. Short title

This Act may be cited as the *Aboriginal Relics (Consequential Amendments) Act 2017*.

2. Commencement

This Act commences on the day on which the *Aboriginal Relics Amendment Act 2017* commences.
