Notices of Motion

- 47 Ms *Haddad* to move—That the House:—
 - (1) Notes the Gutwein Liberal Government seems intent on pushing ahead with their proposal to build a fifth lane on the Southern outlet despite community opposition and serious questions about whether it will do anything at all to improve traffic congestion.
 - (2) Acknowledges that during the 2021 State election, candidates for Clark including now Liberal Member for Clark, Ms Madeleine Ogilvie MP, attended a meeting with residents of Dynnyrne to listen to their concerns.
 - (3) Recognises that the Gutwein Liberal Government's plan for a fifth lane on the Southern outlet will require the demolition of homes and the acquisition of land from the yards of properties bordering the highway.
 - (4) Further notes that a Parliamentary E-petition calling for the Government to scrap the project and look instead at practical alternative solutions has already gathered more than 2,470 signatures.
 - (5) Agrees that the Gutwein Liberal Government should abandon their current proposal for a fifth lane on the outlet due to the lack of evidence it will ease traffic congestion and look instead at practical alternative solutions. (26 October 2021)
- 48 Ms *Haddad* to move—That the House:—
 - (1) Notes:—
 - (a) that on 25 October 2021 the Tasmanian Integrity Commission released a Paper entitled 'Tasmania's Electoral Act Offences and Campaign Conduct'; and
 - (b) the Paper is the first in a Research Paper Series named 'Ethical Conduct and Potential Misconduct Risks in Tasmanian Parliamentary Elections'.
 - (2) Welcomes the fact that the Integrity Commission is pursuing this work and adding to the important conversation about democracy in Tasmania.
 - (3) Further notes the Paper exposes serious issues in our electoral system which should be taken seriously by the Government and the Parliament.
 - (4) Recognises it is vital that Tasmanian elections are fought on a fair and level playing field.
 - (5) Refers the Paper entitled 'Tasmania's Electoral Act Offences and Campaign Conduct' to the Joint Standing Committee on Integrity pursuant to section 24(1)(d) of the 'Integrity Commission Act 2009', for inquiry, such enquiry to include public hearings, and report with specific reference to the matters raised in the paper. - *(a)* the Department of Treasury and Finance's Financial Sustainability Report 2021 predicts General Government Net Debt of between \$16 and \$30 billion in by 2035. The 2021-22 Tasmanian Budget shows net debt will continue to grow by \$2 million per day for four years;
