Notices of Motion

- 71** Dr Woodruff to move—That the House:—
- (1) Notes the significance of the report “On the Edge of Extinction: The Case for the Swift Parrot Protection Plan”, authored by Dr Jen Sanger and Dr Nick Fitzgerald, supported by The Tree Projects, Birdlife Australia, the Wilderness Society, and the contribution of more than 18 swift parrot experts, bird specialists and conservation scientists.
 - (2) Acknowledges only 750 of the critically endangered Swift Parrot remain, and the bird is at high risk of extinction without a dramatic change in land management.
 - (3) Recognises the primary reason the Swift Parrot has experienced a dramatic decrease in numbers in recent years is continued logging of the bird’s nesting and feeding habitat by Forestry Tasmania.
 - (4) Realises the Liberals in Government have repeatedly ignored expert advice about the need to protect crucial areas of Swift Parrot habitat – needed for the long-term survival of the species – from logging.
 - (5) Understands the Public Authority Management Plan (PAMA) weakens protection for the swift parrot by enabling large areas of breeding habitat to be logged, only excludes a small proportion – 2,900 hectares – from being cleared, and fails to include essential foraging habitat.
 - (6) Calls on the Liberal Government to protect the survival of the Swift Parrot, and other threatened and endangered species that rely on intact native forest systems, by ending native forest logging in Tasmania. (1 March 2022)
- 72** Ms O'Connor to move—That the House supports, in principle, recommendation 1 of the Final Report of the House of Assembly Select Committee on the House of Assembly Restoration Bill.
- 73** Ms O'Connor to move—That the House:—
- (1) Notes with heartbreak that on 24 February, 2022, under orders from the Russian President, Vladimir Putin, the Russian military invaded peaceful, democratic Ukraine, without provocation launching the first major war on the European continent since World War II.
 - (2) Acknowledges that Russia has launched a full-scale assault on Ukraine, launching missile strikes at major Ukrainian cities, and deploying military hardware and personnel from Belarus and Russian-annexed Crimea.
 - (3) Recognises:—
 - (a) that Ukraine is gathering evidence of potential crimes against humanity, following the Russian military shelling residential areas, schools, and hospitals; and
 - (b) that Human Rights Watch has proven one case of a cluster munition attack, which are banned under international law, with many more suspected.
 - (4) Further notes that while true casualties are currently unknown, hundreds have been reported injured or deceased, and hundreds-of-thousands more are fleeing Ukraine creating a humanitarian crisis of need for neighbouring countries.

- (5) Condemns Mr Putin and recognises the Russian leader as a war criminal, violent autocrat, and a threat to stability, security and human life in the region and the world.
- (6) Offers condolences and sympathy to the people of Ukraine as they fight to defend their country and supports every effort by the European Union (EU) and other democratic nations to deliver tangible support to Ukraine, and to ensure Russia under Vladimir Putin is threatened as the international pariah it has become. (1 March 2022)

74 Ms O'Connor to move—That the House:—

- (1) Notes the housing and homelessness crisis is only getting worse, (with rental stress/unaffordability) increasing by a third in 2021, during a pandemic.
- (2) Recognises Tasmania, as the least wealthy state, has been the most unaffordable to rent and buy in since the Liberals came to office in 2014, reversing Tasmania's long standing status as an affordable place to buy or rent a home.
- (3) Acknowledges the public housing waiting list was at a ten year low under a Green Housing Minister and it has doubled since the Liberals took government in 2014; now at 4,388 and increasing.
- (4) Further notes that in 2021-22 the Government raised land tax thresholds, reducing land tax for investors and other multiple property owners.
- (5) Further recognises that since then, rents have increased by 9 per cent in the South, 10 per cent in the North-West and 15 per cent in the North.
- (6) Further notes that despite this, the Premier, the Hon. Peter Gutwein MP has announced further land tax cuts, claiming they will "further" decrease rents.
- (7) Agrees that land tax cuts have not, and will not, reduce rents.
- (8) Calls on the Gutwein Government to abandon land tax cuts, and instead adopt the Greens' State Election platform to:—
 - (a) strengthen the Residential Tenancy Act;
 - (b) regulate short stay accommodation;
 - (c) adopt Finland's 'Housing First' approach to homelessness; and
 - (d) commit to building 10,000 homes in the next decade. (1 March 2022)

75 Ms O'Connor to move—That the House:—

- (1) Notes:—
 - (a) Dr Lisa Denny's analysis of 10 years of NAPLAN data published in January 2022 and
 - (b) that in 2012 21.5% of Tasmanian children in their first year of schooling were identified as being developmentally vulnerable, and by year 9 in 2021, this increased to 28.5%.
- (2) Acknowledges that the educational gap between high and low SES areas is widening.
- (3) Recognises the widening gender gap, with over a half of year 9 male students (52.7%) not exceeding the expected standard for writing, compared with a third of female students.
- (4) Further notes that the Gutwein Government has focused on a narrative of year 11/12 retention, but many students are being let down well before year 11/12.
- (5) Agrees urgent investment in our education system is needed, with a strong focus on schools in low SES/ICSEA regions, including immediate investment in:—
 - (a) speech pathology;
 - (b) school psychologist support; and
 - (c) an expanded school breakfast program. (1 March 2022)

76 Ms Finlay to move—That the House:—

- (1) Notes the significant downturn in trade experienced by businesses across the State following the reopening of our borders, including by the many businesses that were forced to close down following the reentry of COVID-19 to Tasmania.
- (2) Recognises:—
 - (a) the impact this has had on workers and businesses, and the importance of listening to these people to understand how they can best be supported; and
 - (b) the Tasmanian Labor Party has done just that in developing its Supporting Business, Supporting Jobs Package.

- (3) Acknowledges that while the Gutwein Government has provided support to some Tasmanian businesses and workers, more needs to be done to ensure Tasmanian businesses and workers can survive what has been a difficult period.
- (4) Calls on the Government to implement the elements of the Labor's Supporting Business, Supporting Jobs Package, including:—
 - (a) easier access to support for businesses who do apply for support grants;
 - (b) payroll support to eligible businesses through a Workers Support Grant;
 - (c) cash flow support through rebates on some fixed charges;
 - (d) an extension of the eligibility for the payroll tax waiver; and
 - (e) tourism and hospitality voucher to rebuild confidence and provide much needed stimulus.
- (5) Further calls on the Government to outline to the House how much of the \$300 million COVID contingency has been spent and the details of this expenditure. (1 March 2022)

- (1) A Select Committee be appointed, with power to send for persons and papers and records, to inquire into and report upon Consumer and Building Sector Protections of the Tasmanian Building and Construction Industry, including:—

- (1) A Select Committee be appointed, with power to send for persons, papers and records, to inquire into and report upon the Tasmanian Government's preparedness for and management of COVID-19 following the relaxation of border restrictions on 15 December 2021, including:—
 - (a) the preparedness of Tasmania's health system, including contact tracing, testing, the Tasmanian Public Health Hotline, and hospitals;
 - (b) preparedness of schools for a COVID-impacted school year;
 - (c) the adequacy of supports available to businesses and workers impacted by COVID-19, including communication, consistency and financial support; and
 - (d) any other matters incidental thereto.
- (2) The Committee shall consist of 5 Members, being:—
 - (a) 2 from the Government nominated by the Leader of the House;
 - (b) the Leader of the Opposition;
 - (d) the Deputy Leader of the Opposition; and
 - (e) Dr Woodruff.
- (3) The Committee report by 3 May 2022. (1 March 2022)

The Minister for Trade to move—That the House:—

- (1) Recognises Ukrainian territorial sovereignty and its right to peace, freedom, and democratic rule.
- (2) Notes:—
 - (a) that Tasmania is home to both Ukrainian and Russian communities who have received this news with deep concern for their loved ones, and we stand with all Tasmanians in wishing to provide care and support for those communities; and

- (b) Tasmania stands with the Australian Government in affirming our respect for Ukrainian territorial sovereignty and its right to peace, freedom, and democratic rule.
- (3) Acknowledges that there is no justification for this aggression, which will ultimately be borne by innocent Ukrainians.
- (4) Condemns any aggressive action in Ukraine, which endangers human life and liberty.
- (5) Further notes that Tasmania has a strong history of welcoming and providing support for national efforts in providing humanitarian responses to previous conflicts and will continue to work with the Australian Government in jointly responding to the unfolding events. (1 March 2022)
