

In accordance with Section 126, 57 Vict. No. 6—"The Patents, Designs, and Trade Marks Act, 1893,"—I have the honor to submit the following Report in respect of the year 1894.

#### REGULATIONS MADE, &c.

The provisions of the new amended and consolidated. Act are so complete and satisfactory that no difficulty as yet has presented itself which required any addition to the regulations already in force.

The reduction in the initial fees has given general satisfaction, and, in consequence, the business of this important branch of the Registrar-General's Department is rapidly increasing.

# TRANSACTIONS, REVENUE, &c.

The principal transactions under Letters Patent, Designs, and Trade Marks respectively for the year 1894 number 540, and the total Receipts, £875.

I anticipate a very considerable increase in revenue in a year or two when the periodical rentals fall due. The following table (A) gives a more complete account of the various transactions.
