



REPORT FOR 1894.

Inspection of Machinery Department, Hobart, 20th February, 1895.

SIR

I HAVE the honor to forward you the following Report for the year ending 31st December, 1894.

Inspections made.

Stationary steam boilers, 261; portable steam boilers, 58; machinery only, 4; marine, 66.

Land Engine Drivers' Certificates.

A large number of applicants have been examined during the year, examinations having been held at various parts of the Colony as often as practicable. Sixty-one Certificates were issued—twenty-eight Competency, and thirty-three Service.

Port Engineers' Certificates.

Applicants for these have been numerous, but only five passed successfully, two for Second-class and three for First-class.

Examinations under "The Merchant Ships Officers Examination Act."

Three candidates passed successfully, one for Second-class and two for First-class.

Machinery Accidents to Persons.

There have been five accidents to persons during the year, none of which were serious. No fatal accidents reported.

Boiler Accidents.

Several of a trivial nature occurred, causing no injury to any person.

Fees received.

Total Fees to Inland Revenue, £265.

Fees unpaid.

These amount to £78.

Steam Pressure Gauges, &c.

Tested and found serviceable, 160; tested and found unserviceable, 12.

Steam Vessels under Survey.

Hobart, 31; Launceston, 9; Devonport and other Ports, 3; total marine inspections made, 97.

Synopsis of other duties performed by the Department.

Engineers' and Iron Shipwright Surveyors, and Examiners in Steam to the Hobart, Launceston, Strahan, and Mersey Marine Boards. Inspection and supervision of the machinery at the Government Printing Department; inspection of steam boilers and machinery for the Defence Department, including supervision of Torpedo Boat and pneumatic guns, &c.; inspection and testing boilers of Government Powder Hulks, and ditto at Hobart Gaol; Examiner of Mining and other Land Engine Drivers, also of Port Engineers and Engineers under "The Merchant Ships Officers Examination Act"; conducting tests of various Tasmanian Coals for the Treasury Department, and classifying and reporting upon same.
