



TASMANIAN COUNCIL OF EDUCATION:

REPORT FOR 1888-9.

Presented to both Houses of Parliament by His Excellency's Command.



ANNUAL REPORT of the Tasmanian Council of Education for the Year 1888-9.

To His Excellency SIR ROBERT GEORGE CROOKSHANK HAMILTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Tasmania and its Dependencies.

MAY IT PLEASE YOUR EXCELLENCY.

1. In conformity with the provisions of "The Tasmanian Council of Education and 22 Vict. Scholarship Act," we have the honor to submit this, our Twenty-eighth Report of the No. 21, Section 30. proceedings of the Council, from the 1st May, 1888, to the 30th April, 1889.

- 2. The Honorable Sir Lambert Dobson was elected President for the year ending President. 30th June, 1889.
- 3. The Annual Examination of Candidates for the Council of Education Exhibitions Council of was held in the month of June, 1888. Thirty-two Candidates, of whom eight were girls, presented themselves for examination; and, on the recommendation of the Examiners, Exhibitions of the value of £20 each for four years were awarded to the under-mentioned Candidates:—John Francis Killalea and Thomas William Maloney, of the High School, Launceston; Ada Bonnily, Miss Hogg's School, Launceston; Montagu Moses Ansell, Hutchins' School, Hobart; and Albert Edward Solomon, Horton College, Ross.

The Examiners, in closing their Report, observe—

It is gratifying to observe how admirably some of the female candidates have acquitted themselves in this examination. For the fourth time a girl has succeeded in gaining an Exhibition; while two others—namely, Miss Wilson and Miss M'Mahon—have obtained far more than the number of marks qualifying for an Exhibition.

4. The Twenty-ninth examination for the Degree of Associate of Arts was held in Degree of June, 1888,—A. B. Weigall, Esq., M.A., Sydney Grammar School, being Examiner in Associate of English, Latin, and Greek; W. Newberry, Esq., M.A., Sydney Grammar School, Arts, Gazette Notice, 3 July, Examiner in French, German, Mathematics, Natural Philosophy, Chemistry, and 1888.

Geology; the Rev. T. Kelsh, Examiner in Italian; the Rev. R. D. Poulett-Harris, M.A., Examiner in Zoology; George Fagg, Esq., M.S.A., Examiner in Drawing; and J. Summers, Esq., Mus. Bac. Oxon., Examiner in Music. Fourteen Candidates presented themselves, three of whom were females. Twelve succeeded in obtaining the Degreefive being placed in the First Class, two in the Second Class, and five in the Third Class.

James Bellord Waldron, as Senior Associate of the year, received the Council's Gold Medal; he also gained the First Prizes for English, Latin, Greek, and French, and Prizes for Natural Philosophy and Geology.

Prizes were also awarded to the under-mentioned Associates who were placed in the First Class, as follows:—Cecil John Gorringe, First Prize for Mathematics, Second Prize for Greek, and a Prize for Chemistry; Thomas Robert Giblin Shoobridge, Second Prize for French, and Second Prize for Mathematics.

In the Third Class, Florence Evelyn Riddle was awarded a Prize for Music and a Prize for German; and Margaret Mary Brown was also awarded a Prize for German.

The Examiners, in closing their Report, observe-

We beg to congratulate the Council upon the general results of this year's Examination. There is a distinct improvement in all the subjects, with the exception, certainly of French and Algebra, possibly of Latin. We would remark, however, that if composition is to be taught in the Language Sections, it should receive more attention than it appears to receive at present, and that the style of many of the Candidates would be improved by a conscious effort to imitate the refinement of expression that characterises the best authors of ancient and modern times. Finally, we wish to remind Candidates that Examinations are the incidents, and not the end, of education, and that wisdom is the reward of patient and independent study, and cannot be gained by cramming for any special Examination.

Tasmanian Scholarships. Gazette Notice, 3 July, 1888.

5. The Examination for the Tasmanian Scholarships took place in June, 1888, and was conducted by A. B. Weigall, Esq., M.A., and W. Newberry, Esq., M.A. Three Candidates presented themselves, all of whom obtained sufficient marks to qualify them. for the Scholarships. The first and second places respectively fell to Robert Leslie Dunbabin (A.A., 1886), and Gustave Heuzé Hogg (A.A., 1885). A Scholarshiptenable for four years from the 1st October, 1888, was awarded to each.

Progress of Tasmanian Scholars.

6. From official sources we learn that Mr. James Harcourt Smith took his B.A. Degree at Cambridge in June last, gaining sixth place in the Second Class in Mathematical Tripos. Mr. Charles Frederick Hales also took his B.A. Degree with a position in the Natural Science Tripos at Cambridge.

From private sources we learn that Mr. J. H. Smith will, at the expiration of his term of Scholarship, proceed to Germany to complete his education as a Mining Engineer. Mr. C. F. Hales is still continuing his studies in the Medical School at Cambridge. Mr. Ralph Stuart Stephenson is steadily progressing in Medical Studies at Edinburgh University, and expects shortly to pass his Second Professional Examination. Mr. Edwin A. Lamprill, of Oxford, passed his third examination in November last with credit, and is now working for his final. Mr. W. L. Giblin is steadily working for his examination at Oxford, which takes place in June. Mr. John T. Wilson has been never accomplaint the written accompany are foliable works. T. Wilson has been very successful in the winter session examinations at Edinburgh Mr. Gustave H. Hogg, of the same University, has also been successful in his class examination, and intends to present himself for his First Professional Examination in July. Mr. R. L Dunbabin has passed his "Smalls" at Oxford, and purposes entering

for the Lincoln Exhibition at the end of the Easter Vacation.

Mr. Evett Gordon Allport, B.A., who took his Scholarship in June, 1884, has returned to the Colony, and is about to enter upon scholastic work at the Horton College.

Minor Scholarships.

7. The two Minor Scholarships at the disposal of the Council for the year have been awarded to James Bellord Waldron and Cecil John Gorringe, in the list of Associates of the year, they having intimated their intention to study and compete for the Tasmanian Scholarships. These Scholarships are each of the value of £40 per annum, and are tenable for two years from 1st July, 1888.

Dry Scholarship.

8. The Dry Scholarship was awarded to James Bellord Waldron, senior Associate of the year, he having announced his intention of studying for the Tasmanian Scholarship examination.

Gilchrist Scholarship.

9. The Registrar of the London University notified in a despatch, under date 16th May, 1888, that Mr. Gustave Heuzé Hogg, of Broadland House, Elizabeth-street, Launceston, had passed the Matriculation Examination in January of that year, and was placed by the Examiners equal with the 56th candidate in the original Honour List. A subsequent despatch was received from the Secretary to the Gilchrist Educational Trust, notifying that the Gilchrist Scholarship had been awarded to Mr. G. H. Hogg.

We regret to state that, notwithstanding our appeal, the Trustees still adhere to

their decision to withdraw the Scholarships from competition in Tasmania.

Local Examination for Matriculation, London University.

10. A Local Examination for Matriculation at the London University was held in June last, at which one candidate presented herself—viz., Miss Beatrice Mary Hudspeth who succeeded in gaining a place in the First Division.

Local Examination for Matriculation at Melbourne University.

11. Since the publication of our last Report two Examinations for Matriculation at the Melbourne University have been held in Hobart under our supervision. At the "End of February Term," 1888, Examination, three candidates presented themselves. Only one, Henry Llewellyn Roberts, succeeded in passing. For the "October Term, 1888," Examination, four presented themselves, but none were successful.

Local Ex-Matriculation University.

12. An Examination for Matriculation at the Sydney University was also held under our supervision in Hobart, in March last, at which one candidate presented himself, who was successful in passing. This is the first Examination under the Sydney University which has been held in Hobart.

13. We have much pleasure in recording the fact that the Melbourne University Recognition of Authorities have at length recognised the Tasmanian Degree of Associate of Arts as A.A. Degree equivalent to the Matriculation of the Melbourne University. The rule sanctioning by Melbourne University Calendar for 1888–9 on page 52, paragraph 2, of chap. x.

14. Vacancies have been caused by the resignations of the Ven. Archdeacon vacancies. Davenport and the Hon. E. N. C. Braddon, which have been filled by the election of the Rev. James Scott and the Hon. B. Stafford Bird.

15. We again beg to express our regret that nothing has yet been done by the Constitution Legislature towards altering the Constitution of the Council with the view to the estab- of Council. lishment of a Tasmanian University.

16. We submit a Statement of the Disbursements of the Council between the 1st Expenditure. January and 31st December, 1888, the termination of the financial year. The total expenditure under every head for that period is shown to have amounted to £2690 3s.
