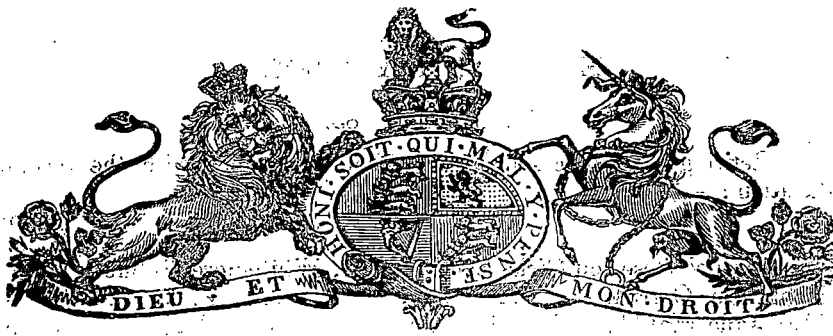

ORDERS of the Governor in Council under "The Superannuation Act," made since the last Meeting of Parliament.

MONDAY, NOVEMBER 19, 1877.

MINUTE No. 487.

ON the recommendation of the Inspector of Police, His Excellency grants Petty Constable John Toomey a Retiring Allowance at the rate of £24 6s. 8d. per annum.

To have effect on 1st October last, and to be provided for upon a Supplementary Estimate.

MONDAY, DECEMBER 3, 1877.

MINUTE No. 516.

UPON the recommendation of the Hobart Town Marine Board, a Retiring Allowance at the rate of £67 18s. 4d. per annum is granted to Mr. Thomas Morgan, Superintendent of Kent's Group Lighthouse, his retirement being caused by failing health.
