

BY THE GOVERNOR IN COUNCIL UNDER THE SUPER-ANNUATION ACT 1860.

Laid upon the Table by the Clerk of the House, and ordered by the House to be printed, 24 June, 1863.



COPIES of Orders by the Governor in Council under "The Superannuation Act," 1860, made since the last Meeting of Parliament.

THURSDAY, 26 FEBRUARY, 1863.

MINUTE No. 105.

His Excellency in Council grants to Mr. Eddie, late Clerk to the Northern Board of Education, Compensation for the loss of such office, at the rate of £37 10s.

THURSDAY, 5 MARCH, 1863.

MINUTE No. 108.

His Excellency in Council grants to Mr. William Giblin, late Registrar of Deeds, a Pension at the rate of £243 2s. 2d. per annum; and to Michael Collins, late Gate-keeper at the Colonial Hospital, Compensation at the rate of £20 10s. 7d.; for the loss of their respective offices.

MINUTE No. 111.

The Colonial Secretary submits for consideration a claim preferred by Mr. J. L. Livingstone for Retiring Allowance, in respect to his office of Writer to the Presbytery.

The Governor in Council decides that Mr. Livingstone is not entitled to a Retiring Allowance.

THURSDAY, 19 MARCH, 1863.

MINUTE No. 127.

The Governor in Council grants Mr. Matthew Robinson a Pension at the rate of £75 1s. 3d. per annum, for loss of his office as Police Clerk at Bothwell, in consequence of that District having been proclaimed a Municipality.

MINUTE No. 128.

His Excellency in Council approves of the payment to Mr. Burgess, late Chief Police Magistrate, of £54, being the difference for the period from 1st August to 31st December, 1861, between the first Pension of £170 7s. 11d. and the second of £300 granted to him from 1st January, 1862; such an amount having already been authorised by His Excellency to be placed on a Supplementary Estimate for 1862, in accordance with an Address from the House of Assembly.

MONDAY, 1 JUNE, 1863.

MINUTE No. 195.

The Governor in Council approves of the adoption of the following Rule in calculating the Pensions of reduced Officers who have served under both the Imperial and Colonial Governments:—

"In those cases where an Officer of the Government has held appointments under both the Imperial and Colonial Governments, and whose services under the latter would entitle him to a Pension, both services may be reckoned in calculating the amount of Pension, with the understanding that in no case shall a higher rate of Pension be granted from Colonial funds in consequence of such amalgamation than would be allowed were only the Colonial period reckoned."

THURSDAY, 4 JUNE, 1863.

MINUTE No. 197.

The Governor in Council has before him papers relating to the Pension of Mr. Robarts, late Overseer in the Government Printing Office, whose office has been abolished.

Mr. Barnard, while testifying to Mr. Robarts's "diligence and fidelity" up to the time of Mr. Barnard's leaving for England, declines to give a similar certificate in regard to the subsequent period.

On consideration of all the circumstances of the case, His Excellency, with the concurrence of the Council, decides upon awarding Mr. Robarts a Pension for the whole period, at the rate to which he appears to be entitled by this decision, under the 5th Section of "The Superannuation Act," 1860, viz., £226 13s. 4d. per annum, from the 1st May last.

MINUTE No. 198.

His Excellency in Council grants to Mr. W. Cahill, late Police Clerk at New Norfolk, a Pension at the rate of £77 per annum, from the 18th March last, in consequence of his services having ceased to be required on the establishment of a Rural Municipality in that District.
