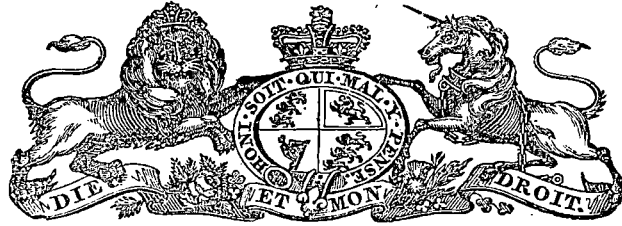

TIMBER DISTRICTS.**

Return to an Order of the Council dated December 14, 1871. (Mr. Crowther.)

December 20, 1871.



RETURN of all Defaulters in the Timber Districts under "The Waste Lands Act," whose blocks of Land are not less than 120 acres, and do not exceed 640 acres, showing the Name of each Defaulter; the Amount paid in Rent and Survey Fees during the time the Lots were held (if so) under the Pre-emptive Regulations of 1851, prior to their having been brought under the Credit Clauses of "The Waste Lands Act;" also the Amount paid as Instalments, with Interest and Expenses upon each Lot; Amount due at the time of Default; the Total Amount paid; and the Sum now required to complete the Purchase.
