

ORDERS of the Governor in Council under "The Superannuation Act," made since the last Meeting of Parliament.

MONDAY, DECEMBER 11, 1871.

MINUTE No. 363.

His Excellency approves of Mr. John M'Ginness being allowed, in consequence of failing health the result of an injury received while in the execution of his duty, to retire from the office of Chief District Constable at Franklin, and of his receiving a Pension at the rate of £65 per annum.

To take effect on the 1st instant, and the amount to be provided on a Supplementary Estimate.

MONDAY, MARCH 18, 1872.

MINUTE No. 63.

His Excellency approves of Superannuation Allowances at the following rates being granted, in consequence of the abolition of their respective offices, to the following persons lately employed in the Lands and Works Department; viz.—

1. Mr. James Laffer, Inspector of Timber Licences.... 40 0 0 per annum 2. Mr. F. G. Dunnett, Lithographer.................... 53 6 8 ditto.

MONDAY, MARCH 25, 1872.

MINUTE No. 72.

MINUTE No. 23.
