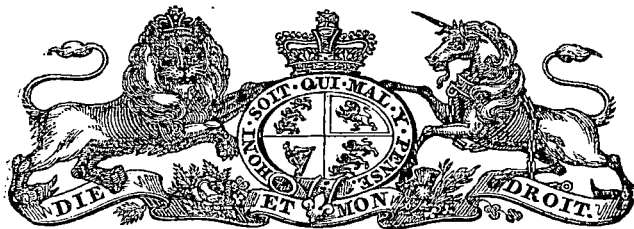

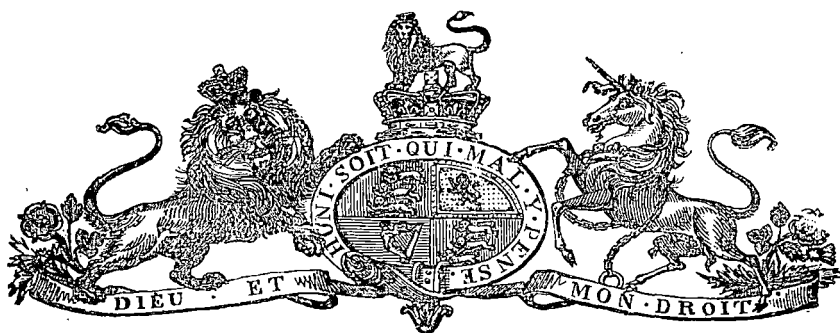

PARLIAMENT OF TASMANIA.

LEAVE OF ABSENCE GRANTED TO CIVIL
SERVANTS, 1880 TO 1890 :

Return to an Order of the House of Assembly. (Colonel St. Hill.)

Laid upon the Table by the Treasurer, 22nd August, and ordered by the House of
Assembly to be printed, August 28, 1890.



RETURN of Leaves of Absence granted for periods over One Month in extent, between the 1st January, 1880, and the 1st January, 1890, to all Heads and Sub-heads of Departments in the Civil Service of the Colony whose length of Service is of 25 years and upwards, specifying the length of service of each recipient, but not including the three Judges of the Supreme Court.

Browne, George	Judges' Associate	28 years	From 1st September, 1881, to 28th February, 1883, 18 months. During this period Mr. Browne paid the salary of the Officer who performed the duty during his absence out of his private purse. On the application of the Governor of the Straits Settlements, his services were placed at His Excellency's disposal for one year from 1st March, 1883, to 1st March, 1884, during which period he did not draw any salary from this Colony. With these exceptions, he has not been absent on leave, except during a portion of the long vacation of the Supreme Court which commences 19th December, and ends 25th February.
Shaw, Bernard	Inspector of Police	30½ years	One month and one day, from 18th October to 19th November, 1886.
Tarleton, William	Police Magistrate	48 years	From 1st July, 1882, to 1st December, 1883, 17 months—under Medical Certificate; from 20th October, 1886, to 25th November, 1886, 5 weeks; from 24th March, 1888, to 1st May, 1888, 5 weeks; from 23rd April, 1889, to 1st June, 1889, 5 weeks.
