EXECUTIVE COUNCIL.

MONDAY, JANUARY 31, 1870.

MINUTE No. 22.

THE Governor approves of Mr. and Mrs. Duncan being allowed to retire from the charge of the Public School at Stanley, Circular Head, and to receive Pensions at the rate of £36 14s. 1d. and £4 per annum respectively. To take effect on the 1st October, 1869, and to be provided for on a Supplementary Estimate.

SATURDAY, FEBRUARY 5, 1870.

MINUTE No. 34.

Sir Valentine Fleming having resigned his office of Chief Justice of the Supreme Court of Tasmania, the Governor, by Letters Patent, grants him the amount of Pension, to commence this day, to which he is entitled under the Act of Council 17 Vict. No. 24, namely, two-thirds of his salary as Chief Justice.

His Excellency and the Members of the Council desire to record on the Minutes their high estimation of Sir Valentine Fleming's long and faithful services to the Colony in the discharge of the important and responsible duties of his office, and their regret at the loss sustained by the community at large in the retirement of so able and upright a Judge.

FRIDAY, APRIL 22, 1870.

MINUTE No. 79.

The Governor grants to Mrs. Ann Curphy, late a Teacher in the Macquarie-street Public School, a Retiring Allowance at the rate of £30 17s. 9d. per annum. To take effect on the 1st January last; the amount to be provided for on a Supplementary Estimate.

WEDNESDAY, MAY 18, 1870.

MINUTE No. 94.

The Governor approves of a recommendation of the Council to the effect that, in accordance with the provisions of "The State Aid Commutation Act," a Retiring Allowance be granted to the Rev. Robert M'Lean, at the rate of £120 per annum. To take effect on the 1st proximo; the amount to be provided for on a Supplementary Estimate.

MONDAY, MAY 30, 1870.

MINUTE No. 116.

Under the provisions of the 9th Section of "The State Aid Commutation Act," the Governor approves of the Rev. Edward Freeman being allowed to retire from the Public Service, and of a Pension being granted to him at the rate of £175 per annum. To take effect from the 30th proximo, and to be provided for upon a Supplementary Estimate.

MONDAY, JUNE 13, 1870.

MINUTE No. 125.

The Governor approves of Mr. Thomas Figgis, late Master of the Public School under the Board of Education at George Town, being granted a Retiring Allowance at the rate of £25 0s. 1d. per annum. To take effect on and after the 1st October, 1869; to be provided for upon a Supplementary Estimate.

WEDNESDAY, JUNE 15, 1870.

MINUTE No. 134.

The Council submit—That Mr. Calder be allowed to retire from the office of Surveyor-General and Commissioner of Crown Lands, and that he be granted a Pension at the rate of £470 per annum. To take effect on the 13th July next.
