#### A BILL FOR

An Act to amend the Government Business Enterprises Act 1995

Be it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

#### 1. Short title

This Act may be cited as the Government Business Enterprises Amendment Act 2005.

#### 2. Commencement

- (1) Section 4 is taken to have commenced on 27 November 2002.
- (2) The remaining provisions of this Act commence on the day on which this Act receives the Royal Assent.
