**A BILL FOR**

**An Act for the appropriation of \$195 664 000 out of the Consolidated Fund for the service of the financial year ending on 30 June 2011 for the purpose of making contributions to a number of Divisions of Part 2 of Schedule 1 to the *Consolidated Fund Appropriation Act (No. 1) 2010***

Be it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

**1. Short title**

This Act may be cited as the *Consolidated Fund Appropriation (Supplementary Appropriation for 2010-2011) Act 2011*.

**2. Commencement**

This Act is taken to have commenced on 1 July 2010.

**3. Issue and appropriation of \$195 664 000**

- (1) In respect of the financial year ending on 30 June 2011, the Treasurer may issue the sum of \$195 664 000 out of the Consolidated Fund.
- (2) The sum specified in subsection (1) is appropriated.

**4. Purpose of appropriation**

The sum of \$195 664 000 is to be applied for the purposes specified in Schedule 1.

**5. Expiry of Act**

This Act expires on 30 June 2012.
