A BILL FOR

**An Act to amend the *Public Works Committee Act 1914* and
to repeal and revoke certain spent legislation**

Be it enacted by Her Excellency the Governor of Tasmania, by
and with the advice and consent of the Legislative Council and
House of Assembly, in Parliament assembled, as follows:

PART 1 – PRELIMINARY

1. Short title

This Act may be cited as the *Legislation and
Regulatory Review (Premier and Cabinet) Act
2026*.

2. Commencement

This Act commences on the day on which this
Act receives the Royal Assent.

**PART 2 – PUBLIC WORKS COMMITTEE ACT 1914
AMENDED**

3. Principal Act

In this Act, the *Public Works Committee Act 1914** is referred to as the Principal Act.

4. Section 32A inserted

After section 32 of the Principal Act, the following section is inserted in Part IV:

32A. Transitional provisions consequent on enactment of *Public Works Committee Amendment Act 2009*

(1) In this section –

amending Act means the *Public Works Committee Amendment Act 2009*;

amendment day means the day on which the amending Act commenced.

(2) If a public work was, before the amendment day, referred to the Committee under this Act for the Committee to report upon the work, then the provisions of this Act as in force immediately before the amendment day
