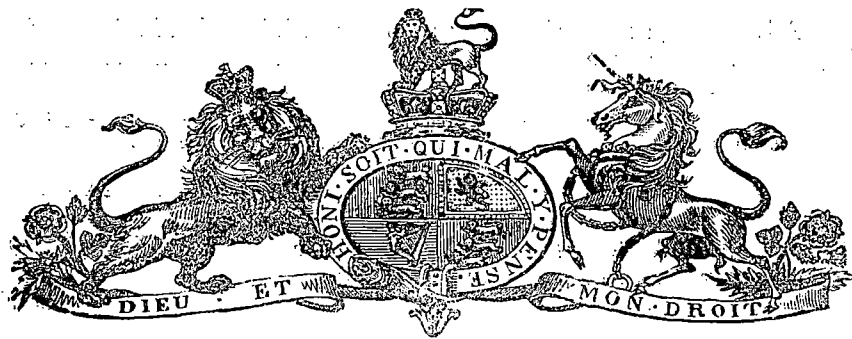

SIR,

WE have the honor to call your attention to the fact that the *Tasmanian Tribune* is one of the best mediums in the Colony to make the various wants of the Government known.

The *Tribune* has the largest circulation of any newspaper in Tasmania; which, if necessary, we are prepared to prove by exposing our books to a responsible officer appointed by the Government.

We would suggest to the Executive the adoption of the system in vogue in Victoria; viz., that any Newspaper which has been in existence six months have a proportion of the Government advertisements in accordance with its value as a commercial medium.

This, we think, would meet the wants of the Colony, by circulating the requirements of the Government through much wider channels, as well as doing away with the stigma of a "subsidised press."

SIR,

In reply to your communication of this date, asking for an explanation of the words "solely in the *Mercury*," we must call your attention to the advertisement calling for the Tenders for the insertion of Government Advertisements in a Hobart Town and Launceston newspaper, &c.

Our Tender is submitted in accordance with this advertisement. We presume a tender gives one the sole right of doing certain work; otherwise there would be no necessity for asking for tenders.

Should this explanation not be sufficiently intelligible, we shall be glad to make ourselves more explicit.

SIR,

WE are in receipt of yours of the 18th instant accepting, conditionally, our Tender for the Government advertising for the year 1877.

With regard to the reservations made by the Government we should like clearly to understand our position.

The Government are aware that, notwithstanding the existence of a Tender held by us for advertising in Hobart Town, the same advertisements appear contemporaneously in another Hobart Town Paper, and this of course is to our detriment; for when a tenderer agrees to perform certain work, it is surely expected that he shall have all the advantages appertaining to the tender.

Should the Government continue to act in the same manner in 1877 as in the past four months, there is no necessity for a Contract; and we should most certainly decline to accept a reduced rate where similar advantages are given to non-tenderers who may, for aught we know, receive full rates.

We shall feel obliged if you will let us know clearly what are the classes of advertisements which require additional publicity.

WE have to acknowledge your letter of the 5th inst., advising us of the acceptance by the Government of Tender from the *Tribune* newspaper for advertising for the Government for the current year at the rate of One Shilling per inch, and offering us the same advertisements at the contract rates.

We cannot reconcile this letter with yours of the 18th December last, notifying the acceptance by the Government of our Tender for advertising for the year 1877, and which as notified in ours of the 2nd January "we held ourselves bound by," &c.

Under these circumstances we protest against the Government accepting a Contract from another paper at twice the rates at which we had contracted with the Government to perform the work.

We think in common fairness we have a right to expect some explanation of this extraordinary proceeding on the part of the Government, after first agreeing to accept our Tender and receiving from us a promise that the Contract would be carried out by us.
