

ORDERS of the Governor in Council under "The Superannuation Act."

EXECUTIVE COUNCIL.

MONDAY, JANUARY 7, 1867.

MINUTE No. 2.

THE Colonial Secretary submits that, with the view of enabling the Government to carry into effect certain changes in the Staff of the Colonial Treasury, having for their object the consolidation of offices and the reduction of departmental expenditure, William Henry Gill, Esquire, Chief Clerk in the Audit Department, be retired from the Public Service, and allowed a Pension, calculated in accordance with the 5th Section of the Superannuation Act, of £160 6s. 8d. per annum from the 1st February next inclusively.

Also, that William Henry Windscr, Esquire, be appointed Chief Clerk in the Audit Department, vice Gill, at a salary of £300 per annum, from the same date.

The Governor in Council approves.

MONDAY, JANUARY 14, 1867.

MINUTE No. 6.

The Colonial Secretary submits that Captain James Reid be allowed to retire, at his own request, from his offices of Superintendent of the Houses of Correction and Gaoler, Launceston, receiving Compensation under the provisions of the Superannuation Act to the amount of $\pounds 168$ 8s.

That, consequent upon Captain Reid's retirement, the offices of Clerk and Storekeeper be consolidated with those of Superintendent and Gaoler; and that Mr. John Francis Cox be appointed Gaoler, Superintendent, and Storekeeper, with salary at the rate of £250 per annum, on and after the 1st proximo.

His Excellency approves.

MINUTE No. 7.

THE Governor in Council approves of the office of Police Clerk at George Town being abolished on and after the 1st instant, and of the present holder of such office, Mr. William Thomas Ashley, receiving the sum of $\pounds 151$ 2s. 2d. as Compensation for the loss of his appointment.

MONDAY, JANUARY 28, 1867.

MINUTE No. 27.

THE appointment of Police Magistrate of Franklin having been abolished, the Governor in Council grants Mr. Walpole, late holder of that office, a Pension under the 5th Clause of the Superannuation Act, at the rate of £113 6s. 8d. per annum: to take effect on the 1st instant.

MONDAY, FEBRUARY 11, 1867.

MINUTE No. 39.

THE Governor in Council grants Mary Noble, late Schoolmistress under the Board of Education in the Margaret-street Public School, Launceston, a Retiring Allowance of £11 6s. 8d. per annum, to commence on the 1st February, 1867, her health being such as to incapacitate her from the efficient discharge of her duties.

WEDNESDAY, FEBRUARY 20, 1867.

MINUTE No. 50.

THE Governor in Council approves of the payment to Mr. W. H. Gill of the sum of £50, in accordance with the Council Minute No. 227, of the 6th July, 1863, he having retired from the Public Service, and the Auditor having certified that he is entitled to that amount.

MONDAY, APRIL 1, 1867.

MINUTE No. 73.

THE Colonial Secretary submits that the Grant of Compensation to Mr. Robert Power, authorised by His Excellency on the 4th February last, be cancelled, and that that gentleman be now granted Compensation upon his retirement from the office of Usher of the Black Rod, on the grounds of age and infirmity of body, to the extent of £155 11s. 1d.

The Governor in Council approves.

MINUTE No. 74.

HIS Excellency grants to the Rev. Arthur Davenport Compensation for the loss of his office as Chaplain to the Male House of Correction and Gaol at Hobart Town, to the amount of $\pounds74$ 8s. 10d.

MONDAY, MAY 13, 1867.

MINUTE No. 89.

JOSEPH ABBOTT, who was lately employed as Messenger at the Police Office with the pay of a Petty Constable, having been reduced, the Governor in Council approves of his receiving a Pension at the rate of £24 6s. 8d. per annum, to commence on the 1st February last.

His Excellency also grants Charles Skurrey, late Tidewaiter in the Customs Department at Launceston, a Pension for the loss of such office of £53 6s. 8d. per annum, to commence on the 1st March last.

MINUTE No. 90.

THE Governor in Council awards Compensation as under mentioned to the following Chaplains, on account of the abolition of their respective offices :---

His Excellency also grants to the Rev. W. W. F. Murray, late Chaplain, Church of England, to the Hospital for the Insane, a Pension for the loss of such office at the rate of $\pounds 13$ 6s. 8d. per annum: to commence on the 1st March last.

MONDAY, MAY 27, 1867.

MINUTE No. 103.

THE Governor in Council grants to Timothy M'Mahon, late Police Constable at the Franklin, who has been permitted to retire from the Service on sick certificate, Compensation to the extent of £65 18s.

MONDAY, JUNE 10, 1867.

MINUTE No. 110.

THE Governor in Council grants to the Rev. J. H. Smales Compensation for loss of office as Religious Instructor at the General Hospital, Hobart Town, to the extent of £22 14s. 5d., and as Religious Instructor at the Brickfields Invalid Depôt to the extent of £39 4s. 8d.; amounting together to £61 9s.

His Excellency also grants to Mr. James Michael Quinn, late Assistant Schoolmaster at the Queen's Asylum, Compensation for the loss of such office to the extent of £172 19s. 7d.; and to Miss Catherine Anastasia Quinn, late Senicr Schoolmistress at the same Institution, Compensation to the extent of £150 0s. 3d.

MONDAY, JUNE 17, 1867. MINUTE No. 114.

THE Governor in Council has under consideration an application from Mr. George Lord Taylor, late Clerk in the Customs Department at Launceston, to be allowed a Pension for his services while in the employ of the Government.

The full amount of the Pension to which Mr. Taylor would, under favourable circumstances, be entitled is represented to be £59 14s. $\mathcal{E}d$. He is stated to have performed his duty, as far as he was able, "with diligence and fidelity;" but as his retirement from the Public Service was rendered necessary by ill-health caused by habits of intemperance, the Council advise that he be granted a Pension at the reduced rate of £52 per annum, to take effect on and from the 1st January last.

His Excellency approves.

MINUTE No. 116.

THE Colonial Secretary submits the following Minute:-

"That the application now submitted for Compensation for loss of office as Master of the Breadalbane Public School, by Mr. James Rogers, cannot be entertained.

"The Board of Education felt bound to close the School in consequence of the declension of the numbers attending; but the correspondence shows that such declension was caused by improper conduct on the part of Mr. Rogers, which in the opinion of the Government would have warranted the Board in dismissing Mr. Rogers as unfit to have charge of any School."

The Governor concurs.

MONDAY, JUNE 24, 1867.

MINUTE No. 123.

THE following recommendation, submitted by the Colonial Secretary, is approved :—" That the Governor in Council having decided upon the reduction of the salary of Mr. Atkins, Superintendent of the Female Gaol and House of Correction, from £266 per annum to £140 12s. 6d, on the ground that he is entitled to draw the sum of £125 7s. 6d. from the Imperial Government as Pension, the two amounts together equalling his former salary, Mr. Atkins be allowed, in the event of his retirement from the Public Service of the Colony under circumstances entitling him to Compensation or Pension under the Superannuation Act, to include the amount of such Imperial Pension as part of his emoluments of office when forwarding his Pension Paper."

MONDAY, JULY 29, 1867.

MINUTE No. 148.

THE Council submit that the Governor in Council having decided upon the reduction of the Salary of Mr. Thomas Reidy, Keeper of the Gaol and House of Correction for Males at Hobart Town, from £338 per annum to £288, on the ground that he is entitled to draw the sum of £50 from the Imperial Government as Pension, the two amounts together equalling his former salary, Mr. Reidy be allowed, in the event of his retirement from the Public Service of the Colony under circumstances entitling him to Compensation or Pension under the Superannuation Act, to include the amount of such Imperial Pension as part of his emoluments of office when forwarding his Pension Paper.

The Governor approves.
