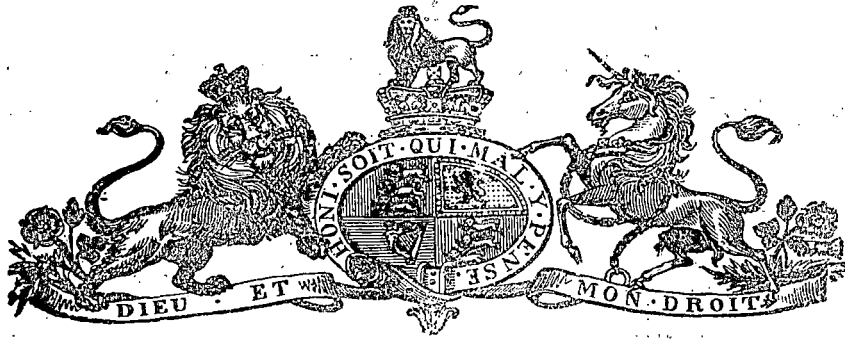

SIR,

I HAVE the honor to submit herewith my Annual Returns showing the working of the Establishment for the year 1875.

In doing so I am glad to be able to state that my Officers have discharged their several duties to my entire satisfaction.

Amongst the Constables there have been some changes, but on the whole they have performed their duties fairly.

As a rule the Prisoners have been well conducted.

You will observe that the daily strength is lower than that of last year; viz.—1874, No. 197, and 1875, 156.

The cost per head for effective Prisoners, taking credit for proceeds of labour, is £2 2s. (See Return marked A.)
