

SUPERANNUATIONS.

ORDERS of the Governor in Council under "The Superannuation Act," made since the last Meeting of Parliament.

### MONDAY, JULY 22, 1872.

#### MINUTE No. 201.

PATRICK Mitchell, late Petty Constable, having been reduced from the Police Force, His Excellency grants him a Pension, calculated on the 1st Clause of "The Superannuation Act," at the rate of £19 18s. 9d. per annum.

To take effect on the 1st instant, and to be provided for upon a Supplementary Estimate.

### MINUTE No. 203.

His Excellency approves of the services of the Javelin Men, Patrick Doolin and Thomas Dullard, being dispensed with, the former on account of old age and infirmity, the latter in consequence of reduction in the Sheriff's Department; and of Pensions, calculated on the 1st Clause of "The Superannuation Act," and to take effect on 1st April last, being granted to them at the following rates. The amounts to be provided for upon a Supplementary Estimate; viz.—

# MINUTE No. 228.

On the recommendation of the Commissioners of the Hospital for the Insane, New Norfolk, His Excellency approves of Daniel M'Namara, Under Keeper, being allowed to retire on the 30th proximo, on a Pension of £34 15s. 10d. per annum.

The Pension to commence on 1st October, and to be provided for upon a Supplementary Estimate.

His Excellency also approves of the retirement of William Moffatt, Constable at the Male House of Correction, Launceston, on account of bodily infirmity, namely, paralysis; and grants him a Pension at the rate of £19 15s. 5d. per annum. To take effect on the 6th instant, and to be provided for upon a Supplementary Estimate.

## MINUTE No. 278.

The Governor approves of Mr Frederick Fennell, Master, and of Elizabeth Fennell, his wife, Mistress for Needlework, at the Public School at Prosser's Plains, being allowed to retire, on the ground of age and physical disease on the part of the former, and to receive Pensions at the rate of £15 8s. 11d. and £4 14s. 6d. per annum respectively.

To take effect from the 1st July last, and to be provided for upon a Supplementary Estimate.

#### MONDAY, OCTOBER 28, 1872.

#### MINUTE No. 288.

Mr. Edward Dickens's services having been dispensed with as Warehouse Keeper on the re-organisation of the Customs Department at Launceston, the Governor approves of a Retiring Allowance being granted to him at the rate of £246 13s. 4d. per annum, of which £152 2s. 3d. will be paid from the Colonial Treasury, and £94 11s. 1d. from Imperial funds. To take effect from the 1st May last, and the Colonial portion to be borne upon a Supplementary Estimate.

Mr. David White's services having been dispensed with as Tidewaiter on the same ground, a Retiring Allowance is granted to him at the rate of £39 per annum.

To take effect on the 1st May last, and to be provided for upon a Supplementary Estimate.

#### MINUTE No. 289.

His Excellency approves of the Rev. Robert Russell, Chaplain of the Church of Scotland at Evandale, being allowed to retire in consequence of failing health, and to receive a Pension at the rate of £185 per annum; the date of commencement to be arranged with the Governing Body of that Church, and the amount to be placed on a Supplementary Estimate.
