

## HOBART MARINE BOARD.

## BY-LAW No. 16.

- A BY-LAW, made pursuant to "The Marine Board Act," to fix and regulate the Wharfage Rates to be paid on Goods entered to be landed at the Port of Hobart.
- 1. By-laws numbered 5 and 9 respectively shall be and the same are hereby repealed.
- 2. The Wharfage Rates set forth in the Schedule hereunder written shall, on and after the coming into operation of this By-law, be paid on Goods entered to be landed at the Port of Hobart.
- 3. This By-law shall commence and take effect on and from the first day of October, 1883.

Made and passed by the Hobart Marine Board, when a majority in number of the Wardens were present, this seventh day of September, 1883.

Rated goods packed in cases, casks, &c. with other goods, shall be charged the package rate only.

Goods for transhipment shall be allowed to pass over the wharves, from one ship to another, free of wharfage.

Exemptions.—All articles for the use of Her Majesty's Government, all goods and merchandize the produce of this Colony or of the fisheries thereof, as well as all fish oil and whalebone landed in the Colony from any vessel engaged in the fisheries; all empty casks intended for the fisheries, and guano, bones, bone-dust, and other manures; also, all wool and mineral ores imported into the Colony intended for exportation.
