DRAWBACKS BILL, 1883, (No. 25) :

PETITION IN FAVOUR.

Presented by Mr. Crowther, September 21 ; and ordered by the Council to be printed, September 25, 1883.



*The Honorable the President and Members of the Legislative Council of Tasmania,
in Parliament assembled.*

The humble Petition of the undersigned Importers and Traders of the City of Hobart,

SHOWETH :

1. THAT the power proposed to be given to the Governor in Council by the Bill now before your Honorable House for extending the system of Drawbacks in the Colony is one which your Petitioners believe to be most useful, inasmuch as articles for drawback may be added to the Schedule as occasion may require.

2. That similar Acts have been in force in the neighbouring Colonies for many years past, and have worked most advantageously in the interests of trade ; Drawbacks being allowed not only on original packages but upon goods which have been repacked.

3. That the exigencies of trade sometimes necessitate the exportation of mixed parcels of goods in order to meet the requirements of small buyers.

4. That the limitation of the advantages of such system would be detrimental to the interests of your Petitioners.

Your Petitioners therefore humbly pray your Honorable House to pass the Bill now under consideration.
