# **Notices of Question**

- 10 Ms *O'Byrne* to ask the Minister for Housing In relation to Specialist Homelessness Information System (SHIP) data collection:
  - (1) Have any individuals who have requested accommodation been refused, and if so, how many in;
    - (a) 2019;
    - (b) 2020; and
    - (c) 2021 to date?
  - (2) Is the SHIP data able to be accessed, and if not, what is the data collected by SHIP is used for? (14 October 2021)
- 14 Ms O'Connor to ask the Minister for Education, Children and Youth In relation to unauthorised student absences:
  - (1) Have there been any unauthorised student absences so far during 2022, and if so, how many?
  - (2) Were there any unauthorised student absences during the same period for 2021, and if so, how many?
  - (3) Have any parents of children registered as an unauthorised absence informed the school the absence is due to Covid related matters, and if so, how many?
  - (4) Have any parents been fined for unauthorised student absences in 2022, or sent correspondence stating that a fine may be imposed, and if so, how many?
  - (5) Where unauthorised student absences are due to parents wishing to keep their child out of class to protect them or other family members from Covid, what will be the Department's response?
  - (6) Are there any resources or support in place for home learning for students who are not physically attending school due to Covid related concerns, and if so, what are they? (1 March 2022)
- **15** Ms *Haddad* to ask the Minister for Corrections In relation to vaccination rates within the Tasmanian Prison Service (TPS):
  - (1) Have inmates received two Covid-19 vaccinations, and if so, how many?
  - (2) Have inmates received the Covid-19 booster, and if so, how many?
  - (3) What percentage of TPS staff have received two Covid-19 vaccinations?
  - (4) What percentage of TPS staff have received the Covid-19 booster?
  - (5) Of those people housed in TPS facilities on remand, how many have received two Covid-19 vaccinations and a Covid-19 booster?
  - (6) For those staff, inmates and people housed in remand who are unvaccinated, what are the reasons for not been vaccinated? (2 March 2022)
- **16** Ms *O'Connor* to ask the Minister for Education In relation to Tasmanian school classrooms or 'learning spaces':
  - (1) Are there any classrooms or 'learning spaces' in Tasmanian schools, government, private and independent, that are perimeter classrooms, and if so, how many?

- (2) If there are perimeter classrooms, do any of these have opening windows, and if so, how many? (8 March 2022)
- 17 Ms O'Connor to ask the Minister for State Development, Construction and Housing In relation to social and community housing:
  - (1) Have any new social and community housing homes been built since 30 June 2014, and if so, how many?
  - (2) Have any Housing Tasmania titles been transferred to new ownership since 30 June 2014, and if so, how many? (8 March 2022)
- **18** Ms O'Connor to ask the Minister for Resources In relation to forestry emissions:
  - (1) What are the total emissions from forestry logging and burning since 2014?
  - (2) What are the total reported emissions from logging on Permanent Timber Production Zone land in 2020 and 2021? (8 March 2022)
- **19** Ms *O'Connor* to ask the Minister for Health Have any Tasmanians with a disability been confirmed as COVID positive between 15 December 2021 and 8 March 2022, and if so, how many? (8 March 2022)
- **20** Ms *O'Connor* to ask the Minister for Racing In relation to racing injuries:
  - (1) Have any greyhounds been injured on the track between 1 January 2022 and 8 March 2022, and if so, how many?
  - (2) Have any thoroughbreds been injured during races between 1 January 2022 and 8 March 2022, and if so, how many?
  - (3) Have any greyhounds been administered a lethal injection as a result of injuries between 1 January 2022 and 8 March 2022, and if so, how many?
  - (4) Have any horses been administered a lethal injection as a result of their injuries between 1 January 2022 and 8 March 2022, and if so, how many? (8 March 2022)
- 21 Ms O'Connor to ask the Minister for Parks In relation to Expressions of Interest:
  - (1) Have any Expression of Interest proposals for development in public protected areas been approved to lease and licence since 1 January 2015, and if so, how many?
  - (2) Is the Government currently assessing any Expression of Interest proposals, and if so, how many? (8 March 2022)
- **22** Ms *Haddad* to ask the Minister for Housing In relation to the 4355 applications listed as of January 2022 on the Housing Dashboard as being on the Housing Register:
  - (1) Are any of those listed classified as 'exiting priority' and if so, how many?
  - (2) Are any of those listed classified as 'priority' and if so, how many?
  - (3) Do any applicants have a disability, and if so, how many?
  - (4) Do any applicants have dependent children, and if so, how many have dependent children?
  - (5) Do any applicants currently have no fixed address, and if so, how many?
  - (6) Can the Minister provide the above information broken down by gender as well as by the following age brackets:
    - (a) Under 18;
    - (b) 18-25;
    - (c) 26-35;
    - (d) 36-55;
    - (e) 56-65; and
    - (f) 66 plus (9 March 2022)
