- Ms *Johnston* to ask the Minister for Science and Technology With respect to the Digital Ready for Daily Life Program launched in 2019:
  - (1) Were any programs and initiatives funded from this Program in each of the financial years: 2019-20; 2020-21; and 2021-22, and if so, how much for each such financial year?
  - (2) Have any programs and initiatives been funded from the Program for 2022-23, and if so, what are the details?

  - (4) What are the Key Performance Indicators used to assess and measure the performance and effectiveness of the Program, what outcomes have been identified for Tasmanians experiencing high levels of digital exclusion, specifically: low income households; older Tasmanians; and people not in paid employment?
