Notices of Motion

- 144 Mr Young to move—That the House:—
 - (1) Acknowledges:-
 - (a) that Tasmania continues to lead the nation on economic performance, having ranked first overall for 12 of the previous 14 CommSec State of the State Quarterly Reports and has improved on all eight performance indicators in the report since the Liberal Government was elected in 2014; and
 - (b) the latest Australian Bureau of Statistics (ABS) labour force data, which shows Tasmania breaking employment records, with a record 291,100 Tasmanians employed, including a record 140,200 women, which is over 56,000 more jobs compared with when the Liberal Government was elected in March 2014.
 - (2) Notes that the current unemployment rate of 3.8% is the lowest in the state's history.
 - (3) Further notes that, in contrast, the former Labor-Green Government oversaw an economy where:—
 - (*a*) consumption and investment contracted, quarter after quarter;
 - (b) State Final Demand contracted for six out of seven quarters between December 2011 and June 2013;
 - (c) the unemployment rate reached 7.9%, and over 19,000 Tasmanians were unemployed; and
 - (*d*) the State was plunged into recession.
 - (4) Endorses the Rockliff Liberal Government's strong economic management, which has turned Tasmania's economy around, and its plan to continue growing our economy and seeing a record number of Tasmanians employed.
 - (5) Acknowledges that these figures represent the livelihoods of real Tasmanians, as each new job created is another person contributing to our economy, but more importantly, providing for their family, and having a strong economy allows us to invest more into the things Tasmanians care about most. (8 August 2023)
- 145 Ms *Haddad* to move—That the House:—
 - (1) Notes:-
 - (a) that the week of 7 13 August 2023 is Homelessness Week a time that Tasmanians are encouraged to reflect on issues affecting housing and homelessness;
 - (b) that for far too many Tasmanians, every week is homelessness week with increasing numbers of people unable to find a safe, affordable place to call home; and
 - (c) there are dramatic supply shortages in social and government housing, affordable housing, private rental homes and homes to buy.
 - (2) Recognises:-
 - (*a*) there are significant supply shortages in social and government housing, as well as affordable housing, and homes for private rent and sale; and
 - (b) that since the Liberal Government took office in 2014, the housing wait list has more than doubled and the housing wait time has more than quadrupled.

- (3) Further recognises a series of practical policies could be implemented to increase supply of housing across the board, and that Tasmanian Labor is putting forward a range of policies to achieve that including:—
 - (*a*) increasing the supply of social and government housing;
 - (b) build to rent to increase supply of private rental homes;
 - (c) expanding the My Home program to help more Tasmanians to buy a home; and
 - (d) removing the 'first mover' penalty that acts as a disincentive to unlocking land to increase the supply and construction of housing.
- (4) Further recognises Labor is focused on the things that matter to Tasmanians: housing, health and the cost of living and focused on practical policies that can be implemented to significantly increase the supply of housing across Tasmania. (8 August 2023)
- 146 Mr *Wood* to move—That the House:—
 - (1) Supports the Rockliff Liberal Government's Renewable Energy Dividend (RED) policy, noting that:—
 - (a) each year when Hydro returns a dividend to Government over \$100 million, Tasmanians will directly share in it;
 - (b) the RED will be 50 per cent of the usual Government dividend over \$100 million;
 - (c) the dividend will appear as a financial credit on bills for around 254,000 Tasmanian households;
 - (d) Tasmanians could expect a saving of around \$100 off their power bill if Hydro delivered a profit of around \$160 million; and
 - (e) this means that when Hydro makes money, Tasmanians save money. (8 August 2023).
- 147 Ms *White* to move—That the House:—
 - (1) Agrees that after nearly 10 years the Liberal minority Government has lost its way.
 - (2) Notes that in a cost of living, housing and health crisis, the Premier, Hon. Jeremy Rockliff MP, has engaged a PR company to spin his messages rather than deliver real solutions that will help people and improve the lives of Tasmanians.
 - (3) Recognises the Liberal Government's broken promise to deliver a Tasmanian First policy on energy is hurting Tasmanian households and businesses with a 22.5% increase in prices in just the past two years.
 - (4) Further notes that the Premier was not the leader elected with a mandate and that the stadium has never been put to the people of Tasmania.
 - (5) Further notes the comments by Independent Members Mr John Tucker MP and Mrs Lara Alexander MP, that to attempt to blame them for the Government's problems is in their words, "pathetic".
 - (6) Further notes that in addition to the cost of living, health and housing crisis that makes life more difficult for Tasmanians, the Liberal Government is also making life difficult for our firefighters and for business, like Tasmanian-based saw-millers.
 - (7) Agrees that an inept Cabinet and Liberal Government is failing Tasmanians. (8 August 2023)

148 Ms *White* to move—That the House:— Orders the Premier, Hon. Jeremy Rockliff MP, to inform the House of the revised cost for the construction of Marinus Link and to table the letter sent by the Tasmanian Government to the Australian Government in July 2023 expressing concerns about the cost of the project, by Thursday 10 August 2023. (8 August 2023)

149 Ms *White* to move—That the House censures the Minister for Energy and Renewables, Hon. Guy Barnett MP for the following reasons:—

- (*a*) deliberately and callously overseeing a 22.5% electricity price increase for Tasmanian households and small businesses;
- (b) doing nothing tangible to support larger businesses battling electricity price increases of more than 50%;
- (c) breaking his 2018 promise to de-link from the National Electricity Market;
- (d) breaking his 2021 promise to cap power prices if there was high volatility in the National Electricity Market;

- (e) saying he could not implement a price cap because it would jeopardise Project Marinus;
- (f) signing an agreement with the Australian Government on 19 October 2022 to fund Marinus Link saying Tasmania will only pay their fair share, before announcing nine months later that same agreement means Tasmania is not getting a fair deal;
- (g) refusing to be honest and transparent with Tasmanians about the current estimated cost of Marinus Link;
- (*h*) refusing to be honest and transparent with Tasmanians about the share of the cost of Marinus Link the Tasmanian Government is planning to contribute;
- (*i*) bringing four of Australia's largest energy companies to Tasmania to manufacture hydrogen and then telling them there was no power or water available to actually do it; and
- (*j*) overseeing an energy drought whereby our largest energy users are being told they cannot access additional electricity to create new jobs. (8 August 2023)
- 153 Ms *Haddad* to move—That the House:—
 - (1) Notes:-
 - (*a*) that the Honourable William Cox AC conducted a thorough review of the Tasmanian Integrity Commission in 2016;
 - (b) that to date, the Liberal Government has implemented just six of the 55 recommendations made by Mr Cox; and
 - (c) that the Tasmanian Integrity Commission has some of the weakest powers of equivalent bodies around the country.
 - (2) Further notes:—
 - (a) the need for better funding for the Integrity Commission and the implementation of recommended improvements to uphold integrity in our public institutions; and
 - (b) the Tasmanian Integrity Commission has the second lowest funding per capita of all integrity bodies in the country and complete less than ten percent of the number of investigations completed by mainland integrity bodies.
 - (3) Further notes that trust in politics is at an all time low and that well functioning integrity bodies are an integral part to restoring trust in public institutions.
 - (4) Further notes that the Government stubbornly refuses to progress work to implement the recommendations of the Cox review, or even give timelines for full implementation, and that there have been just a measly six implemented to date.
 - (5) Calls on the Government to progress this work as a matter of urgency. (9 August 2023)
- 155 The Minister for Energy and Renewables to move—That the House:—
 - (1) Notes:-
 - (a) that TasNetworks responded to a weather event on 31 July 2023; and
 - (b) the weather event, which lasted for a relatively short period, had a major impact on energy users around Tasmania;
 - (2) Further notes Tasmania State Emergency Service received 10 call outs after record-breaking winds up to 143km/h were reported in Strahan and up to 100km/h at Bruny Island and Low Head.
 - (3) Further notes outages were reported at Little Swanport, Swansea and Triabunna along with other parts of the State;
 - (4) Acknowledges that dedicated TasNetworks crews around the State restored connection to around 15,000 customers within 24 hours of the disruption to service, with majority of disrupted households reconnected in that window.
 - (5) Further notes that given the work needed to repair the infrastructure in a safe manner, the reconnection of so many households in such a small amount of time is a reflection of the hardwork and dedication the TasNetworks team delivers to the Tasmanian people on a daily basis. (9 August 2023)

156 The Minister for Veterans' Affairs to move—That the House:—

(1) Notes the Minister for Veterans' Affairs, Hon. Guy Barnett MP was honoured to represent the Premier, Hon. Jeremy Rockliff MP at the RSL Tasmania – Inaugural

Mid-Winter Gala Ball on 1 July 2023 in the Ricky Ponting Room, Blundstone Arena, Bellerive.

- (2) Further notes highlights included the Royal Australian Navy Band Tasmania providing music and vocals for guests to enjoy the evening.
- (3) Further notes:—
 - (a) RSL Tasmania's core function is commemoration, comradeship and welfare with RSL Tasmania delivering over 200 commemorative events in 2023 so far;
 - (b) the fantastic support of individuals and groups contributing donations to the raffle, with proceeds going to supporting Veterans and their families; and
 - (c) celebrating events such as this demonstrate how community spirit is alive and well with people showing an ongoing support for our Veterans and acknowledges that RSL Tasmania as a peak body is important to this ongoing success.
- (4) Congratulates RSL Tasmania for organising the Inaugural Mid-Winter Gala Ball, with appreciation to Acting State President Mr Michael Gallagher, CEO Mr John Hardy and the RSL Tasmania Team and thanks the many Volunteers who supported this inaugural event. (9 August 2023)
- **157** Ms *White* to move—That the House refers the Premier, Hon. Jeremy Rockliff MP to the Committee of Privileges and Conduct given his breach of the Standing Orders. (10 August 2023)
- **158** Ms *White* to move—That so much of Standing Orders be suspended as would prevent Notice of Motion No. 157 from being debated forthwith. (10 August 2023)

159 The Minister for Energy and Renewables to move—That the House:—

- (1) Notes the 2023 Civil Contractors Construction Tasmania Awards were held Friday 21 July 2023 at Hobart's Grand Chancellor Hotel.
- (2) Further notes the event is known as the Earth Awards and was well supported with Katelyn Barry and Dave Noonan as Master of Ceremonies.
- (3) Congratulates the Civil Contractors Federation 2023 Tasmanian Earth Award Winners:—
 - (a) BridgePro and Latrobe Council Project Value up to \$2million Winning Project – Warrawee Suspension Bridge;
 - (b) AWC Pty Ltd Project Value \$2m \$5m
 - Winning Project St Marys and Elephant Pass Flood Repairs;
 (c) Shaw Contracting (Aust) Pty Ltd Project Value \$5m \$10m
 - Winning Project Bruny Island Submarine Cable Replacement;(d) Fulton Hogan Construction Project Value \$10m \$30m
 - Winning Project Midway Point Intersection Upgrade;
 - (e) Hazell Bros Group Pty Ltd Project Value \$30m \$75m
 - Winning Project Tasman Highway, Hobart Airport Interchange
 - (f) Gradco Award Safety at Roadworks;
 - (g) Downer EDI Award Commitment to Training;
 - (*h*) Jayden Speed of Sutcliffe Contracting
 - Award Civil Trainee / Apprentice of the Year;
 - (*i*) Visualise Contracting Award Owner Operator of the Year;
 - (j) Sutcliffe Contracting Award Small Civil Contractor; and
 - (k) Mark Lusted, AWC Pty Ltd Equipment Operator of the Year.
- (4) Further congratulates the Civil Contractors Federation 2023 Tasmanian Earth Awards on a successful event and acknowledges the support from business partners and members in celebrating the achievements of individuals and companies while showcasing the importance of the industry. (10 August 2023)
- 160 Ms *Dow* to move—That the House:—
 - (1) Notes:-
 - (a) Tasmania's only Mother and Baby Unit at St Helen's Private Hospital closed on 23 June 2023 resulting in the loss of 8 beds;

- (b) in May 2023 the Liberal minority Government promised an interim solution of 3 beds at the Royal Hobart Hospital (RHH); and
- (c) six weeks later there has been just one bed available, with patients facing significant delays accessing the bed.
- (2) Further notes:—
 - (a) there are 6,000 babies born in Tasmania each year and one in five of their mothers can experience depression or anxiety;
 - (b) mothers and babies in need of immediate support have had to wait weeks to receive a psychiatric assessment at the RHH;
 - (c) after 10 years in office, the minority Liberal Government has failed to prioritise maternal and perinatal mental health services across the State; and
 - (*d*) based on modelling from other States with the same number of births each year, approximately 10 mother baby beds across the State, complemented with outpatient services, would meet demand.
- (3) Calls on the Premier, Hon. Jeremy Rockliff MP and Minister for Health, Hon. Guy Barnett MP to:—
 - (a) meet with those care providers who have raised immediate concerns with them;
 - (b) ensure the three beds at the RHH and outpatient services are accessible now, as committed to in May 2023; and
 - (c) outline a long term plan to provide a regional model of care and 10 mother and baby beds across Tasmania. (15 August 2023)
- 161 Ms *Dow* to move—That the House:—
 - (1) Notes:—
 - (a) Tasmania has the highest heart disease prevalence across all States and Territories;
 - (b) its prevalence of 9.5% (or 37,200 people 18 years and over) is 2.9 percentage points higher than the national average of 6.6%;
 - (c) the Government's own outpatient data shows that urgent Northern cardiology patients are currently waiting 201 days just to receive an appointment with a cardiologist, while in the South patients are waiting 148 days; and
 - (d) that the Government recently commissioned a review of cardiac services across the State to be undertaken by St Vincent's Heart Centre Professor Andrew MacIsaac.
 - (2) Further notes:—
 - (a) at the Mersey Community Hospital and North West Regional Hospital, patients may be waiting up to a week to be transferred to the Launceston General Hospital (LGH) for urgent diagnostic testing or coronary intervention;
 - (b) at the LGH patients may be waiting to be transferred to Hobart for cardiothoracic surgery, placing further pressure on our hospitals and contributing to bed block;
 - (c) the LGH has 6 dedicated coronary care beds to service the population of the North and North West; and
 - (d) access to timely cardiac care is critical as is access to cardiac beds.
 - (3) Calls on the new Minister for Health, Hon. Guy Barnett MP to release the findings of the MacIsaac report publicly and inform Tasmanians how he will improve access to coronary care beds across Tasmania. (15 August 2023)
- 164 The Minister for Health to move—That the House:—
 - (1) Notes:-
 - (a) the 2023 Tasmanian Volunteering Awards were held 19 May 2023 at Government House in Hobart; and
 - (b) His Excellency the Honourable Alan Blow AO, Lieutenant Governor of Tasmania and Mrs Margaret Blow hosted the awards.
 - (2) Further notes the ceremony celebrated the amazing people who volunteer and give so much to our communities across Tasmania,
 - (3) Congratulates the Tasmanian Volunteering Awards 2023 Winners:—

- (a) Julie Porter Premier's Tasmanian Volunteer of the Year Award & Arts, Heritage, Tourism and Events Volunteer Award;
- (b) Sweta Sharma Community Care and Health Volunteer Award;
- (c) Michelle Howells Best Practice in Volunteer Management Award;
- (*d*) Lara Emmett Youth Volunteer of the Year Award;
- (e) Melanie Beets Sport, Recreation and Service Groups Volunteer Award;
- (f) Graeme Foale Lifetime Achievement Award;
- (g) Paul Doherty Environment, Animal Care and Conservation Volunteer Award;
- (*h*) Mavis Sayer Education, Science and Technology Award;
- (*i*) Brylyn Craven Emergency Services Volunteer Award; and
- (*j*) Deloraine Community Garden Volunteer Group Award;
- (4) Congratulates the Tasmanian Volunteering Awards 2023 on a successful event and acknowledges the amazing volunteers across Tasmania who continue to give so much to our local communities. (17 August 2023)

167 Ms *White* to move—That the House:—

- (1) Agrees the Minister for Energy and Renewables, Hon. Guy Barnett MP, misled the House on numerous occasions on 16 August 2023 during the debate on motion 162.
- (2) Further agrees that the fact that an updated costing for Marinus Link was provided by the Minister through a press release on 3 September 2023 demonstrates, through his own actions, that his earlier statements were false.
- (3) Expresses its view that the Minister deliberately misled the House in order to try to prevent it from seeking information it was perfectly entitled to request.
- (4) Censures Hon. Guy Barnett MP, Minister for Energy and Renewables, for misleading Parliament. (5 September 2023)
- 169 Ms *Butler* to move—That the House:—
 - (1) Notes the invaluable work provided by the 18 community managed Online Access Centres (OAC) across rural/regional Tasmania.
 - (2) Acknowledges:—
 - (*a*) community managed OACs provide services unique to individual community needs, often meeting gaps in Government services; and
 - (b) OACs provide a diverse range of services such as MyGov ATO, Judicial, Medicare, online banking, setting up new mobile phones, iPad/ tablet, set up/sending emails, online shopping, secretarial services, digital literacy, accessing medical services, online passport & visa applications, family violence orders, high quality printing services, email access, physical printing of documents, digital access, digital instruction, digital advocacy.
 - (3) Recognises:—
 - (a) community run OACs are reliant on Government funding from the Government's Digital Connections Grant; and
 - (b) current OAC funding arrangements have not increased, are not indexed and are largely inadequate with a number of OACs cutting services, and unless current grant funding arrangements are changed, many OACs will be forced to shut.
 - (4) Further notes recommendation 34 of the Premier's Economic and Social Recovery Advisory Council (PESRAC) Report acknowledges the importance of OACs in closing the digital divide and improving digital inclusion by utilising existing facilities, which provide digital capability.
 - (5) Calls on the State Government to appropriately fund and expand the OAC network to improve digital literacy and access to Tasmanian regional and rural communities.
 - (6) Further notes OACs provide different services than Libraries Tasmania.
 - (7) Further calls on the Government not to amalgamate OACs into Libraries Tasmania. (5 September 2023)
- 170 Dr *Broad* to move—That the House:—
 - (1) Notes the challenging financial circumstances of the Avebury Mine and Mallee Resources.

- (2) Further notes the importance of Avebury to the West Coast economy and to the over 200 direct jobs reliant on the continuing operation of the mine.
- (3) Further notes:—
 - (*a*) the Government promised on 30 July 2023 an immediate support package of payroll tax reimbursement \$3.5m; and
 - (b) the Government has not provided any payroll tax relief.
- (4) Calls on the Government to immediately provide the payroll tax relief to the Avebury mine that it has promised on multiple occasions since 2018. (5 September 2023)
- 174 The Attorney-General to move—That the House:—
 - (1) Notes that the Justice Video Conferencing Upgrade (VCU) Project was awarded the Tasmanian ICT/Telecommunications project of the year at the 2023 Australian Institute of Project Management Achievement Awards on 31 August 2023.
 - (2) Further notes that the VCU Project delivered 16 individual projects as a part of the broader program of work, over a 22 month period and that project deliverables benefited the Magistrates and Supreme Courts, the Tasmania Prison Service, along with the broader agency.
 - (3) Recognises the significant work that was undertaken by the Department of Justice's Project Team to deliver the VCU Project, which is already delivering benefits to our community. (6 September 2023)
- 175 The Minister for Veterans' Affairs to move—That the House:—
 - (1) Notes that the National Legacy Badge Week 2023 was held in Tasmania from Sunday 27 August till 2 September 2023.
 - (2) Recognises 2023 as the Centenary year of Legacy from its origins as the Remembrance Club, first started in Hobart by Tasmanian Major-General Sir John Gellibrand KCB DSO and Bar.
 - (3) Further notes:—
 - (a) that the enduring hard work of Hobart Legacy and Launceston Legacy in providing services to families who have suffered loss from, during or after service in the Australian Defence Force;
 - (b) that around 1,500 widows, widowers and children are supported by Hobart Legacy and Launceston Legacy; and
 - (c) that funds raised assist Legacy in providing essential services including counselling, special housing, medical, advocacy and social support to Australian families and also help assist the education and development of the children of our deceased veterans.
 - (4) Further notes that during Legacy Week, dedicated volunteers and members of the Australian Defence Force sold badges including special centenary badges and bears along with receiving donations to Legacy.
 - (5) Congratulates and thanks the committee, staff, Legatees and dedicated volunteers for their efforts over the many years in supporting the families of our incapacitated and deceased veterans. (6 September 2023)
- 176 The Minister for Veterans' Affairs to move—That the House:—
 - (1) Notes that 18 August 2023, was Vietnam Veterans Day, an annual day of remembrance for those who served during the Vietnam War.
 - (2) Recognises 2023 as the 50th year of cessation of the Vietnam War and the withdrawal of Australian Combat Troops.
 - (3) Further notes:—
 - (*a*) that during Vietnam Veterans Day communities throughout Australia remembered the service made by the 60,000 men and women, paying respects to the 523 Australians who died in the conflict and the over 3,000 that were wounded; and
 - (b) that this day, originally known as Long Tan Day, commemorates the day in 1966 when the battle of Long Tan was fought by the men of D Company, 6th Battalion, the Royal Australian Regiment (6RAR).
 - (4) Acknowledges the service of the approximately 1,800 Tasmanians who served in Vietnam, including 17 who died in their country's service.

- (5) Further notes commemorative service and wreath-laying ceremonies were held in Tasmania to mark the event, and thanks all the members of the Vietnam Veterans' Association of Australia (VVAA) Tasmania, including State President Terry Roe, for their efforts in supporting Vietnam veterans across the State over the years.
- (6) Honours the service and sacrifice of all those who fought for freedom in this conflict and remembers the motto of the VVAA: "Honour the Dead but Fight like Hell for the Living." (6 September 2023)
- 179 Mr *Winter* to move—That the House:—
 - (1) Notes power prices have increased 22.5% since June 2022, putting substantial pressure on Tasmanians during a cost of living crisis.
 - (2) Further notes the Government broke its 2018 election policy to de-link from the National Electricity Market (NEM) and its 2021 election policy to implement a price cap should there be high volatility in the NEM.
 - (3) Further notes the Liberal Party's website continues to claim the Liberal Government will implement a price cap in the event of 'volatility', but the Premier, Hon. Jeremy Rockliff MP, has repeatedly refused to do so.
 - (4) Calls on the Premier to immediately remove the relevant section from the Liberal Party's website before any more Tasmanians are deceived by his false promises. (12 September 2023)
- **180** Ms *White* to move—That so much of Standing Orders be suspended as would prevent Notice of Motion 167 from being debated forthwith. (12 September 2023)
- 181 Ms *Dow* to move—That:—
 - (1) A select committee be appointed with the power to send for persons, papers and records to inquire into, consider and report on reproductive, maternal and paediatric health and perinatal mental health services in Tasmania, with the following terms of reference:—
 - (a) to assess the adequacy, accessibility and safety of the following services for Tasmanian parents and their children in relation to:—
 - (i) reproductive health services;
 - (ii) maternal health services;
 - (iii) birth trauma;
 - (iv) workforce shortages;
 - (v) midwife professional Indemnity Insurance;
 - (vi) perinatal mental health services;
 - (vii) paediatric services for children aged 0-5 years;
 - (viii) the Child Health and Parenting Service (CHaPS).
 - (b) to examine disparities in the availability of services, staffing and outcomes between:—
 - (i) Tasmania and other Australian states and territories;
 - (ii) Tasmanians living in rural, regional and metropolitan areas;
 - (iii) Tasmanians experiencing socio-economic disadvantage; and
 - (c) to make recommendations on actions that can be taken by the State Government to ensure reproductive, maternal and paediatric health and perinatal mental health services meet the needs of Tasmanian parents, families and children.
 - (2) The number of Members appointed by the House to serve on the committee be six: two nominated by the Leader of Government Business; two nominated by the Leader of Opposition Business; one nominated by the Leader of Tasmanian Greens Business and an Independent Member nominated by the Mover.
 - (3) The committee shall report by 9 April 2024. (12 September 2023)
