Notices of Motion

96 Ms *Johnston* to move—That the House:—

- (1) Orders the Treasurer. Hon. Guy Barnett MP to make a statement to the House within 30 days of the release of a Budget Paper or Revised Estimate Report detailing the actions it will take in the following 12 months to meet the targets over the forward estimates, should the Budget Papers and/or the Revised Estimates Report show the Government has not met or will not meet one or more of its fiscal targets during any of the financial years for which Forward Estimates are provided.
- (2) Calls on the Treasurer to fund within the 2025/2026 Budget the establishment of a parliamentary budget office.
- (3) As a matter of urgency, calls on the Treasurer to table in the House a Bill to amend the Charter of Budget Responsibility Act in accordance with the recommendations contained in the 'Eslake Report' "Independent Review of Tasmania's State Finances".
- (4) Further calls on the Government to implement by the end of 2025 the recommendations from the Integrity Commission Paper 2: 'Grant Commitments in Election Campaigns' to ensure election commitments of public money are efficient, effective, economical and ethical. (11 March 2025)

97 Mr *Bayley* to move—That the House:—

- (1) Refers the following reference to the Standing Committee on Government Administration Committee A to inquire into and report upon the mass salmon mortality events and contributing factors with the following terms of reference:—
 - (a) examine and report on the responsibilities of the varying parts of Government in charge of approving and regulating the aquaculture industry and the efficacy of current laws, regulations and practices to protect and inform the public;
 - (b) examine and recommend improvements in the way these responsibilities are established and executed;
 - (c) ensure appropriate public consultation is conducted on all matters;
 - (d) any other matter incidental; and
 - (e) that the Committee reports by 25 September 2025. (11 March 2025)

98 Mr *Winter* to move—That the House:—

- (1) Notes the Premier, Hon. Jeremy Rockliff MP's announcement on Tuesday 4 March 2025 that his Government is considering the sale of Tasmanian Government Businesses and other entities.
- (2) Establishes a Select Committee, with the power to send for persons, papers and records, to inquire into and report upon the potential sale of Government businesses and other entities, with the following terms of reference and rules:—
 - (a) that the Committee inquire into and report upon the following:—

- (i) the Tasmanian Government's plans to sell government businesses and other entities, and the potential impacts;
- (ii) the current performance of Government businesses, including governance, financial outcomes, capital delivery and their contribution to Tasmania's broader economic objectives; and
- (iii) any other matters incidental thereto.
- (b) that the Committee consist of six members: two nominated by the Premier, two nominated by the Leader of the Opposition, one nominated by the Leader of the Tasmanian Greens, and the Member for Braddon, Mrs Beswick.
- (c) that the Committee report by 1 February 2026. (11 March 2025)

99 Ms *Haddad* to move—That the House:—

- (1) Notes:—
 - (a) the circumstances and legal ruling regarding the use of Northern Midlands ratepayers' money to fund the instigation of personal defamation proceedings; and
 - (b) the Liberal Government authorised the provision of approximately \$300,000 of public money to the Member for Bass, Hon. Michael Ferguson MP, to fund defamation proceedings launched in a private capacity.
- (2) Expresses its concern at the precedent set by the decision to fund Mr Ferguson's private defamation action.
- (3) Calls on the Minority Liberal Government to reverse its decision to allocate public resources to Mr Ferguson's private defamation action. (11 March 2025)

100 Mr *Winter* to move—That the House does not support the Premier's policy to privatise Tasmania's assets. (11 March 2025)

101 Mr *Winter* to move—That the House:—

- (1) Notes the complete and entirely predictable failure of the Minority Liberal Government's attempts to lease our new Spirit of Tasmania vessel to a foreign operator.
- (2) Further notes that more than \$2 million was wasted storing the new vessel in Scotland while a lease was being sought.
- (3) Expresses its concern that the Minority Liberal Government:—
 - (a) seriously considered leasing our new vessel for use as a floating refugee camp, despite the readily available reports of human rights issues when this was previously tried;
 - (b) believed it was negotiating with a representative of the Scottish Government, when it wasn't, and refused to answer questions for six weeks based on these non-existent negotiations; and
 - (c) has stated it is considering attempting to lease Spirit V
- (4) Censures the Minister for Transport, the Hon. Eric Abetz MP, and the Premier, the Hon. Jeremy Rockliff MP, for the incompetence and financial mismanagement displayed throughout the leasing saga. (11 March 2025)

102 Mr *Behrakis* to move—That the House:—

- (1) Condemns the alarming and dangerous behaviour carried out by individuals on behalf of the Bob Brown Foundation, who by their own admission, scaled Parliament House on the 4 March 2025.
- (2) Recognises with concern that the reckless and dangerous actions have been endorsed and promoted, by Greens MPs on social media.
- (3) Agrees that the individuals' actions:—
 - (a) exposed our first responders to entirely avoidable risks;
 - (b) unnecessarily wasted valuable Tasmania Police resources;
 - (c) jeopardised the safety of the individuals themselves;
 - (d) unnecessarily exposed the Heritage Listed Parliament House to potential or actual damage, endangering its historical significance and cultural heritage; and

- (e) had the potential to cause significant distress and anxiety for Parliament House staff, and others working in the building.
- (4) Establishes a Select Committee with power to send for persons, papers and records to inquire into and report upon whether any Members of the House of Assembly were complicit in the alleged trespass, and reckless and dangerous actions including by enabling restricted access to the individuals who scaled Parliament House on 4 March 2025:—
- (5) The Members appointed to serve on the Committee be:—
 - (a) two Members appointed by the Leader of the House;
 - (b) two Members appointed by the Leader of the Opposition;
 - (c) one Member of the Greens nominated by the Leader of the Greens; and
 - (d) One Independent Member.
- (6) The Committee report by 6 May 2025. (11 March 2024)

103 Mr *Wood* to move—That the House:—

- (1) Recognises that Tasmania’s tourism industry is one of the State’s biggest employers, and Tasmania’s economy relies on key sectors like the tourism and hospitality industries to fund schools, roads, and hospitals.
- (2) Notes that visitors inject around \$3.5 billion into the Tasmanian economy every year, and for every dollar visitor spent in Tasmania, another 83 cents is generated in our economy.
- (3) Agrees that for the Labor Opposition to describe critical marketing campaigns that drive visitation to Tasmania as, “puff and promotion,” is a blatant display of his disregard for homegrown jobs.
- (4) Further agrees that Labors’ plan to slash the Government’s investment in this vital sector should send a shiver down the spine of the nearly 43,000 Tasmanian jobs it employs.
- (5) Further notes:—
 - (a) that under Labor, these jobs, and the families they support, would be at risk; and
 - (b) Labors’ recent attack on co-funded grant support for small businesses as “reckless spending”.
- (6) Further notes that as part of the Government’s 2030 Strong Plan for Tasmania’s Future, the Government is investing in destination marketing to ensure the State remains competitive in national and global markets.
- (7) Calls on the Leader of the Opposition, Hon. Dean Winter MP to withdraw his attack on the Tourism and Hospitality Industry in Tasmania. (11 March 2025)

104 Mr *Wood* to move—That the House:—

- (1) Recognises Tasmania’s rich built heritage as a defining feature of our identity, culture, and economy.
- (2) Notes the significant contribution of the heritage sector to the State’s economy, supporting over 5,000 jobs and injecting nearly \$1 billion annually.
- (3) Acknowledges the vital role of heritage in tourism, local business, and regional development.
- (4) Commits to strengthening collaboration across government, industry, and communities to protect, activate, and celebrate Tasmania’s historic places for future generations.
- (5) Further acknowledges Tasmania as the Heritage State, championing the conservation and activation of its historic assets as a driver of economic growth, tourism, and community pride. (11 March 2025)

105 Mr *Fairs* to move—That the House:—

- (1) Notes:—
 - (a) the important contribution of our events sector in driving economic growth, tourism and jobs in every region of the State;
 - (b) that events and the “gig economy” are a trigger for visitors to travel to Tasmania and provide on average a 5:1 return on investment; and
 - (c) that during 2023-24 financial year more than 112,000 visitors travelled to Tasmania to attend an event supported by Events Tasmania and that visitors to events and festivals have a higher yield than regular visitors.

- (2) Back the Tasmanian Government’s investment in our critical events sector and provide ongoing support to ensure a balanced events portfolio across seasons and regions to support our tourism and hospitality sectors, drive economic growth and continued job prosperity. (11 March 2025)

106 Mr *Jenner* to move—That the House:—

- (1) Notes:—
- (a) research indicates that retired police personnel are at an increased risk of PTSD, depression and other mental health conditions; and
 - (b) hundreds of retired and former police personnel suffer from mental health disorders as a direct result of their work.
- (2) Acknowledges the vital role that police officers play in protecting the community and the lasting impact their service can have on their mental well-being.
- (3) Recognises that many former and retired officers struggle to access adequate mental health support due to the lack of Government funded mental health support.
- (4) Further notes that the Government provides some mental health support for those whose conditions arise and are reported during service.
- (5) Calls on the Government to immediately establish and fund ongoing mental health support services for those whose conditions were found arising during service, but weren’t reported at the time, due to the fact health issues like PTSD can often emerge years later. (11 March 2025)

107 Mr *Garland* to move—That the House:—

- (1) Notes:—
- (a) the recurrence of mass salmon mortality events in Tasmania; and
 - (b) the unprecedented scale of salmon mortalities over the months to 11 March 2025, particularly in the lower D’Entrecasteaux Channel (“the event”).
- (2) Understands the event has a multi-factorial origin, including from rising ocean temperatures, an increase in nutrient levels, marine pests and bacterial disease.
- (3) Recognises:—
- (a) the significant community concern about the impact of the event on the marine environment and public health;
 - (b) the on-going community and scientific debate about the impact of salmon farming in Tasmania;
 - (c) the significant impact of the event on the salmon industry and its workers;
 - (d) the importance of primary production to the Tasmanian economy;
 - (e) that salmon farming is Tasmania’s largest primary production industry; and
 - (f) the current shift from marine to land-based fin fish farming around the world.
- (4) Calls on the Minister for Business, Industry and Resources, Hon Eric Abetz MP in consultation with Mr Garland MP, to commission an independent, interstate consultant to conduct a feasibility study, to be tabled in Parliament within 6 months, on the costs, benefits and opportunities for Tasmania to transition its marine salmon farming industry to land-based aquaculture. The study will also include detailed discussion of:—
- (a) the current and emerging environmental and social pressures on marine fin fish farming in Tasmania; and
 - (b) emerging land-based fin fish farming practices world-wide, and the applicability of these practices to Tasmania. (11 March 2025)
