SIR,

THE Board of Immigration have the honor to present their Annual Report on Immigration for the year ending 31st December, 1871.

The Immigration under the Bounty System has materially decreased during the past year, only nine souls having been introduced by tickets, consisting of four single women from England and one from Scotland, and two single men from Ireland and two from Scotland.

The introduction of these Immigrants cost the Board the sum of Seventy-nine Pounds.

Under the 7th Section of the Act of Parliament 31st Vict. No. 26, fourteen Land Certificates have been granted, entitling the holders to select eight hundred and twenty acres of the waste lands of the crown.

These Certificates represent an addition to the population of fourteen male, seven female adults, and twenty-six children.

Mr. Frederick Buck, the Agent of the Board in Germany, having been instructed to close the agency, the last vessel left Hamburg on the 20th October for Hobart Town via Brazil, having on board for this port thirty-two married couples, twenty-seven single males, thirteen single females, and seventy-four children, Bounty Immigrants, besides seventeen Land Order Warrant steerage passengers and three in the intermediate cabin. Mr. Buck himself accompanies these Immigrants.

The Board have been in communication with their Agents in London, the Emigrant and Colonists Aid Corporation, Limited, and have supplied them with all necessary papers, maps, and other information, but as yet no practical results have followed the establishment of this agency.

In order to facilitate the introduction of suitable labour for the construction of the Main Line of Railway, the Board, at the instance of Captain Audley Coote, appointed the Secretary for the time being of the Main Line Railway Company their Agent under the Act of Parliament 31 Vict. No. 26, so far as relates to the issue of Land Order Warrants to persons who shall enter into agreements to serve the Company in Tasmania for a period of not less than two years: the issue of the Land Order Warrants not to exceed in all fifteen hundred statute adults, two children between the ages of twelve months and fifteen years being reckoned as one adult, and the total issue to include not less than one thousand able-bodied male laborers and mechanics, or in the proportion of two male adults to one adult female, or two children.

Mr. Whitesmith's proposed Co-operative Emigration Association still remains undeveloped, and the Board do not anticipate that any material advantage to the Colony will be derived from this source unless the Association should find itself in a position to adopt the course suggested by Mr. Whitesmith himself, and fully concurred in by the Board, namely, to despatch accredited agents to visit Tasmania and satisfy those interested that the elements of success are available.

The balance at the disposal of the Board on the 31st December last amounted to £9150 2s.

Appended are five tabulated Returns, prepared by the Immigration Agent, referring to the operations of the Board under the Bounty System, and one relating to the transactions under the Act of Parliament 31 Vict. No. 26.
